The Manager outlined that issues regarding the start and finish locations for the race and also closing down traffic in the area for three days around the event where raised by the former Chief Executive with the organisers of the marathon. He also informed members that while the Transportation Department may be asked to comment on proposals submitted, it is the Events Section of Dublin City Council deal with this annual occasion.

- 2 Finance SPC request for discussion at the Traffic and Transport SPC on the issue of congestion charges for Dublin City.

The Chair of the Finance SPC kicked off the discussion informing members that introducing congestion charges has arisen a number of times at the Finance SPC, and they wanted to see if there was a political will to progress the issue among the members of the Transport SPC.

A number of members did not support the charges. Other members that did not object to the idea of congestion charges did feel however, it was not the time to introduce them and would rather concentrate on delivery of current projects such as the City Centre Programme.

Brendan O'Brien said it was not a suitable tool in Dublin at this time and would involve a high cost upfront. Dublin City Council does not have the mechanisms in place to carry it out at the moment.

Councillor Lacey requested a list of any committees in the Department of Transport of which the Executive of Dublin City Council is a member.

The Executive would not commit to any reporting on this matter in the short term, suggesting congestion charges may be a consideration for future committees.

3 Report on Draft Dublin City Council Parking Control Bye-Laws 2024

The report recommended to increase parking fees as part of the 2024 Budget.

Issues raised in discussion included:

- Vehicle emissions
- Raising Residential Permit fees
- the cost of bike parking (bunkers) versus car parking (residential permit)
- How the increase will affect those reliant on the car as their only more transport.
- The Development Plan objective to remove all free parking between the can
- Business Permits

In response the Manager said a full review of Dublin City Councils Parking Contr Laws will take place in the near future and should address these issues. Members agreed to recommend the Draft Dublin City Council Parking Control Bye 2024
