Housing Matters North Inner City

Choice Based Letting Competitions:

Five of the properties from the last CBL competition have been occupied. We are currently awaiting the completion of snagging and the availability of keys to complete the allocation process of the nine remaining units.

It is expected that the next CBL Competition will be ready in the third guarter of 2024.

Residents Groups/Associations:

- A new Residents Group has been formed at Poole House and funding has been arranged through the Community Section.
- A Residents Group has been formed at Courtney Place and initial meetings between the Housing Section and the Group have taken place. We are currently arranging for the Community Room in the complex to be renovated to facilitate the group.
- A new Residents group has been formed at Ballybough House and a formal meeting with the Housing Section is being scheduled.
- Informal WhatsApp groups has been formed among some residents at the Dublin Landings and Spencer Place complexes. The Project Estate Officer is encouraging the groups to put the format on a more formal footing.

Graffiti Removal:

Ballybough House and Matt Talbot Court were targeted with graffiti in recent weeks which was removed swiftly by our housing attendants and painting sections. This is an ongoing issue in the area and due to the obscene nature of the graffiti the photos have not been published in this report.

A similar Graffiti incident took place in stairwells of North Clarence Street Flats which is currently being dealt with.

Courtney Place:

Following consultations with the residents we are currently arranging contractors to have the area at the rear of the community room in Courtney Place resurfaced.

Matt Talbot Court

The decanting of Matt Talbot Court continues with the Project Estate Officer encouraging tenants to consider CBL properties as they become available. All properties once vacant are steeled up and a plan is in place to secure non occupied balconies in order to prevent Anti-Social Behaviour and Health and Safety issues.





O'Brien Hall:

Following consultations with the Residents we arranged to have the rear courtyard of the complex deep cleaned to remove the Green Algae which was proving a danger to those using the space. The area has also been treated with a non- chemical moss preventive spray.

Railway Court/The Forge/The Kiln

Nine Car Parking spaces have been created at the new Railway Court/Railway Street complex. These car park spaces have replaced the original car parking spaces that where available for the residents of The Forge and The Kiln. One of the spaces is a designated disability parking space. There will also be Electrical Power points to facilitate electric cars.

We are currently in discussion with Circle Housing in relation to a new bin chamber being installed in the Railway Court development specifically for The Forge and The Kiln complexes. The tenants will be informed by the City Council and Circle VHA of how the disposal of their normal house hold waste will be managed.

Spencer Dock:

Following consultation with the residents the public areas of the five blocks at Spencer Dock have been deep cleaned.

Spencer Place North:

Following intense lobbying by the Project Estate Officer the tenant's individual Letter boxes have now been installed in the complex and they can now receive their mail directly rather than through the Concierge.

Housing Matters North West Inner City

Dominic Hall and Lower Dominick Street

Regular discussions are being held with residents in the area regarding any issues that arise.

The date of the launch is yet to be confirmed.

Contractors are on site completing snag issues at present.

The Parnell Street office continues to facilitate access to apartments and town houses.

Upper Dominick Street

Estate Management continues to hold meetings with concerned residents.

Constitution Hill

The project proposal is for a mixture of deep retrofit, amalgamation and infill of the three existing housing blocks and for the provision of new housing blocks on the site. It is proposed that the project will be completed in two phases. The first phase involves the amalgamation and redevelopment of the northern housing block (block nearest to Broadstone depot) and a new apartment block on the northern end of the site. A multi-use childcare space will be provided as part of Phase 1. The second phase will provide for the redevelopment of the two other housing blocks, along with a new apartment block to the south of the site and a row of mews houses along the boundary wall at the rear of the site. The new scheme will provide 100% social housing, with a mix of one, two and three bedroom homes. The Area Housing Manager and her staff are continuing to update the residents on an ongoing basis.

A soft strip survey of Block 1 has completed onsite. The results of these works will provide relevant information required for the tendering process. The Stage 3 application is due to be submitted in April 2024 to the DHLGH. It is anticipated following the necessary design, procurement and DHLGH approvals that a contractor will start Phase 1 in Q4 2024

Henrietta House

Ongoing discussion with residents in relation to issues that arise in the complex.

Kevin Barry House

New security doors have now been installed and keys will be issued to residents in the coming weeks. Locks will then be installed and activated.

Ongoing discussions take place between Estate Management and residents regarding the upkeep of the complex and any other issues as they arise.

Hardwicke Street

Painting has been completed of the yellow-box outside of the bin chambers beside the community centre.

Vehicular gates have been installed between Dermot O'Dwyer House and Rory O'Connor House.

A statue of Our Lord has been erected at Dermot O'Dwyer House and the residents are liaising with a local priest to arrange a prayer service at it.

Saint Michans House

Ongoing meetings continue to be held with residents.

Wolfe Tone Close

Upgrade works on the pedestrian gates are to commence shortly. New locks are to be fitted in the coming weeks on one of the blocks. Ongoing meeting with estate management and residents as issues arise.

Sheridan Place / Court

Ongoing discussions with estate management and residents as issues arise

New security doors are now complete.

New gate operating system has been installed in the carpark and is fully activated .Residents can now access the carpark via their mobile phone.

Chancery House

Ongoing discussions with residents addressing issues in the complex.
