#### Road Maintenance Services.

Road Maintenance Services' 2024 Annual Works Programme, for the upgrade of roads and footpaths aims to deliver approximately 32km of renewed footpaths and 13km of resurfaced carriageways across the City. Tender documents are presently being prepared for issue to contractors to tender for works packages. It is anticipated that these upgrade works will commence in May and continue through to November.

During January and February, the Division's direct labour crews repaired/ made safe approximately 900 defects and hazards on the road network. Furthermore, approximately 70 critical defects and hazards on the road network were repaired/ made safe within 24-hours of them being reported.

## Parking Tag and alternative methods of paying for parking

The numbers using the Parking Tag have increased and by week ending  $10^{th}$  March 2024, that week's revenue was €516,152.01. For week ending  $10^{th}$  March 2024, the usage of coin in parking meters was €105,857.06 and for week ending  $3^{rd}$  March 2024 card payments were €171,466.

#### Waste Services Update

#### **City Cleaning St Patricks Day Festival 2024**

Over the busiest weekend of the year for Waste Management Services, 300 staff worked throughout the festival period across the core city centre. Showcasing the city involved extensive planning and preparation, deploying over 130 temporary bins, arranging rotas to cover all key cleaning windows at safe times and engaging appropriate access to waste collectors for household and commercial collections.

Waste Management Services are pleased with standards and feedback and a review of 2024's activities will take place.



#### Waste Education School Programmes

The Relove Fashion Grand Final was held in the Rediscovery Centre on 21st March, there were 2 finalists representing DCC. The Green-Schools deadline was on 15th March. DCC staff are currently carrying out renewal visits to schools. Successful schools will be awarded their new Green Flag in May.



## Dublin Waste to Energy Community Gain Fund

The Dublin Waste to Energy Community Gain Fund Committee are inviting nominations for the position of Community Representative on the Committee to represent the interests of the following sectors:

- 1. Community, Residents Association and Voluntary Sector
- 2. Arts, Culture, Education, Environment and Sports Sector
- 3. Business, Social Enterprise, Health and Social Care and Charity Sector

There are 3 Community Representative positions available, one for each of the above sectors. The nominees should be representative

of one of these sectors but will represent all of them on the Committee.

The call for nominations will be published in the April / May edition of the NewsFour local newspaper. The opening dates for the submission of nominations will be from the 1<sup>st</sup> April to the 10<sup>th</sup> May 2024.

Eligible clubs / groups / associations and organisations representing these sectors in the Irishtown, Ringsend and Sandymount catchment area are invited to submit an application form nominating a representative for consideration. Application forms will be circulated to the 120 community groups and individuals on the Projects Grant Scheme's e-mail notification list and will also be available by e-mailing cglc@dublincity.ie

The Dublin Waste to Energy Community Gain Fund Committee held their first meeting of 2024 on the 25<sup>th</sup> March. At this meeting the Dublin Waste to Energy Projects Grant Scheme 2023 Annual Report was approved. ## Fleet Management Services, Environment and Transportation Department

A request for tenders for the establishment of a Single Operator Framework Agreement for the supply on lease hire with maintenance of Waste Management Services' Side Loaders (Side-Loading Box Cage Body Tipper Vehicles), used for street refuse collection was published on eTenders on Monday 4 March 2024, with a closing date for submissions of Friday 26th April.

As a decision was made to electrify at least 50% of these Side Loaders, this tender was broken into two Lots – one for low emission (ICE) vehicles and one for electric vehicles. It is expected that at least 25 EVs will be added to the fleet in place of diesel vehicles as a result.

In order that these EVs can charge at a sufficient rate so as not to affect service a tender is also currently being drafted for the supply and installation of up to thirty 22 kW AC EV chargers in the North City Operations Depot in Ballymun.

A request for tenders for the establishment of a Multi-Operator Framework Agreement supply on lease hire with maintenance of Light Commercial Vehicles for all DCC divisions is currently being drafted and will be published in Q2 of this year. It is our aim then is that 40% of this Light Commercial Vehicle fleet (approximately 80 vehicles) procured in the upcoming procurement exercise will be electric vehicles, pending the installation of requisite charging infrastructure.

As such Dublin City Council aims to exceed the revised 'Clean Vehicles Directive' (Directive 2019/1161/EU established in law in S.I. No. 381 of 2021) across each of these procurements.

The S.I. establishes a minimum target for the share of clean vehicles procured by public bodies of 38.5%. Until 31/12/2025 a 'clean' vehicle is defined as a vehicle which emits a maximum 50 g  $CO_2$  / km, thereafter a clean vehicle is defined as a vehicle which emits 0 g  $CO_2$  / km – a zero emission vehicle i.e. an electric vehicle.

Because the standard lease hire term that DCC lease hire vehicles is 5 years we will equate clean vehicles with zero emission vehicles more immediately.

#### Protection of Water Bodies Office (PWBO)

Dublin City Council is working to deliver a number of projects to ensure that we meet our Water Framework Directive (WFD) obligation of achieving "good" status for all our water bodies by 2027.

#### Current examples are:

**Golden Lane Public Realm Redevelopment -Urban Runoff (Action 70):**. Tender awarded for multi design team and installation of monitoring equipment. Design and monitoring equipment installation is expected to commence within Q2 2024

**Culvert Improvement Works – Screen Upgrade Works**. The construction contract is substantially complete.

Santry River Restoration and Greenway Project (<u>www.santryriver.ie</u>) – The Design stage is ongoing, currently flood design element).

Rainscapes Nature-Based Solutions Project (River Santry and River Dodder Rainscapes ] Dublin City Council). Tender for the contractor for phase 1 (McAuley Park) open for submission.

**Bathing Water:** Fortnightly sampling at bathing water locations continues in accordance with the DCC out of Bathing Water Season monitoring

schedule. Samples results are available online, on <u>www.dublincity.ie</u> and <u>www.beaches.ie</u>

#### Flood Defence Project - Camac River

Consultants have been appointed by DCC to investigate the reduction of flood risk across the DCC and SDCC sections of the River Camac. Environmental and topographical surveys are now complete. A computer model has been built to investigate tidal, fluvial and pluvial flood risks associated with the river. Preliminary flood extent maps have been verified. Flood alleviation options such as storage, walls, embankments and de-culverting are currently being computer modelled. A further public consultation is planned in April 2024 on emerging options following the successful ones in June 2022.

This study, as with all other flood alleviation projects, is being integrated into a desire to "deculvert" and widen, what is now seen as an over engineered river, where possible so that it can, over time, be restored to a more natural state, as far as reasonably possible. The project will also involve identifying and remedying urban pollution sources, where possible. This is also being done in conjunction with an existing Greenway proposal and in tandem with Urban Regeneration and Development Fund (URDF) funded projects in the area. The new City Edge project gives opportunities to achieve some of River corridors of 10m-25m wide are this. policies in the development plan and these will be implemented where possible on this very constrained Liaison with river. large stakeholders is ongoing on possible flood storage areas in DCC and SDCC.

Further wintering bird surveys are ongoing in 2024 to identify protected species as well as other bird quantities. Building threshold surveys are completed. A large Site Investigation for both Dublin City Council and South Dublin County Council areas of the Camac catchment commenced in July 2023 and is now complete This involved over 100 areas of investigation.

#### Drainage Planning, Policy & Development Control

The SuDS Working Group has produced a new "Property Level Guide to SuDS". This is intended to give guidance on SuDS implementation for developments. individual small houses. extensions, driveways etc. It provides straightforward advice on meeting SuDS requirements in the City Development Plan. It also assists anyone who may want to install water butts, permeable paving etc. to help protect their own local area from flooding and climate change. A media campaign was carried out before Christmas to highlight the issue of people paving their gardens with impermeable materials.

To ensure sustainable development within the City, the Drainage Planning, Policy and Development Control team has established a framework for auditors of Basement Impact Assessment Reports. There are five consulting engineer companies on the cascading framework and a number of BIA reports are currently under review.

#### **Climate Action Team**

#### Climate Action Plan

Submissions received have been reviewed and compiled into the Chief Executive's Report, that was presented in draft for the SPC. The final report has been submitted to the Council along with the final plan for adoption. Submissions are broadly supportive and constructive, and where appropriate actions and text have been amended to reflect.

#### EV Strategy

The Dublin Local Authority Electric Vehicle Charging Strategy was published in June 2022.

To support the Electric Vehicle Charging Strategy, the four DLAs agreed to a pilot project to install 200 charging points (at 50 locations) across the City and County.

The final date for submission of tenders was 7<sup>th</sup> February, 2024 and the successful tender is expected to be appointed in March 2024. The pilot project is primarily focussed on destination charging. All new (or upgraded) commercially operated car parking developments will be required to provide a minimum of 50% of spaces with EV charging facilities.

#### Energy Management

DCC Energy Oversight Committee have agreed to progress towards attaining ISO 50001 Energy Management System Accreditation. Achieving ISO 50001 certification will enhance DCC's reputation as a socially conscious and responsible organisation.

Putting structures in place to induce collaboration between departments will facilitate a more effective response to tackling GHG emissions and improving our energy efficiency.

#### Decarbonising Zones

Workshops in Ballymun and Ringsend/Poolbeg have been completed. Drafting of the plans will now be completed by Codema.

## Dublin Metropolitan Climate Action Regional Office (CARO)

In June 2023, a new Service Level Agreement between the Department of the Environment, Climate and Communications and the lead Local Authorities, for each of the four CAROs was agreed and signed. The new SLA will be in place until June 2029. New governance arrangements are in place including the establishment of the Strategic Implementation Group and the Strategic Advisory Group.

The CARO 2024 Work Programme has been agreed and the Dublin CARO team are working with the other CARO regions to prioritise and schedule work for the year ahead.

The team are currently involved in organising the first CARO Networking Event with climate action teams which will take place in April 2024.

#### Draft Dublin City Centre Transport Plan 2023


The current Dublin City Development Plan (2022-2028) objective SMT05 requires a update of the 2016 City Centre Transport Study. "To review the City Centre Transport Plan 2016 in collaboration with the NTA in the lifetime of the an, setting out a clear strategy to prioritise active travel modes and public transport use, whilst ensuring the integration of high quality public realm."

Consulation on the plan has finished and over 3,500 response were received. A full report on the consultation and the final plan was presented to the Transportation SPC on the 7<sup>th</sup> of February. It is intended to present it to the Council Meeting on April 8<sup>th</sup>.



## The Active Travel Programme Office (AcTPrO) – Walk-Wheel-Cycle Network

The multi-disciplinary team within the Active Travel Programme Office (AcTPrO) continues to work on the design and delivery of a number of projects as part of the overall network, which when fully completed, will result in 95% of people being within 400 metres of the high quality network within Dublin City.

#### **Customer Services**

- 13,055 calls were answered between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024, with 45.91 % of those calls answered in less than 30 seconds.
- Average call answered by Customer Services in 2 minutes and 29 seconds between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024.
- 3,906 emails were received by Customer Services between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024, from the generic customer services email account.
- 5,626 emails were sent out by Customer Services between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024, from the generic customer services email account.
- 2,283 emails were received by Customer Services, relating specifically to Parking Permits, between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024, from the generic Parking Permits email account.
- 1,842 emails were sent by Customer Services, relating specifically to Parking Permits, between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024, from the generic Parking Permits email account.
- Customer Services have taken 3,354 payments between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024.
- Customer Services have processed 2,069 Parking Permits between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024.
- The Reception Desk in Civic Offices continues to be busy, with 1,866 visitors greeted at the reception desk between 18<sup>th</sup> February 2024 and 15<sup>th</sup> March 2024.

#### **Improving Customer Experience Initiatives**

#### Focus Group

- The first focus group session was held during March 2024 with external customers invited from the Public Participation Network and via Customer Services "X" account.
- Major issues raised related to digital accessibility, language service offerings, physical accessibility to DCC offices and the use of Plain English in all written areas, e.g. website. These areas are to be reviewed with the relevant areas and possible improvement solutions considered and implemented where possible.

#### **Interpreter Service**

- Customer Experience has looked at sourcing an interpretation service to improve the customer experience at the reception desk and to reduce the need for customers to make multiple visits.
- A pilot project is being considered with interpreter services via an online app which uses live people. It is expected that the interpretation service will be available within 5 minutes for customers.
- A survey of customers using the building, along with information from key frontline services, to decide on the main languages required.

#### **Reception Desk**

• An additional staff member from Customer Services has now been assigned to the reception desk to improve the customer experience and to speed up the service being offered to customers.

#### **Mystery Shopper**

- A mystery shopper programme started on 13<sup>th</sup> March and will run for approximately four weeks. The results will be available at the end of the four weeks.
- The programme will look at a variety of frontline touchpoints using both in person visits and telephone calls, based on publicly available information on the Dublin City Council website. The programme will also look at some of our digital offerings, e.g. Citizen Hub.


The Council is implementing some of improvements identified as part of the review. We are working with Fingal County Council and the supplier to pilot a solution on digital signatures.

Currently two services are being designed with the assistance of a service designer – the Council's business travel system and phase 2 of the Disabled Persons Organisations Consultation and Participation Process.

#### **Digital Workplace**



- The team are working on solutions for Dublin Fire Brigade, Corporate Health and Safety Office, Waste Management, Finance and Fleet management.
- A street washing app has been development for Waste Management where crews can upload images of before and after. Looking at building on this for other waste management activities including response to Citizen requests. An app for street grading is currently being explored
- Work is nearing completion on the new internal phonebook. Verifying extension numbers has taken longer than we anticipated but we are hoping to go live in April/May.

**Staff Awards 2024** Nominations for The Staff Awards Scheme 2024 have now closed with additional categories based on the feedback from the inaugural awards in 2023. It is anticipated the award ceremony will be in May.

#### 3. Dublin City Council Announce Partnership with OpenAl



As Artificial Intelligence is an increasingly topical technology tool, this workshop brought this information to DCC staffers to increase their knowledge and to create an environment where people could ask questions and learn more about AI. The expl[ai]n worksop was delivered through the Smart Docklands district: a unique partnership between Dublin City Council and the CONNECT Research Centre at Trinity College Dublin.

#### **Residential Zoned Land Tax**

The annual draft RZLT map was published on the Dublin City Council website on 1st February 2024 and is available for public inspection up to 31 May 2024. Landowners and third parties can make submissions to challenge the inclusion or exclusion of land, make rezoning requests or request a change of date that makes the land eligible for the tax. There are two submission deadlines within this public consultation period:

- 1 April 2024 for submissions regarding the inclusion in or exclusion from the final map of specific sites, or the date on which a site first satisfied the relevant criteria.
- 31 May 2024 for submissions regarding rezoning requests.

#### **Departmental Projects**



Project Built Heritage Investment Scheme (BHIS) 2024 and Historic Structures Fund (HSF) 2024

The **BHIS** supports small-scale conservation projects and the employment of skilled and experienced conservation professionals, craftspeople and tradespersons in the repair of the historic built environment.

The **Historic Structures Fund** enables larger scale conservation works to be carried out on significant historic structures in need of urgent support. **Progress in Previous Quarter** The Conservation Section of Dublin City Council has assessed the 114 projects submitted for the BHIS and has approved 68 projects. These projects have been provisionally approved for a total of €492,400 in funding. The Department of Housing, Local Government and Heritage have approved these provisional grant offers.

A total of 41 applications were received for the HSF funding. Three projects have received provisional funding offers under the HSF totalling €271,000. Two further projects have funding rollovers from 2023 totalling c.€350,000. Acceptance letters have been returned to the Dept. for the three 2024 projects.

Overall applications for both funding streams were higher than normal for 2024.

Next Stage

Provisional Letters of Offer will be issued shortly to the successful applicants, followed by letters to the unsuccessful applicants.

The Conservation Section will then commence coordination of the inspection stage of the grants. Once an initial inspection has been made, works can commence on site with ongoing inspections as required.

The final date for completion of all projects is 27th September 2024.



Sarah Purser: Champion of Irish Art

10<sup>th</sup> July 2024 – 5<sup>th</sup> January 2025

Sarah Purser (1848 – 1943) was a hugely influential figure in Irish artistic circles, both as an artist and as an organiser. This exhibition, drawn largely from the HLG collection, will present her life and work from three different perspectives: artist, collector and activist. Purser was born in 1848 in Dún Laoghaire and studied in Switzerland, Dublin, and Paris before establishing herself as a leading portraitist in the city.

## Early Years Artist Residency: High Expectations

We are delighted to be working with the North East Inner City (NEIC) on 'High Expectations', an early years artist-residency with artist Helen Barry and Ozanam House in Mountjoy Square. This year long initiative, which began in May 2023, sees artist Helen Barry working with three groups of children at the preschool in Ozanam House on a weekly basis and including monthly visits to the Hugh Lane Gallery where children and their parents creatively engage with artworks and the gallery space. As part of their experiences at the Hugh Lane Gallery, the young children and their parents met poet Paula Meehan whose portrait in the collection they are very familiar with.

#### Make and Be

Through this art education project, we hope to encourage families from international communities within the DCC area to develop a relationship with the HLG and our programmes. To date we have worked with artists Nasrin Golden, who speaks English and Farsi; Anca Danila led workshops from the Romanian community; Olga Knukova assisted by Olga Khomiak led workshops for the Ukrainian community; and Bríd Higgins Ní Chinnéide who led a programme through Irish in the autumn and winter of 2023/24. In spring 2024 we are seeking to engage with families within the African-Irish community led by Victory Nwabu-Ekeoma and Rema Hamid.


