Update St. Anne's Court

1. De-tenanting of St. Anne's Court:

- o The process of relocating tenants from St. Anne's Court is progressing well.
- o The team is actively prioritizing resident preferences during this transition.

2. Tenant Relocation:

- Out of the 57 tenants in St. Anne's Court, 36 have already been successfully moved to new accommodations.
- o These relocations have been made to areas that the tenants specifically requested.

3. Letter of Comfort:

 All tenants who have moved have been provided with a letter of comfort assuring them that if they wish, they can return to St. Anne's Court once the new development is completed.

4. Remaining Tenants:

o Currently, there are 21 tenants left to be relocated.

5. Ongoing Communication:

The Area housing team will maintain regular communication with the residents and keep residents informed about suitable alternative accommodations while the redevelopment of Anne's Court is underway.
