Reply

The traffic signals at this junction are controlled by Dublin City Council's Urban Traffic Signal Management System, SCATS, which adapts signal timings on each approach, automatically, in response to real time demand(s) from traffic / pedestrians. All operation is demand dependant, traffic detectors are located in the road surface on approaches to the junction and are activated by a vehicle passing over them whilst pedestrians demand the crossing using the pedestrian push buttons. The installation of traffic signals at the junction has increased the level of service and safety for pedestrians, which is in line with national and City Council policy to provide for active and sustainable modes of transportation.

Traffic count data extracted from the SCATS system shows that traffic volumes along **(details)** Road exceed those of the **(details)** Avenue approach and therefore Gracefield Rd approaches receive traffic signal priority, subject to demand.

The operation of the traffic signals has been continually reviewed since installation and traffic signal operation amended to decrease vehicle journey times through the junction

The operation of the traffic signals will continue to be monitored and further amendments made, as required, where there is scope to do so.

Non Statutory public consultation for the scheme was undertaken in July 2023 and a walk-in Public Information Event was held on the 25th July 2023 in the Artane-Coolock Family Resource Centre. On review of the submissions it was evident that there were a number of key concerns.

In October 2023 a Consultant in the Active Travel Design Office was appointed to progress the project through detailed design, planning, procurement and construction phases.

The design team have been undertaking a revision of the design taking on board the submissions whilst also improving the design proposals. This review also provides an opportunity to align with the latest National Transport Authority (NTA) design guidance relating to pedestrian and cycle infrastructure.

Publication of the Public Consultation Report and revised design and is expected to take place in Q2/Q3 2024. A Public Information event is proposed with an information leaflet to be distributed to residents at this time.

Phase 2 - Vernon Avenue, from the junction with Seafield Road to Clontarf Road, The Active Travel Programme Office propose to engage Consultants for the Active Travel Design Office to develop the design for this project and work is earmarked to commence at the end of Q2 2024

The team note the complexities of Phase 2 with constraints such as narrow road width, parking and requirement for deliveries for businesses whilst also

addressing the needs for appropriate active travel and public realm infrastructure. Therefore it is proposed to undertake early engagement with residents, businesses and other key stakeholders ahead of full public consultation. This will assist the multi-disciplinary design team in the options assessment process. It is expected that this Phase 2 early engagement will take place over Q3 2024.

It is anticipated that full Public consultation for Phase 2 will be undertaken later in 2024.

1. When is normal route for traffic through Fairview heading into town going to re-open?

We have not confirmed a date for the removal of this diversion. The Project team are working towards a time during the forthcoming summer months to lift it. The Project team has arranged a meeting of the C2CC Consultative Forum mid-May, further details will be discussed at this meeting.

2. Is the pedestrian/footbridge overhead bridge remaining?

There is no change proposed to the existing footbridge in Fairview. Two additional pedestrian crossings are also being provided (i) on the Fairview side of Annesley Bridge and (ii) at Marino Mart which shall make it easier for pedestrians to cross the road through Fairview/Marino.

3. How long more will work be ongoing on Alfie Byrne Road/ East Wall Road? Meaning when can people go to work unhindered by road works

Works are expected to be completed on the East Coast Trail project on Alfie Byrne Road & East Wall Road by the end of May. It should be noted that the outstanding works include some activities such as the installation of red cycle lane surfacing, which are weather dependent.

4. Respond to the negative commentary about the new design of entrance off Clontarf Road to Alfie Byrne Road., being designed to slow traffic with a very deliberate left turn contrary to what was there before.

At the Clontarf Road/ Alfie Byrne Road junction the C2CC Scheme connects to existing infrastructure providing a dedicated cycle-track along the coast. The trail along the coast from Fairview to Clontarf is a busy and extremely popular route for pedestrians and cyclists alike. Providing safe cycling and pedestrian infrastructure is one of the main objectives of the C2CC scheme.

Figure 1 (as per below) illustrates the junction arrangement at the Alfie Byrne Road which existed prior to the C2CC Scheme commencing. With this configuration, whilst travelling inbound and arriving at the end of the coastal cycle-track a cyclist was then required to cross (i) the left hand slip from Clontarf Rd onto Alfie Byrne Rd (ii) the Alfie Byrne Road itself with inbound and outbound lanes and (iii) the left turn slip from Alfie Byrne Road onto Clontarf Road. Similarly when travelling outbound in order to access the coastal trail, cyclists were required to cross the Clontarf Road, and then the left turn slip from Clontarf Road onto Alfie Byrne Road. Pedestrians and other vulnerable road users were required to complete these multiple crossings also in order to get from one side of the road to the other.



Fig. 1 – Clontarf Rd/Alfie Byrne Road Junction Pre C2CC Scheme




Fig. 2 – Clontarf Rd/Alfie Byrne Road Junction C2CC Scheme Design

During the design process, in line with current best practice, it was identified that the current configuration did not give sufficient priority or protection to cyclists and pedestrians alike. The design as illustrated in Figure 2 (enclosed below) was subsequently developed. The dedicated traffic left-hand turn lane from Clontarf Road onto Alfie Byrne Road develops (starts) almost at the exact same location as it did prior to the scheme commencing. The slip lane which existed previously is removed but the dedicated filter lane on the approach to the traffic signals remains.

For cyclists the new configuration provides for a smooth progression from the coastal cycle-track onto the newly opened inbound segregated C2CC cycle-track. Only one crossing of the Alfie Byrne Road is now required for both pedestrians and cyclists compared to the three separate crossing points which existed previously. The inbound configuration shall also facilitate cyclists who wish to continue from the coastal trail along Alfie Byrne Road to East Wall Road. A single dedicated crossing point of the Clontarf Road shall facilitate outbound cyclists accessing the coastal track. Pedestrians, vulnerable users and cyclists alike shall benefit greatly from the proposed layout with increased priority and fewer crossing points whilst the left turn traffic lane to Alfie Byrne is still provided although part of the wider junction signal control.

When the inbound diversion at Edge's corner to facilitate the construction of the C2CC Scheme is removed later in the year colleagues in DCC Traffic shall continue to monitor changes in traffic patterns to maximise efficiency of this junction.

5. Regency Glass, Martins Off Licence, Costello's Pharmacy, and other businesses in Fairview along the route of the C2CC project are experiencing serious problems in terms of customer fall off (in the extreme); can the manager say when the barriers outside Regency Glass and the other businesses along this stretch, will be removed

Works between Marino Mart and Malahide Road are expected to be completed in July 2024. ESB diversion and new connection works are almost complete which shall allow the Scheme Contractor to progress with the Scheme elements (cycle-track, bus stop, footway, kerbing, public lighting etc.). Every effort is being made to progress the works in the area. We shall endeavour to manage the works programme and the school exam schedule in the area as best as is possible.

6. If he can make arrangements, for once and for all, to ensure that construction workers do not park their vehicles in the reduced number of temporary carpark spaces along this stretch fronting business in Fairview

Construction workers relating to the C2CC Scheme have been asked not to park in the spaces provided outside the businesses through Marino to try ensure they are available for business customers only. Signage to that affect shall be erected in the near future. Additional car-park spaces were provided last weekend.

7. If he can make arrangement to ensure that 'rental cars' are not parked all day long in the temporary carpark spaces along this stretch fronting business in Fairview

The Project Team shall make contact with the relevant DCC Department to see what can be done on this matter.

8. Say why, there was no work being done on the project in Fairview over the Easter weekend when business owners continue to suffer massive negative effects on their livelihood"

Apart from the designated holiday periods, the Scheme Contractor typically works almost all weekends at some location along the Scheme route.

Minimal construction works were carried out this weekend on the Project for a number of reasons, including the fact that material suppliers and their plants were closed for the weekend. Works did take place in Marino on Easter Monday 1st April in an effort to advance works for the ongoing ESB connections.

This weekend was in the middle of the Construction Industry Federation Holidays commonly known as the "builders' holidays" which runs from 29th March to 5th April for the Easter period.

This period also aligned with the school holidays, when there are reduced traffic flows. The Contractor took advantage of this reduced traffic flow, and carried out a number of major traffic interventions at a number of locations along the route, in order to progress a number of major utility connections, and complicated public realm works.

From a management of the works perspective and also from a site productivity perspective it works much better for as many of the site crews and staff to take holidays at the same time. This helps with the efficiency of resources and hence productivity to progress the works.

As part of the preparation of the 2022-2028 Dublin City Development Plan, the Council was aware that this Local Area Plan (LAP) was due to expire and Clongriffin – Belmayne was thus designated as a Strategic Development and Regeneration Area (SDRA). This designation provides a strategic spatial and urban design framework for the area, and ensures that the pertinent policies and objectives of the LAP can be delivered as part of the future build out of the lands (see Chapter 13, SDRA no. 1 of the Dublin City Development Plan).

With respect to L-shaped lands at Belmayne the urban structure envisaged by the LAP and included in the Development Plan is for a Key Urban Village (KUV) at Belmayne addressing the Malahide Road and the recently completed Main Street; providing a mix of uses (residential, commercial and community / social).

A cross-department team has been established in the City Council to consider the development options of the City Council owned lands at Belmayne. The Council own c. 9.6ha of the L-shaped lands; the Council do not own the south western corner of the L-shaped lands (c. 1.29ha). This team have analysed the revenant planning history of the area, the 2022 Census figures and the community provision. An analysis of the existing open space facilities is ongoing.

Following completion of the open space analysis, revised capacity studies will be undertaken for the DCC owned lands, with a presentation to Council on this work in September / October 2024.

- Hazelwood Drive is short in length and is currently traffic calmed with two speed ramps placed at appropriate distances for optimum traffic calming. At the junction with Hazelwood Drive/Hazelwood Park, traffic is calmed by a raised table (large ramp).
- The 30 km/h Slow Zone signage covers Hazelwood Drive, signalling the reduced speed limit and designating the area as a Home Zone/Slow Zone. This alerts drivers that the road is residential and to be cautious of children. The signs are prominently displayed at the entrances from Kilmore Road and Ardlea Road.
- There is a 30km/h road marking at the entrance of Chanel Rd from Brookville Park, accompanied by additional 30 km/h Slow Zone signage when entering from Malahide Road.

Instances of erratic driving/speeding should be referred to the Gardaí as a matter of enforcement. Transport Advisory Group will raise the Councillor's concern with the Gardaí at the next TAG Meeting.
