

# **Monthly Local Fund Statement**

## Background

Attached for consideration by the Elected Members in this May 2024 Council Agenda is the Local Fund Statement for the period 24<sup>th</sup> February to 29<sup>th</sup> March 2024. Information is provided on:

- Monthly receipts and payments for current period and same period last year.
- Cumulative receipts and payments for current year and last year.
- Details of main receipting areas and receipts over €1m for the current month and same period last year.
- Details of payroll payments and non-pay payments over €1m in the current month and same period last year.

#### Overview

Over the period 24<sup>th</sup> February to 29<sup>th</sup> March 2024. Dublin City Council made payments to the value of €227.1m. Dublin City Council receipted €242.3m of funds with a surplus of receipts over payments of €15.2m moving to a net Debit balance at period end of €41m. This value of is €41m is the maximum value applicable, as it includes the full value of payments made whether cashed or not. As at 29/03/2024 Dublin City Council had placed €333.8m on investment. The net transfer to investments and refundable deposits was €51m.

There were 5 weeks in March 2024 and 5 weeks in March 2023.

### Receipts

During the period Dublin City Council receipted €242.3m.

€66.3m was receipted from the Department of Housing, Local Government and Heritage during the period as follow

- €13.2m for Homeless Expenditure Recoup Section 10 Q1 2024
- €24.3m for Local Authority Housing Stock Acquisitions
- €7.2m for Local Authority Housing Stock Developments O'Devaney Gardens €6.6m and Finbar Court
- €2m for Energy Efficiency Works
- €9.8m for Voluntary Housing Bodies CALF, CAS and CLSS
- €5.6m Funding- The Peter McVerry Trust
- €1.1m for Homeless HAP December 2023 (increased number of properties secured and increased rent costs than previously)
- €1.5m for Riots in November 2023

€11.4m was receipted from the other local authorities during the period including:

- South Dublin County Council €2m for February Fire Brigade Contribution
- Dun Laoghaire Rathdown €1.6m for February Fire Brigade Contribution and €2.3m for Q1-Q4 Homeless Policy Contribution
- Fingal County Council €4.2m for January & February Fire Brigade Contribution

€6.4m was receipted for Development Levies including €1.9m for Mater Misericordiae University Hospital – development of the Covid emergency extension block at Eccles Street and €1.8m for Waterside Block 9 Developments Limited – Office, retail, exhibition/gallery space – City Block 9, North Wall Quay, Mayor Street Upper, Dublin 1.

€3.6m was receipted for Uisce Éireann including €3m for Payroll, CMC Pension & CMC Costs for January and February 2024 net of RCT deductions. From January 2024, CMC and Pension costs are being recouped from DHLGH on a quarterly basis. Uisce Éireann will continue to be charged for Payroll and Goods / Services.

### **Payments**

During the period Dublin City Council made payments to the value of €227.1m. €33m was paid to Contractors as follows:

- €1.2m to Beauchamp's Solicitors Purchase of Local Authority Housing Stock Deposits and Balances of 3 units in D9, D10, D12.
- €2.9m to Bartra ODG Limited Payment regarding construction / refurbishment of Social and Affordable unites at O'Devaney Gardens, Dublin 1.
- €3.2m to Sheehan & Co Solicitors Acquisition balance 14/15 Fitzwilliam Quay, Dublin 4 to be converted to Social Housing.
- €5.7m to Homeless Voluntary Body The Peter McVerry Trust Funding.
- €3.5m to Homeless Voluntary Body Dublin Simon Community Q1 Funding €2.4m and CAS re Ushers Island Treatment Centre €1.1m.
- €1.2m to Circle Voluntary Housing Association CAS St. Michaels Estate, 52 Apartments for the Elderly.
- €3.2m to Co-Operative Housing Ireland Society LTD 1<sup>st</sup> CALF drawdown for Wellington Street, Dublin 7. 24 x Social Housing Apartments.
- €1m to Purcell Construction LTD Local Authority housing stock at Glin Court & New Quayside Building Dublin 1.

- €1.7m to Clonmel Enterprises LTD Road Refurbishment Clontarf to City Centre Project.
- €1.1m to Energia Electricity costs across the Council for January and February 2024.
- €1.1m to Bord Gais Energy Limited Gas costs across the Council: November/December and December/January.

Payments were made for the WTE Dividend Q4 2023 of €1m to Dun Laoghaire Rathdown County, €1.3m to South Dublin County Council and €1.3m to Fingal County Council.
