ENVIRONMENT AND TRANSPORTATION DEPARTMENT

Road Maintenance Services

Road Maintenance Services' 2024 Annual Works Programme, for the upgrade of roads and footpaths aims to deliver approximately 32km of renewed footpaths and 13km of resurfaced carriageways across the City. Tender documents are presently being prepared for issue to contractors to tender for works packages. It is anticipated that these upgrade works will commence in May and continue through to November.

From January to March, the Division's direct labour crews repaired/ made safe approximately 1,300 defects and hazards on the road network. Furthermore, approximately 101 critical defects and hazards on the road network were repaired/ made safe within 24-hours of them being reported.

Road Maintenance Services responded to the impact of the high wind event, Storm Kathleen on 6th April, removing sixteen fallen trees and ensuring the safey of road users.



Parking Tag and alternative methods of paying for parking

Revenue for Parking Tag for week ending 7th April 2024, was €355,369.90. For week ending 7th April 2024, the usage of coin in parking meters was €86,148.00 and for week ending 7th April 2024 card payments were €137,870.79.

Permit Parking, Pay & Display

New Schemes:

A new Residential Parking Permit scheme commenced in Clare Road, Dublin 9, hours of operation are Monday to Saturday 7am to 7pm and Ebenezer Terrace, Dublin 8, hours of operation are Monday to Saturday 7am to Midnight. Both schemes commenced on 8th April 2024.

Waste Services Update

Team Dublin Clean-Up

The 7th Annual Team Dublin Clean-up which took place on Saturday, 27th April 2024 from 11am and 1pm.

Team Dublin Clean-up encourages residents, community groups, businesses and environmental groups in Dublin to come out and support clean-up events in their local area. Dublin City Council's, Waste Management Services will provide clean up equipment and will collect and dispose all litter collected by the groups.

All groups taking part will be entered into the Dublin City Neighbourhoods Competition and will be in with a chance to win €1,000 for their community.



Waste Management Recruitment

Further to a street cleaning review, interviews for an additional 100 general operatives will commence from the end of April. Recruitment will be on a phased based later in the year and support expanding core city centre 24 hour cleaning and increasing staff numbers across DCC areas.

Waste Management New Fleet on the Streets

Waste Management Services took possession of 5 Multihog CV350 Compact Road Sweepers. The new sweepers are based in our city centre depots Bow Lane and O Rahilly Parade. In addition to the Compact Sweepers we 2 Compact Washers which will be in operation in the coming weeks, the Compact Washers will be used to clean selected footpaths and pedestrian areas.



Dublin Waste to Energy Community Gain Fund

32 grant applications were approved grant funding in respect of the Dublin Waste to Energy Community Gain Projects Grant Scheme 2023 and the total value awarded was €995,027. To date 15 grant recipients have completed their projects and drawn down grant funding to a value of circa €326K. The remaining 17 grant recipients have until the 1st September 2024 to complete their grant aided project.

The Dublin Waste to Energy Community Gain Fund Committee are currently inviting nominations for the position of Community Representative on the Committee to represent the interests of the following sectors:

- 1. Community, Residents Association and Voluntary Sector
- 2. Arts, Culture, Education, Environment and Sports Sector
- 3. Business, Social Enterprise, Health and Social Care and Charity Sector

There are 3 Community Representative positions available, one for each of the above sectors. The nominees should be representative of one of these sectors but will represent all of them on the Committee. The closing date for the submission of nominations is the 10th May 2024. Application forms are available by e-mailing cglc@dublincity.ie. It is expected to have the selection process completed and the newly

appointed Community Representatives in situ by mid-June 2024.

Fleet Management Services, Environment and Transportation Department.

A request for tenders for the establishment of a Single Operator Framework Agreement for the supply on lease hire with maintenance of Waste Management Services' Side Loaders (Side-Loading Box Cage Body Tipper Vehicles), used for street refuse collection was published on eTenders on Monday 4 March 2024, with a closing date for submissions of Friday 26th April.

As a decision was made to electrify at least 50% of these Side Loaders, this tender was broken into two Lots – one for low emission (ICE) vehicles and one for electric vehicles. It is expected that at least 25 EVs will be added to the fleet in place of diesel vehicles as a result.

In order that these EVs can charge at a sufficient rate so as not to affect service a tender is also currently being drafted for the supply and installation of up to thirty 22 kW AC EV chargers in the North City Operations Depot in Ballymun.

A request for tenders for the establishment of a Multi-Operator Framework Agreement supply on lease hire with maintenance of Light Commercial Vehicles for all DCC divisions is currently being drafted and will be published in Q2 of this year. It is our aim then is that 40% of this Light Commercial Vehicle fleet (approximately 80 vehicles) procured in the upcoming procurement exercise will be electric vehicles, pending the installation of requisite charging infrastructure.

As such Dublin City Council aims to exceed the revised 'Clean Vehicles Directive' (Directive 2019/1161/EU established in law in S.I. No. 381 of 2021) across each of these procurements.

The S.I. establishes a minimum target for the share of clean vehicles procured by public bodies of 38.5%. Until 31/12/2025 a 'clean' vehicle is defined as a vehicle which emits a maximum 50 g CO_2 / km, thereafter a clean vehicle is defined as a vehicle which emits 0 g CO_2 / km – a zero emission vehicle i.e. an electric vehicle.

Because the standard lease hire term that DCC lease hire vehicles is 5 years we will equate

clean vehicles with zero emission vehicles more immediately.

Protection of Water Bodies Office (PWBO)

Dublin City Council is working to deliver a number of projects to ensure that we meet our Water Framework Directive (WFD) obligation of achieving "good" status for all our water bodies by 2027.

Current examples are:

Golden Lane Public Realm Redevelopment - Urban Runoff (Action 70):. Tender awarded for multi design team and installation of monitoring equipment. Design and monitoring equipment installation is expected to commence within Q2 2024

Culvert Improvement Works – Screen Upgrade Works. The construction contract is substantially complete.

Santry River Restoration and Greenway Project (<u>www.santryriver.ie</u>) – The Design stage is ongoing, currently flood design element).

Rainscapes Nature-Based Solutions Project (River Santry and River Dodder Rainscapes | Dublin City Council). Tender for the contractor for phase 1 (McAuley Park) open for submission.

Bathing Water: Fortnightly sampling at bathing water locations continues in accordance with the DCC out of Bathing Water Season monitoring schedule. Samples results are available online, on www.dublincity.ie and www.beaches.ie

Flood Defence Project - Camac River

Consultants have been appointed by DCC to investigate the reduction of flood risk across the DCC and SDCC sections of the River Camac. Environmental and topographical surveys are now complete. A computer model has been built to investigate tidal, fluvial and pluvial flood risks associated with the river. Preliminary flood extent maps have been verified. Flood alleviation options such as storage, walls, embankments and de-culverting are currently being computer modelled. A further public consultation is planned in April 2024 on emerging options following the successful ones in June 2022.

This study, as with all other flood alleviation projects, is being integrated into a desire to "deculvert" and widen, what is now seen as an over

engineered river, where possible so that it can, over time, be restored to a more natural state, as far as reasonably possible. The project will also involve identifying and remedying urban pollution sources, where possible. This is also being done in conjunction with an existing Greenway proposal and in tandem with Urban Regeneration and Development Fund (URDF) funded projects in the area. The new City Edge project gives opportunities to achieve some of River corridors of 10m-25m wide are policies in the development plan and these will be implemented where possible on this very constrained river. Liaison with large stakeholders is ongoing on possible flood storage areas in DCC and SDCC.

Further wintering bird surveys are ongoing in 2024 to identify protected species as well as other bird quantities. Building threshold surveys are completed. A large Site Investigation for both Dublin City Council and South Dublin County Council areas of the Camac catchment commenced in July 2023 and is now complete. This involved over 100 areas of investigation.

Public consultation days took place in Dublin City on 17th April and in South Dublin on 18th April. Updates on this project can be seen on Camac Flood Alleviation Project website www.camacfas.ie

Drainage Planning, Policy & Development Control

The SuDS Working Group has produced a new "Property Level Guide to SuDS". This is intended to give guidance on SuDS implementation for small developments, individual houses. extensions, driveways etc. lt provides straightforward advice on meeting SuDS requirements in the City Development Plan. It also assists anyone who may want to install water butts, permeable paving etc. to help protect their own local area from flooding and climate change. A media campaign was carried out before Christmas to highlight the issue of people paving their gardens with impermeable materials.

To ensure sustainable development within the City, the Drainage Planning, Policy and Development Control team has established a framework for auditors of Basement Impact Assessment Reports. There are five consulting engineer companies on the cascading

framework and a number of BIA reports are currently under review.

Climate Action Team

Climate Action Plan

Submissions received have been reviewed and compiled into the Chief Executive's Report, that was presented in draft for the SPC. The final report has been submitted to the Council along with the final plan for adoption. Submissions are broadly supportive and constructive, and where appropriate actions and text have been amended to reflect.

EV Strategy

The Dublin Local Authority Electric Vehicle Charging Strategy was published in June 2022.

To support the Electric Vehicle Charging Strategy, the four DLAs agreed to a pilot project to install 200 charging points (at 50 locations) across the City and County.

The final date for submission of tenders was 7th February, 2024 and the successful tender is expected to be appointed in March 2024. The pilot project is primarily focussed on destination charging. All new (or upgraded) commercially operated car parking developments will be required to provide a minimum of 50% of spaces with EV charging facilities.

Energy Management

DCC Energy Oversight Committee have agreed to progress towards attaining ISO 50001 Energy Management System Accreditation.

Achieving ISO 50001 certification will enhance DCC's reputation as a socially conscious and responsible organisation.

Putting structures in place to induce collaboration between departments will facilitate a more effective response to tackling GHG emissions and improving our energy efficiency.

Decarbonising Zones

Workshops in Ballymun and Ringsend/Poolbeg have been completed. Drafting of the plans will now be completed by Codema.

Dublin Metropolitan Climate Action Regional Office (CARO)

The DM CARO team assisted in organising and facilitating a networking event for Directors of Services, CARO staff and local authority climate teams in Ennis in April. DM CARO made a presentation and participated on a panel discussion. The Minister for Environment, Climate, Communications and Transport officiated on day 2 of the event for the official launch of the Local Authority Climate Action Plans.

The DM CARO team assisted in the report to the Climate Change Advisory Council 'Assessing Progress in Adaptation and Resilience'. This was undertaken on behalf of the County and City Management Association.

Draft Dublin City Centre Transport Plan 2023

The current Dublin City Development Plan (2022-2028) objective SMT05 requires a update of the 2016 City Centre Transport Study. "To review the City Centre Transport Plan 2016 in collaboration with the NTA in the lifetime of the an, setting out a clear strategy to prioritise active travel modes and public transport use, whilst ensuring the integration of high quality public realm."

Consulation on the plan has finished and over 3,500 response were received. A full report on the consultation and the final plan was presented to the Transportation SPC on the 7th of February. And to the Council Meeting on April 8th.



The Active Travel Programme Office (AcTPrO) – Walk-Wheel-Cycle Network

The multi-disciplinary team within the Active Travel Programme Office (AcTPrO) continues to work on the design and delivery of a number of projects as part of the overall network, which when fully completed, will result in 95% of people being within 400 metres of the high quality network within Dublin City.



A more extensive quarterly report on the activities of AcTPrO, was submitted to the Lord Mayor and Elected Members for this April Council Meeting, report no. 85/2024.

Customer Services had two representatives attend the Access in the Public Realm event, on 20th March, to better understand the issues faced by customers. This was suggested at the Public Participation Focus Group at the inaugural meeting held in March.

<u>Gaeilge</u>

Customer Services have proposed a pilot project to improve the reported issues in relation to signage in Gaeilge and to involve the Irish schools in the project and therefore identify the organisation as an employer of choice for school leavers who wish to utilise their language skills in their future employment. This project has been shortlisted for a staff award.

Interpreter Service

- A pilot project has been agreed with interpreter services Samanta, via an online app which uses live people. It is expected that the interpretation service will be available within 5 minutes for customers.
- A review of the main languages required has been received from the Housing department to ensure that the service will be of maximum benefit to the customers presenting at the Civic Offices.

Quality Assurance



Customer Services have been shortlisted for a Quality Assurance award. This relates to the Q Mark award received in the Mansion House in February and recognises the best practice being employed by the section.

Dublin Officially Accepts European Capital of Smart Tourism 2024 award



At the end of March, the official ceremony was to hand over the title of 'European Capital of Smart Tourism' to Dublin. Over 100 representatives from our staff and partners attended this ceremony. This event took place in the Tourism team's new office space in CHQ. With its modern design and state-of-the-art facilities, the space serves as a hub for fostering partnerships, hosting workshops, and driving forward initiatives to elevate tourism standards across Europe. The new space is a beacon of innovation and collaboration perfectly

mirroring the ethos of the European Capital of Smart Tourism Award.

Dublin Economic Monitor Launch

The Dublin Economic Monitor released their March 2024 issue. A launch event took place in Grant Thornton's Dublin offices for this issue centred on the theme of smart tourism. Owen Laverty mediated a panel discussion on smart and sustainable tourism composed of Megan Best (CEO, Native Events), Eoghan O'Mara Walsh (CEO, ITIC), Liz Halpin (Head of Dublin, Fáilte Ireland), and Barry Rogers (Head of Tourism Unit, Dublin City Culture Company). Smart D8 Community Engagement - Q1 2024

In the first quarter of this year, Smart D8 has directly engaged with almost 700 community members in the D8 area, through supporting and participating at key community events focused on topics like Mental Health, Healthy Food and Eating and Physical Health and Well-being.



Following three years of success in engaging Enterprise, Academia and a range of relevant stakeholders, the Smart D8 initiative has delivered 12 impactful and scalable pilots. Any rezoning request submissions received will be assessed and a report prepared; and, if considered appropriate, may be recommended for a variation of the City Development Plan.


