Litter Hotline/CRM

In the period 1st – 31st April the following incidents were reported via Litter Hotline / Citizens HUB for the Central Area.

In addition to the Citizens Hub reported numbers, the Public Domain crew for the North Inner City & Glasnevin / Cabra Area carry out inspections of their assigned routes on a daily basis. They collect any dumped bags / materials found, that is not always reflected on the above figures.

The total tonnage of collected illegally dumped items from our four vehicles was:

- **21.76 tonne** for April 2024. Total Tonnage for 2024: **85.4 tonne**.

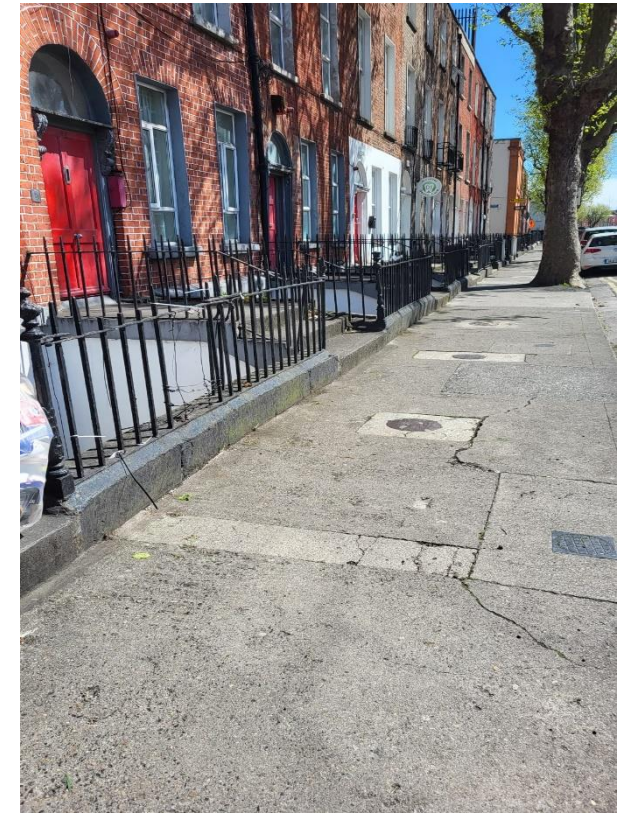
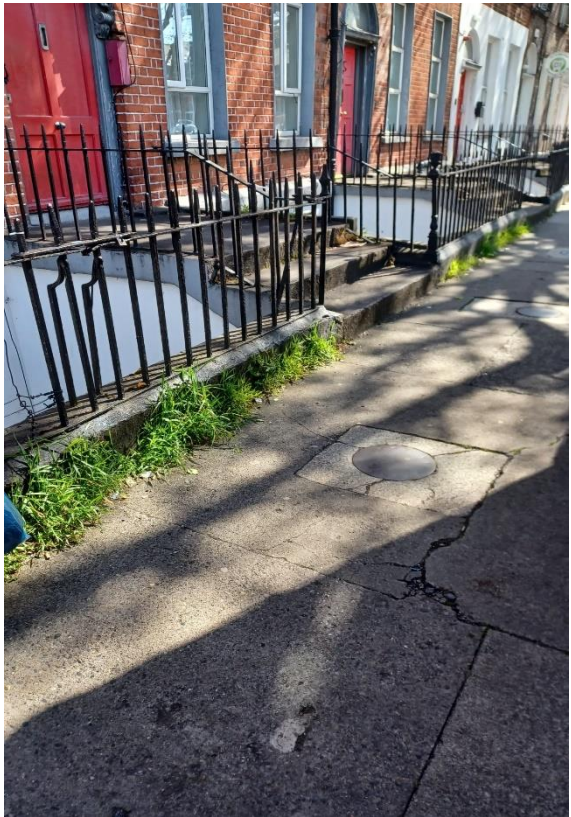
Spring Clean - Team Dublin Clean Up

Public Domain crew removed material from an area near the Royal Canal Cycle way between North Strand and Sheriff Street on 24th April.

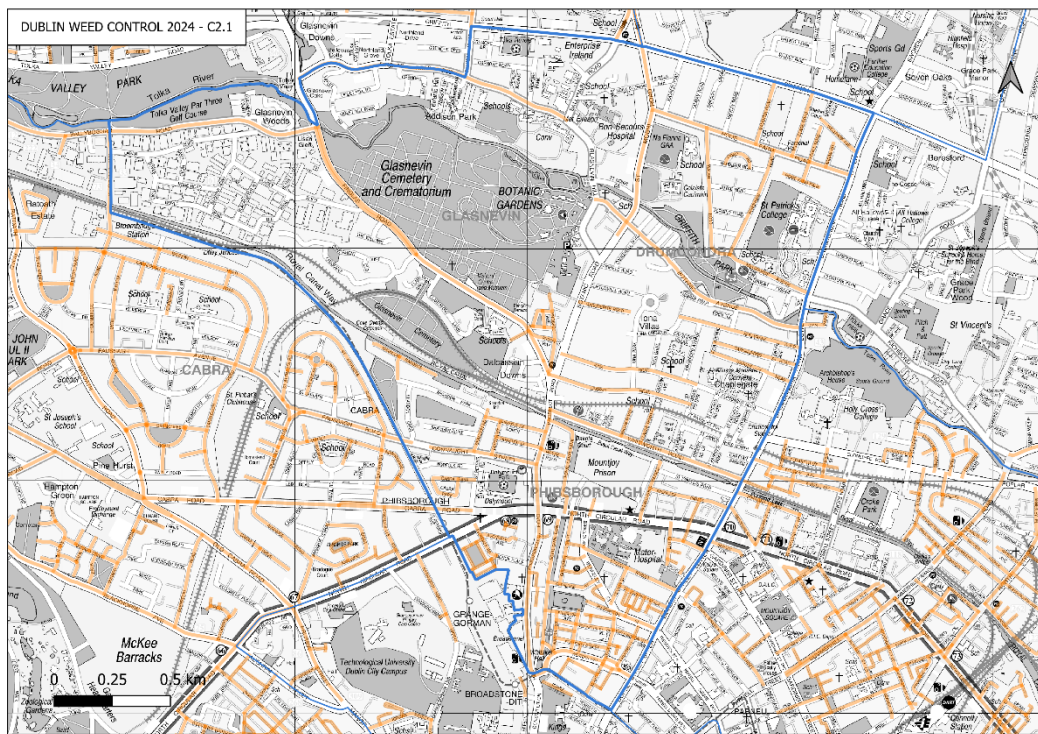


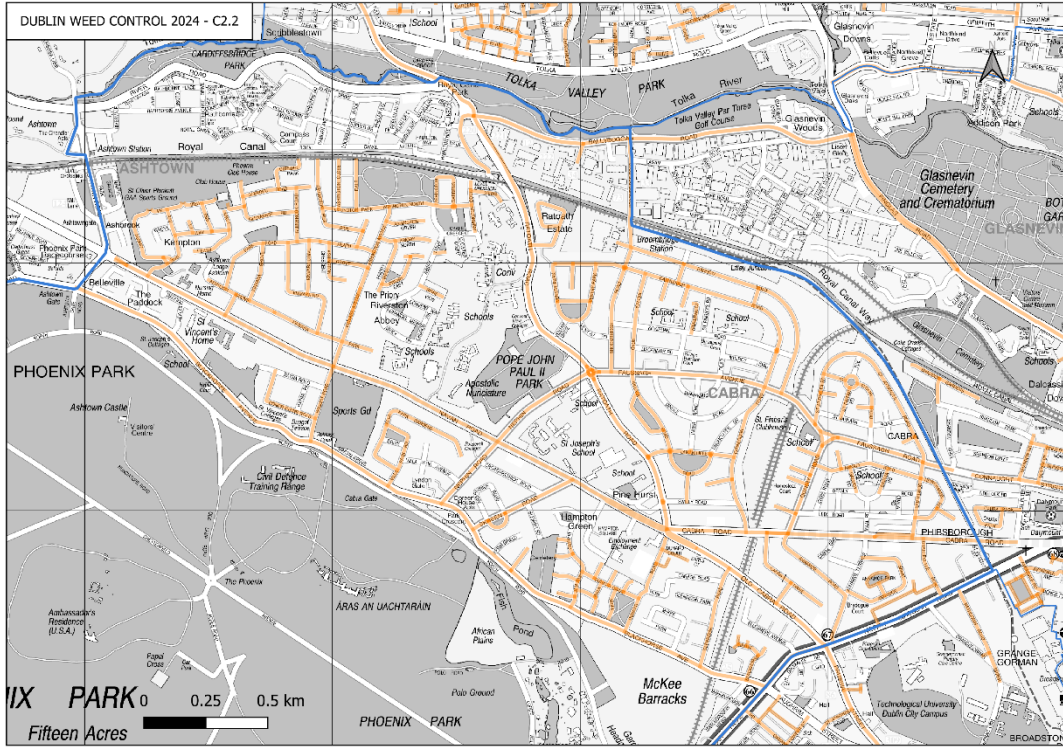

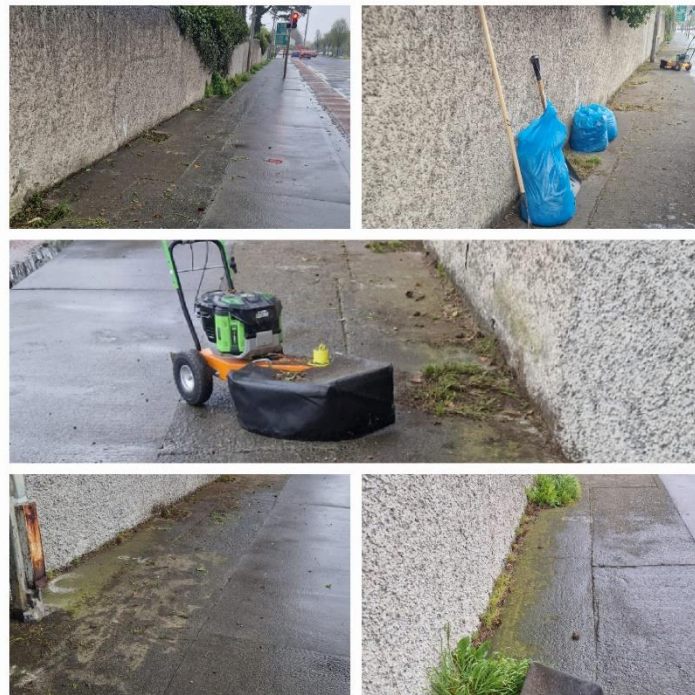
