

MINUTES OF THE CLIMATE ACTION, ENVIRONMENT AND ENERGY STRATEGIC POLICY COMMITTEE MEETING HELD ON 27th MARCH 2024

1. Minutes of the meeting held on 29TH November 2023 & 31st January 2024

 - (i) The Chair welcomed the launch of the new Climate Action Plan.

Derek Kelly advised the Committee that Committee's endorsement to City Council to put the plan out to public consultation should have been sought at the meeting held on 31st January when the presentation on the plan was given.

6. Sustainability and the event sector - Simon Clarke

Members thanked Simon for his report and raised the following questions / issues

- DCC needs to be leading at all events, e.g. vendors using fossil fuelled generators should not be allowed.(DC)
- I noticed disposable e-cigarettes being sold at a Fairview Park event.
- Single us items were used at the launch of the Climate Action Plan (CM)
- Are there figure available on the % of compostable items that are being successfully composted (CM)
- The ban on the single use plastic was successful, it would be a shame for it not to continue (CM)
- We should be looking at direct connections for electricity at events (CB)
- What happens if a trader is not compliant with the sustainability element of the licence (CB)
- What needs to be done to stitch environmental requirements into licences at DCC events (CB)
- Can we contact planning to advise what can be done.

Simon responded

- An overall strategic policy is required to cover all events
- We use contractors that can certify that items are composted / recycled
- The contractors would verify that the material has gone through whatever process is needed
- I would have no problem with DCC initiatives being on display at events, e.g. one cup, single use plastics etc.
- Planning should be consulted in relation to licenced events.

Actions:

- (i) Liaise with Planning to clarify what can be put into event licences to preclude the use / sale of single use plastic, waste &fossil fuels for energy
- (ii) Training to be provided to DCC Events staff on sustainable event management
- (iii) Clarify if this SPC can develop a policy on sustainable events or is it a matter for the Arts SPC.

7. Bathing Water Quality, Emma Senior Executive Engineer

Members thanks Emma for her presentation and raised the following questions / issues

- Disappointed that North Bull wall is not a designated bathing area as 00's us this
 amenity. The EU directive makes it clear that areas used for bathing by many people
 should be a designated bathing area (DC)
- There should be Councillor / swimmers groups representation on the Management Group (DC)
- It should be noted that the main sources of pollution is the waste water treatment (DC)

- The water quality is not on <u>bathing.ie</u> (DC)
- Why has our request to have North Bull Wall designated not been facilitated (DC)
- Can the membership of the management group be expanded to include Councillors / Swimmers Groups etc. (DC)
- It is great to see that there is science underpinning the data (NOM)
- The 55% for fouling in shocking
- Designating North Bull Wall should be designated (NOM)
- Is there signage, poo bag dispensers on Sandymount Strand (CB)
- How far away are from real time pollution information

Emma, Roy & James responded

- DCC has dedicated public participation webpage
- Participation period ran from May September 2023
- We received 5 submissions for the North Bull Wall; location was assessed in accordance with the EPA criteria and it did not meet the required criteria for designation
- All submissions were replied to with reasons for non-designation
- It is sampled at the same frequency as other areas and results are published similarly
- 55% of poor water results are directly attributable to dog fouling
- We are happy to present at future meetings if required
- The designation status has no bearing on the level of work / sampling etc being carried out
- Real time info cannot be provided currently

Sabrina responded

- An artist will be engaged in consultation with the community for the hoardings
- On the Northern most block we are planning on taking 500metres to display rain water harvesting, water planters & rain gardens. This will inform the final design of what goes through

Members thanked Barry for the report and raised the following questions

- Would rather see the suburban areas get the additional attention first (NOM)
- Are you satisfied that category c, weekly clean is in fact a weekly clean(NOM)
- Would it be possible to look at smaller electric refuse collection vehicle (DC)

Barry responded

- Areas on the fringes of the Central Commercial District will know get a 24 hour (Thomas Street / Baggot Street) service which will help street cleaning deployed to the suburbs.
- We have gone to tender for a new fleet which will be 50% electric

11. Motion tabled at the January meeting of the South East Area Committee

"This area committee agrees that in line with the city's circular economy and waste reduction objectives, and supporting government efforts to reduce the use of single use coffee cups, it will be a condition for all new licences issued by DCC to operate coffee docks and tea rooms in the South East Area that the use of single use cups will not be allowed. Many compostable cup designs cannot be recycled and are not disposed of properly, and our city does not provide bins for the separate collection of compostable food containers, so all new applicants for licenses to operate coffee docks and tea rooms should commit to using only reusable/returnable beverage containers for sit down and takeaway orders."
