## Dublin City Council Strategic Policy Committees 2024 - 2029 Sectoral and Public Participation Network Membership

---

### Introduction

Under Section 48 Local Government Act 2001, (as amended by Section 41 of the Local Government Reform Act 2014), a local authority shall establish by resolution committees to be known as Strategic Policy Committees (SPCs). These committees are to consider matters connected with the formulation, development, monitoring and review of policy which relate to the functions of the local authority and to advise the local authority on those matters.

Following the Local Elections, it is necessary for each local authority to establish new SPCs in line with the revised Guidelines for the establishment and operation of Corporate Policy Groups and Strategic Policy Committees published by the Department of Housing, Local Government and Heritage in June 2024. SPCs are intended to be strategic in nature while the operational matters are dealt with at Area Committees. The Council is, and remains, the decision making authority and the final decision on strategic issues rests with the full Council. All policies formulated by an SPC must go to Council for adoption or amendment.

The Department of Housing, Local Government and Heritage Guidelines state that the SPCs should:

- assist the Council in the formulation, development and review of policy and strategy
- reflect the major functions or services of a local authority within the broader context
- take account of the Council's overall corporate policy and objectives, integrate with statutory plans and link realistically to financial resources
- be tailored to the size, membership and administrative resources of a local authority
- be chaired by one of the councillor members.
- have a minimum total membership of nine.
- have at least one third of their membership drawn from sectors relevant to the Committees' work. At least one of those members on each committee should be drawn from the Public Participation Network Membership.
- meet twice yearly at a minimum. SPCs in Dublin City Council have traditionally met four to six times a year

### Appointment of Chairs Designate

Dublin City Council at its meeting on the 1<sup>st</sup> of July 2024 established seven SPCs, agreed that the Draft SPC Scheme should go out for consultation and appointed seven Councillors to be the Chairs Designate to each SPC.

### Scheme Adopted and Appointment of Elected Members

In September 2024 the Draft SPC Scheme 2024-2029 (Report No.173/2024) was amended and adopted by the City Council and Elected Members were appointed to each of the SPCs (See Appendix A). The remit of each SPC was agreed (See Appendix B). This list is indicative, not exhaustive.

## **Revised Sectoral Representation on SPCs**

The Council agreed that the appropriate sectoral and Public Participation Network (PPN) membership on each SPC is as outlined in the table below. The overall representation by sector of the 44 sectoral members was to be 15 PPN, 21 Business/ Commercial, 6 Development/Construction, 2 Trade Union. Arts groups, most housing bodies, cultural groups, professional and other bodies are treated as Business /Commercial under the scheme.

## **Appointment of Sectoral and PPN Representatives**

The PPN held their nomination procedure and have selected 15 representatives to fill the 15 PPN vacancies on the SPC.

Dublin City Council called for expressions of interest to cover the Commercial/Business, Development/Construction and Trade Union vacancies. Nominations were received from 19 organisations by the closing date of Monday, 30<sup>th</sup> of September 2024. Many organisations were nominated for multiple SPCs. The Elected Members on each SPC met and reviewed the nominees and organisations, and have recommended the organisations listed in **Appendix C**. All SPCs will have had their induction by mid-November and the first formal meeting of each SPC will take place in November/December.

## **Corporate Policy Group (CPG)**

The Corporate Policy Group comprising the Lord Mayor and the chairpersons of the SPCs was re-established by the July City Council meeting. The CPG will continue to provide a forum for policy issues which transcend the remit of individual SPCs and where policy positions affecting the whole Council can be agreed for submission to the full Council. The CPG has a role in budget preparation, value for money, service delivery plans and corporate planning.

The Council hereby approves the SPC membership 2024-2029 and the nominations included therein.
