The vehicle images in RED reflect where vehicles habitually park (by neighbours, **details supplied 2**),. The engineer's drawings and markings in the images sent by DCC are not relevant to the reality of what goes on here on a daily basis, the resident informs me. Can this be reassessed as promised?

Reply

In accordance with the Road Traffic (Traffic & Parking) Regulations 1997, Section 36 paragraph (2); A vehicle shall not be parked:

(g) in any place, position or manner that will result in the vehicle obstructing an entrance or an exit for vehicles to or from a premises, save with the consent of the occupier of such premises;

Double yellow lines are intended to ensure the smooth flow of traffic and to prevent hazards and congestion due to parked vehicles. They are not provided outside private entrances or driveways, as it is illegal to park in such a manner as to obstruct a driveway or entrance. Enforcement is a matter for the An Garda Síochána.

By means of an interim measure at the junctions of (i) Merville Ave/Fairview and at (ii) Fairview Ave Lower/Fairview the Clontarf to City Centre Project have closed off two parking spaces at each location.

The Road Safety Audit for the Scheme was undertaken on the last week of January. Once the findings of the Audit have been assessed the next steps for the two areas shall be considered. We can revert back once any proposals have been established.

Whilst longer term proposals are being assessed the two spaces in advance of Fairview Ave Lower and Merville Ave shall remain closed off.

Based on the applicant's positions, it may be some time before they are reached for an offer of housing. Dublin City Council allocates properties based on time on the list and currently there are applicants on the waiting list of longer standing who have to be considered as suitable vacancies arise. It is not possible to indicate accurately the prospect of an offer for any applicant. The number of vacancies arising will be a determining factor in the length of time applicants could expect to be on the waiting list.

Dublin City Council are increasing the number of units that are being allocated through the Choice Based Letting Scheme, such vacancies are advertised on the DCC website. Applicants can only apply for properties in their chosen areas that meet the size requirement of their household.

The applicant may be eligible for HAP which will provide her with financial assistance towards the cost of renting another property. Should the applicant wish to apply for the HAP scheme, she should make an appointment with a Housing Advisor in Housing Allocations and bring in her current income details wherein she can be advised on the scheme.

The applicant's interest in the new build at Oscar Traynor Road has been noted on her housing file.

Reply

Glenveagh Developments are engaging with Building Control and are continuing investigations on site to identify all potential issues. Glenveagh have paused some works until such time as they identify all issues and have a clear plan to address the Building Control issues identified.

However, some works are still underway.

1. In the current phase investigation works are underway and the results of these investigations will identify works that require remediation and will be outlined to Building Control.
2. In Phase 2 area of the development Glenveagh are carrying out essential works to concrete structures that are partially erect to ensure they are safe until such time as work resumes in that area. Glenveagh are also continuing works installing ESB infrastructure around the site and works to de-culvert the Naniken River.

Glenveagh will be notifying Building Control when works are commencing to ensure Building Control have the opportunity to inspect as required.

The project is in the early stages and is ultimately scheduled for completion in early 2028, Glenveagh are still endeavouring to occupy the first units in the scheme by the end of 2025 subject to ongoing engagement and the timely resolution of any Building Control compliance issues.

Further, where on the path should those turning left over the bridge be? If this is outside the remit of the NCAC could it please be referred to the relevant official for a response to issue to the NCAC?

Reply:

The intersection between the *Royal Canal Phase 2*, *Royal Canal Phase 3* (Charleville Mall) and the *Clontarf to City Centre Scheme* at Newcomen Bridge is an important intersection along the Active Travel network. The layout of this intersection (utilising a toucan crossing) follows best practice design guidelines whilst also accounting for the existing environment such as the physical structure of Newcomen Bridge itself.

Toucan crossings are signal-controlled crossings where pedestrians and cyclists share the crossing with no separation between the two. This is the arrangement provided for at the intersection between these three Active Travel Schemes. The ramps provided from the Clontarf to City Centre Scheme cycle-track (as shown in Fig. 1) are intended for cyclists to exit the *Clontarf to City Centre* track and gain access to the shared space and turn left or right as required (right turners shall utilise the toucan crossing).

The design provides for any right-turning cyclists to be able to safely access the toucan crossing, call the crossing and then wait in a safe location that doesn't block the cyclist travelling straight ahead.

With respect to the layout of the *Clontarf to City Centre Scheme* cycle-track if an inbound cyclist wished to access Charleville Mall to the *Royal Canal Phase 3 Scheme* or if travelling outbound to access the *Royal Canal Phase 2 Scheme* they shall need to cross North Strand Road. To safely manage all required movements, the layout as-constructed provides for all straight ahead cyclists to continue as normal along North Strand Road with and a ramped transition provided to bring all turning cyclists up to a shared space. Tactile paving is provided to warn users that they are entering a shared space. The reason for the ramp is to accommodate all turning cyclists and to try avoid the straight-through cyclists being blocked by those waiting to cross North Strand Road. Otherwise the straight ahead cyclist might have a green signal but may not be able to progress if turning cyclists were blocking the track. After using the ramps to exit the main track with caution left-turning cyclists can continue on their route and right-turning cyclist are required to wait at the toucan crossing.

As it may not be initially obvious that it is necessary to utilise these ramps in order to turn right from North Strand Road a right-turn arrow on the ramps has been provided to communicate this message. Space is limited on the ramps and the markings have regulatory sizes and layouts. Cyclists can queue on the ramps if required out of the way of the straight-through cyclists and can progress with care to the shared space and turn left to continue their journey or turn right to the toucan crossing to cross North Strand Road.

The litter wardens for the North Central Area patrol daily, removing bags of waste for investigation to try and gather evidence to issue fines to offenders under the Litter Pollution Acts 1997-2009. The difficulty is, that due to GDPR, identity theft and paperless billing, it is becoming increasingly difficult to identify offenders this way as people are extra vigilant to dispose of their bills, correspondence carefully. This means the wardens will need to be present when these offences are taking place and have the assistance from the Gardai to gather the offenders name and address. Being lucky enough to be present during these offences taking place is hard enough, having the Gardai present at the time makes it almost impossible to catch these people.

CCTV is an option but will not help unless the offenders use a vehicle in carrying out the offence. Footage of a person walking to dump a bag does not give us a way of identifying that their name and address.

In recent years the homes there have been upgraded to an average B1 BER rating from an original E1 rating through a range of measures including;

- the buildings in the estate were wrapped in 2016 / 2017 to improve insulation;
- in 2015, with support from SEAI's Better Energy Communities Scheme, the heating system was significantly upgraded and this work consisted of replacing the 3 no. boilers that serve the estate with 2 no. air to water heat pumps which are much more efficient.
- The single glazed windows in the units were upgraded to double and triple glazed at the time.
- the roofs were re-laid insulated and the water tanks were changed from galvanised to plastic and insulated.
- Weather compensation controls were installed as part of the heating upgrade which moderates the flow water temperature to each apartment based on the external temperature.
- Temperature sensors were installed in each apartment which enables internal conditions in each apartment to be monitored remotely (see images below).
- A new fast-recovery hot water cylinder was also installed.

Reply from the C2CC Project Team:

During the course of the construction of the Clontarf to City Centre Scheme (C2CC) it was noted that there was routinely significant traffic disruption caused as a result of cars entering and exiting the gym and blocking the footway and cycle-track at the gym entrance. This was the case prior to any reduction of vehicular movements entering or exiting the gym. It was regularly observed that there were two queues of traffic trying to get out of the gym (turning left out and right out) and then a further two queues of traffic trying to enter the gym (right in and left in). Please see Figure 1 and Figure 2 for an example of what was typically observed in December 2023 during time when all vehicular movements were still permitted i.e. traffic lanes, footpath and cycle-track blocked.

During construction of the C2CC Scheme measures were undertaken to try mitigate the issues observed (as per Figure 1 and Figure 2).

Some of the measures undertaken by the C2CC Scheme included;

- Red surfacing was installed across the entrance to Westwood Gym to see if this would assist in keeping vehicles off of the cycle-track and footway.
- A central median was constructed as it was considered that there were simply too many movements coming into and out of the gym i.e. two lines of traffic entering and two lines of traffic exiting all crossing each other and interacting with general traffic on the road and also impacting on cyclists and pedestrians trying to pass the gym entrance.
- By constructing the central median it reduced the number of vehicular queues at the gate to two i.e. left turn out and left turn in only. This does appear to have

regularised the movements at the gate and although there does appear to be queues waiting to enter the private car park it could be regarded that the situation has certainly improved for cyclists and pedestrians at the entrance. As a result of installing the central median;

- Right-turning traffic exiting the gym which is now restricted which reduces one line of vehicles potentially sitting on the footway/cycle-track waiting to make the right-turn across several lanes of traffic.
- Right-turning traffic entering the gym is now restricted which reduces another line of vehicles potentially sitting on the footway/cycle-track or else sitting on the outbound carriageway waiting to make the right-turn and delaying outbound traffic whilst queuing to gain access the gym car-park.
- Outbound traffic is now required to pass the gym main entrance, past the DART Station access and make a turn. This layout routes motorists past the gym overflow car-park (car-park no.2 adjacent to the DART Station car-park) providing a second parking option to motorists if they do not wish to queue for the main complex (car-park no.1). It also ensures the new and frequent bus services accessing the DART Station have a clear route to access the DART Station and continue on their route.
- A yellow box which was removed as part of the roadworks outside of the gym main entrance has been reinstated to try assist vehicles exiting the gym to clear the entrance quicker and hence assists in clearing the car-park quicker.
- The provision of dedicated access in the central median for buses to enter unhindered into Clontarf DART Station was provided as part of the C2CC Scheme. Access for the new frequent bus routes to access the DART Station now provides excellent connectivity to the Dart Station, the gym and the surrounding area. This dedicated access is intended to ensure the reliability of the bus schedule for the entire route.
- The new C2CC cycle-track connects to the Clontarf coastal cycle route which extends along the promenade in the Clontarf direction and all the way to Talbot Street in the city direction. Hence, there is vastly improved new cycling connectivity options for users to access all of the facilities in the Clontarf Road area.
- Additional pedestrian crossing facilities have been provided by the C2CC Scheme in Fairview and Marino providing much improved connectivity of the residential areas around Marino and Malahide Road to the Fairview Park side of the Fairview Road and Clontarf Road.
- The Project Team have witnessed on more than one occasion the enforcement of cars queuing in the bus lane and across the cycle-track and footway.
