Pay & Display Machine replacement programme



A further 100 new machines were rolled out in July bringing the total to 300 of the oldest meter stock being replaced under the new leasing contract. A further 100 machines to be

rolled out before year end ensuring that the Very High Demand Yellow zone is fully populated. The integration of real time parking data between the machine suppliers (UTS) and the Parking Tag providers (Payzone) is ongoing with a view to developing enable a real time App to allow motorists view real time parking availability. Wave and pay technology and new multi-function meters to be trialled in October/November.

Parking Tag and alternative methods of paying for parking

Memberships increased from 134,000 in August to 137,000 in September. Parking Tag transactions averaged at 79,000 per week over the last month up from the previous monthly average of 70,000. Paying in shop registered an average of 1,000 per week and the new once off payment facility from either mobile phone or debit card averaged almost 2,400 per week up from an average of 2,000 in June. Competitive dialogue tender process to commence in Q4 and will include all four Dublin local authorities together with Meath and Kildare County Councils.

Car Clubs

Dublin's second car club operator, YUKO, has now set up on-street car club bases throughout the City. With the Council's support the launch of the first electric car club vehicles is expected to take place in October. There are currently 19 dedicated car club only bays in the City.

Electric Vehicle Only Parking

There are currently 23 dedicated EV only bays in operation on the city streets and a further 8 sites being examined for suitability.



Noise Mapping

The computation of the revised noise maps has commenced and is on schedule. Initial results for some of the areas computed indicate that night time sound levels have reduce since the 2012 round of noise mapping. Computation of the noise model will have been completed by the end of September 2016, followed by quality control checks. The computation of the number of people and residential buildings exposed to various bands of sound levels will commence mid October and is due to be complete by mid December. Sound measurements are due to be carried out in support of the development of the proposed revision of the Special Speed Limit Bye Laws. Approximately 40 locations will be assessed in relation to current ambient sound levels. These locations will be reassessed if and when the Bye Laws are implemented to ascertain whether the lower speeds resulted in the lowering of ambient sound levels.

The assessments will take place over the July /August periods in conjunction with speed assessments at the 40 locations. Sound measurements lasting 3 days, at 40 sites across the city have now been completed and the data is currently being quality controlled and inserted into one data set for analysis.

A Horizon 2020 project called ISCAPE (Improving the **S**mart **C**ontrol of **Air P**ollution in **E**urope), commenced on the 1st Of September, with Dublin City being a minor partner. Its role is to facilitate research on the impact of low barrier walls in mitigating air pollution. It will also provide relevant data for inputs into air dispersion and climate models and historical air quality data. It is due to run for 3 years with TCD being the lead partner.

Traffic Service Requests

537 traffic service requests were received in May, 692 in June and 597 in July and 472 received in August 2016. These requests include applications for the introduction of new residential parking schemes, pedestrian crossing, parking restrictions and many other traffic related issues.

Parking Enforcement Activity

A total of 4,600 enforcement actions were carried out in August including 108 vehicle relocations and 26 vehicles impounded. A new Croke Park major event parking enforcement protocol has been agreed with relevant stakeholders and came into effect on Sunday 21st August. Enforcement activities and public safety relocations have been implemented successfully for all major events in Croke Park since then.



School Warden Service

There are currently 205 School Wardens employed throughout Dublin City. Induction for 23 reserve wardens was completed in August.

Roadworks Control

There were 356 applications for licences for positioning of skips, cranes/hoists and scaffolding/hoardings in June and 324 received in July.

Progress Report on Environment Projects

Waste to Energy Project

Construction remains on schedule for completion in Q3 2017 with all construction related activities currently programmed on a 24/7 basis.

The main focus of the civil and process system designers, PM Group Limited and Hitachi Zosen Inova respectively are:

- erection of structural steel associated with the building envelope including cladding and the installation of the two stacks,
- installation of the Flue Gas Treatment equipment,
- installation and commissioning of steam and condensate pipelines,
- installation and commissioning of instrumentation and electrical equipment.

Environmental Impact

Environmental monitoring and mitigation measures continued to be implemented during the construction phase of the DWtE facility and the Construction Phase Environmental Report for quarter 1 (January – March) 2016 is available for download at the Dublin Waste to Energy Website.

To date the DWtE project environmental consultant has issued six (6) quarterly environmental monitoring reports, which have examined the monitoring results associated with Noise, Dust Deposition and Suspended solids in Surface Water. All of the data has demonstrated that the facility construction is being undertaken in line with recognised national and international guidelines in order to avoid, or minimise, potential adverse impacts to the environment and local community.

Community Liaison

Local Office

The local information office for the Dublin Waste to Energy Facility continues to operate in the Ringsend Library, Fitzwilliam Street, Dublin 4. The office operates on Tuesday and Thursday mornings between 10:00 and 12:00.

Community Gain Liaison Committee (CGLC)/Community Gain Fund

A total of 56 applications for the first Community Gain Projects Grant Scheme were received by the closing date on 31st March 2016. The CGLC has met and assessed the applications received requesting less than €100k (34 in total) and has approved 18 projects in the sum of €277k. 11 applications were rejected and additional information has been requested in respect of 6 applications.

The committee met twice in July to assess applications received in excess of €100k (22 in total seeking funding of €35.4m). The Committee has agreed to fund a number of projects in principle (in some cases subject to additional information requests and clarifications). Next meeting arranged for September to review status of projects approved, review/amend scheme for next year and to discuss autumn newsletter.

Ballymun Boilerhouse Repurpose Project

Work is progressing well on site and Purcell Construction is on programme. ABK architects, DCC and its Environmental consultant (Bevan Architects) and the Rediscovery Centre continue to work closely with the contractor on all elements of the project. The contractor has also engaged his sub-contractor for the design and installation of an ecological drainage system including compost toilets). Hempcrete walls have been completed, external cladding, including salvaged bricks, is partially complete. Timber cladding was selected in July. Windows and sheeps wool insulation have been salvaged from a demolished apartment block in Ballymun and have been installed internally in the building. An Expert Panel meeting was held in June and client meetings with the external design team and main contractor are being held monthly.

Pay by Weight & Bags to Bins

The DOECLG made regulations that from 1st July 2016, waste operators must only collect household kerbside waste in approved receptacles which are designed for reuse (bins) and must use a weighing system to weigh every collection of this waste collected separately in receptacles designed for reuse. The department also set out minimum charges per kilo for each waste stream. A National Awareness Campaign was launched on the 18th May 2016. On the 30th June 2016 the Minister made new regulations removing the requirement for the introduction of pay by weight on the 1st July 2016 but left unaltered the requirement for designation of areas as only suitable for bag use.

The Council has completed a visual survey of all streets on which bags are currently presented for collection and has made Orders in accordance with the criteria from the Department designating the areas in the city which will continue to be bag collection areas post July 1st 2016. The waste industry, NWCPO, DOECLG have been informed of same and DCC website updated with the full list of designated streets.

Establishment of a Special Committee of the City Council in respect of new Waste Management Legislation

The Committee has met regularly to discuss the new waste regulations which came into force on the 1st July and in particular has reviewed the lists being compiled by DCC on the proposed designation of streets as only suitable for bag collections after this date. The Committee has met with Greyhound management to discuss their dissatisfaction with the manner in which Greyhound is encouraging customers to change to bin collections in advance of the designation process being completed. The Committee has agreed to continue to meet to discuss litter related issues and has expressed a desire to engage with the waste industry to consider alternative waste receptacles to replace bags.

Climate Change Strategy

The Environment SPC established a working group to review the Climate Change Strategy for Dublin City 2008-2012 and to prepare a new strategy. The working group has consulted with the other Dublin Local Authorities and they are agreeable to the new Strategy being prepared on a regional basis. A Regional Steering Group has also been established and relevant personnel identified across appropriate departments in each local authority for input to the strategy document. Codema, the local authority energy consultant, is project managing the process on behalf of the 4 authorities. The Strategy will be completed by the end of the year and followed by the preparation of detailed Action Plans in 2017 for each local authority which will include Adaptation and Mitigation measures as required by EU and national legislation.

Dublin District Heating System

The Technical Services Division is working to bring the Dublin District Heating System (DDHS) to the next stage of delivery, by advertising through the Request For Tender (RFT) procedures, for a suitably qualified and multi-disciplinary Service Provider to examine the strategies for managing, administering, developing and financing of the DDHS, based on an assessment of the costs, benefits and risk associated with each strategy, primarily focussing on the Docklands SDZ area. This service provider will make recommendations to senior Council management in relation to the preferred business model and strategy to implement the DDHS. It had been intended to advertise for stage 1 (Expressions of Interest) of the RFT process by the end of April; however following Internal workshops and consultation, extra work packages were put into the scope of the RFT, aiming to reduce the long-term timeline of the project. The ultimate goal is to have a contract awarded by the end of the 2016.

Litter Management Plan 2016 -2018

The Litter Management Plan 2016-2018 was approved by the City Council at its April Meeting. One of the key issues highlighted by both Councillors and members of the public was the problem of dog fouling and one of the objectives of the LMP is to install additional litter bins/dog fouling bins in or in close proximity to every enclosed Park within the City. We are currently trialling a number of dog fouling bins around the City. We are liaising with the Parks Division on this and we are also commencing a citywide anti-dog fouling enforcement programme based on the successful template used in the South Central Area last summer.

Street Cleaning Agreement with Croke Park

Agreement was reached at the end of May for Waste Management Services to continue to provide street cleaning services outside Croke Park on match days. The agreement will last until the end of 2020.

NICLAG (North Inner City Litter Action Group)

The NICLAG group made a presentation in May to IBAL (Irish Business Against Litter) on the continuing work to combat litter and illegal dumping in the North Inner City. IBAL summer inspections will commence shortly and they have advised that they will be including Ballymun in their forthcoming inspections. Results published recently.

Housing & Residential Services - Monthly Management Report

Policy issues:

- 1. Housing (Miscellaneous Provisions) Act 2014: Main Parts –Repossession Procedure for LA dwellings (Part 2) regulations commenced April 2015
 - Procedures for repossession have been reviewed to ensure compliance with the Act. OHMS system has been modified to allow the issue of Tenancy Warnings and other documents prescribed by the Act. Meetings currently in progress to discuss further modification which will improve the electronic generation of warnings.
 - As of the 19th September DCC has issued 192 Tenancy Warnings for arrears cases.
 - Meetings have taken place with the three other Local Authorities to discuss new procedures and to ensure consistency.
 - New National Rent Scheme: New National Rent Scheme not commencing in July as per circular from Dept. New circular to follow:
 - HAP: A specific purpose HAP implementation Dublin working group has been established. This working group has responsibility to plan/manage the roll out of HAP for the remaining LA's in the Dublin Region. Dublin City Council has nominated staff to this group who are currently identifying the key resources required to implement the scheme
 - New Improved Customer Quarterly Statement has been developed and issued to all customers.

2. National Strategy for People with a Disability 2011 - 2016

Under the terms of the National Housing Strategy for People with a Disability 2011-2016 DCC has established a Steering Committee including officials from Dublin City Council, Health Services Executive and representatives from a variety of organisations including St. Michaels House for Intellectual Disability, The Irish Wheelchair Association, The Deaf Association of Ireland, Hail Housing Association, Respond Housing Association, The Irish Council for Social Housing and Focus Ireland. The first meeting of this committee took place on May 27th and 12 meetings have been held to date. A Working Group has also been established with the specific objective of developing a Strategic Plan and this group has met 8 times.

The work is primarily operational and will include the transferring of people from congregated settings to regular housing, and the provision of disabled access housing in new build schemes, regeneration schemes, HAP, RAS schemes and through the adaptation of existing housing stock.

The Operations Group whose task it is to implement the Actions set out in the Strategic Plan had its third meeting on the 12th August 2016. Dublin City Council gave a presentation on the numbers of people on Housing Allocations waiting list who need specific type of housing to meet their needs

The next meeting of the Steering Committee will take place on 30th September 2016 in Civic Offices a presentation from City Architects on Housing Design for people with disabilities will be given by the Senior Executive Architect.

Delivery Targets for Dublin City Council 2015-2017

The Department of the Environment, Community and Local Government has set the following challenging targets for the Dublin City Area. 3,347 additional units are expected to be delivered by the City Council, Approved Housing Bodies and private landlords by the end of 2017. 1,498 of the units are to be delivered through construction, Part V and the

Capital Assistance Scheme at an estimated cost of €272.2 million. The Social Housing Capital Expenditure Programme (SHCEP) is expecting to fund the leasing of 1,626 units in that period, 425 of those in 2015. The Rental Accommodation Scheme is expected to deliver the remaining 223 units up to 2017.

To date 3022 units or 90% of the programme has been delivered September 2016.

Roof Repairs

The documentation for the multi party framework agreement for roof repairs was published online via eTenders on 29th June with a closing date of 8th August. The scope of this framework is the re-roofing of larger scale flat complexes, generally four to five storeys high, varying roof types such as gullwing roofs, flat roofs and parapet roofs.

The framework will be established using the open procedure to initially invite tenders for repairs to two specific gull wing roofs. The maximum duration of the framework will be two years subject to a performance review at the end of the first year. The value of the work is estimated at approximately €275,000 per year pending approval.

Stairwell Repairs

The stairwell in Sheridan Court was resurfaced using an IKO Polimer Product with application of the membrane via hand held pole spreaders. The stairwell repairs at Matt Talbot Court comprised a combination of the use of a high strength chemical compound and the fixing of anti nosing to the individual steps with associated concrete repairs.

Miscellaneous Precinct Works

There are a number of miscellaneous precinct works ongoing to address various items that have become defective due to wear and tear over several years. There were substantial concrete repairs carried out to the balconies at Canon Mooney Gardens as a follow up to the upgrade of the common areas in 2015. The balconies at Fitzgibbon Court are currently on the concrete repairs programme.

Roof Fall Arrest Systems

Tenders were received for fall arrest systems at the following locations in Q2 2016:

- Blackhall Place / Marmion Court.
- Saint Michan's House.
- Matt Talbot Court.

We are investigating systems that can be used to increase the height of parapets to meet the heights required by the Building Regulations.

It is hoped to continue to investigate fall arrest systems for other locations such as Constitution Hill Flats, Alfie Byrne / Hill Street, Michael Malin House, Markievicz House, Whitefriar Gardens, Courtney Place, Marrowbone Lane, Henrietta House, Thomas Court, McDonagh House, Canon Mooney Gardens, Emmet Buildings, George Reynolds House, James Larkin Place, Leo Fitzgerald House, Chancery House, Rory O'Connor/D O'Dwyer House, Mary Aikenhead House, Whelan House and O'Rahilly House.

Fire Separation at Windows

The fire separation of windows at Saint Michan's House is now complete with certification of all blocks (A-B, C-D and E-F) issued by Factfire on 30th June. The fire separation of windows at Oliver Bond House is currently at tender stage. It is estimated that there are approximately 34 nr. compartment wall/window junctions (i.e.) 68 nr. units within Oliver Bond House that require fire separation measures.

Marrowbone Lane Flats, Saint Audeon's House and Avondale House were inspected on a joint basis and it was agreed that all three locations meet the regulations for fire separation at windows and no works are necessary.

Attic Separation

There is an ongoing programme to identify and address any issues with fire separation in the attic space of adjacent units during all inspection and maintenance work. The following locations were identified as having either no attic separation or serious deficiencies in fire compartmentation: • Mercer House Flats, Ravensdale Drive Senior Citizen Units, Galtymore Drive Senior Citizen Units and Carnlough Road Senior Citizen Units.

Tenders for all of the above locations were received during the summer and the works commenced in August.

The following senior citizen residential blocks were identified as having gaps in existing party boundary walls between adjacent attics. Typical issues included gaps between the top of the party wall and the underside of the felt on the sloping roofs, unsealed openings and/or large gaps in party walls for service pipes running through, general gaps due to poor finishing/ workmanship etc.

 Dolphin Park, Father Kitt Court, Lissadel Court, Lorcan O'Toole Court, Maxwell Court, Rockmeade Court, Stannaway Court, Charlemont Court, Garden View Court, Powers Court, Ranelagh Close, Rathmines Avenue Court and Stephens Place.

A fire stopping works programme was completed by a specialist contractor at all of the above locations

Lead water supply service connection replacement and/or relining

A higher proportion of DCC units was constructed before 1970 and is therefore at risk of having lead piping. There is an ongoing survey of the housing stock to determine the extent of any lead pipework or plumbing. The objective is to identify such properties based on age, history of renovation and relevant material garnered by Irish Water during the national domestic metering programme.

Based on this survey a programme is under development to mitigate the risk by targeting action in areas where the risk of exceeding the chemical parameters of the EU Drinking Water Regulations is highest. An initial group of four hundred and forty DCC units have been identified by Irish Water as having lead water service connections. A pilot scheme of relining lead water service connections was carried out at Kilkieran Road, Cabra in cooperation with DCC Water Services and Irish Water.

This scheme includes sampling and testing the water. There are three water samples tested for each property. The first sample represents the existing scenario prior to any work, the second sample is taken following the replacement of the section of lead service connection on the public side of the boundary box by Irish Water and the third sample is taken following the relining of the lead service connection on the customer side of the boundary box by DCC Housing Maintenance.

The test results for the third set of samples taken in the pilot scheme indicated that the lead was successfully reduced to less than the 10 μ g/l parameter for lead set out in the EU drinking water regulations in all cases.

Glover Court, O'Carroll Villas and Countess Markievicz House

There is survey and design work ongoing at Glover Court, O'Carroll Villas and Markievicz House to look at options for precinct improvement in each case subject to funding and agreement with the South East Area Office.

Inner Rooms

There is a completed design for the elimination of Inner Rooms at the second and third floor levels of Henrietta House. This design essentially comprises of converting 3 bed units to 2 bed units and 2 bed units to 1 bed units.

The Architects are currently working on design options for the removal of Inner Rooms at Ballybough House. The design is expected to be similar to Henrietta House. Ballybough House is identified as a pilot scheme for the elimination of Inner Rooms.

Legionella Management and control of hot and cold water services

Attendance at recent CPD training on Legionella Management and control of hot and cold water services has highlighted the possibility of public health issues that could arise in the absence of a co-ordinated and proactive Legionella Management system.

We are currently seeking quotes from three companies to audit and report on the existing scenario at three separate locations. Following a review of the existing procedures (or lack thereof) recommendations will be made on city wide Legionella Management procedures.

Loans

Local Authority involvement in issuing loans is as a direct response to Government Policy promoting home ownership and assisting persons who could not obtain loans from commercial banking to finance the purchase of a home. As at the end of **August 2016** Dublin City Council's loan portfolio consisted of **2,364** loans with a total value of **€267,040,634.08**. Of the **2,364** loan account **995** of them are in arrears with a value of **€13,315,615.66**.

All tenants eligible to purchase their houses were notified of the Scheme during the month of May 2016. To date we have received 122 applications from tenants who are eligible for this scheme. 116 applications have been forwarded to City Valuers for valuations, of these 64 valuations have been completed and 40 offer letters have been sent to tenants. We are awaiting confirmation of funding from these tenants, prior to progressing to close of sale.

Home Grants

- The Grants section provides grant assistance to those in private homes and privately rented accommodation who need to have their homes adapted due to illness. The "combined capital allocation to Dublin City Council for the payment of the Housing Adaptation Grants for Older People and People with a Disability Schemes, in 2016 is €6,797,650
- The Housing Adaptation Grant is available where changes need to be made to a home to make it suitable for a person with a physical, sensory or intellectual disability or mental health difficulty to live in. The grant can help you to make changes and adaptations to your home, for example, making it wheelchair-accessible, extending it to create more space, adding a ground-floor bathroom or toilet or a stair-lift. In some cases, the provision of heating can be included, but only under certain conditions.
- The Mobility Aids Grant Scheme provides grants for works designed to address
 mobility problems in the home, such as the purchase and installation of grab-rails, a
 level access shower, access ramps or a stair-lift. The scheme is primarily for older
 people, but people with a disability can also apply for it.
- The Housing Aid for Older People Scheme is used to improve the condition of an older person's home. In general, it is aimed at people 66 years of age and older, who are living in poor housing conditions. However, in cases of genuine hardship the local authority may assist people under age 66.
- There are currently 1309 applications at hand.

Housing Allocations 2016

Each housing authority should make arrangements for timely and efficient selection of households and offers of accommodation so as to ensure that households are notified and ready to move into dwellings as soon as they become available. These arrangements should seek to avoid inadvertent delays in letting dwellings, and dwellings being left vacant for lengthy period due to refusals of offers of accommodation. The use of choice based lettings is being used in areas throughout the City for a limited number of properties.

The number of allocations made by Dublin City Council to end of August 2016 is **1248** which includes **461** HAP and **31** RAS lettings.

Housing Needs Assessment:

In accordance with section 21 of the Housing (Miscellaneous Provisions) Act 2009 (No. 22 of 2009), as adapted by the Environment, Heritage and Local Government Order 2011, Dublin City Council must now carry out a general revision of the Housing Waiting List. The purpose of this revision is to update our records and to remove the names of those applicants from the List who are no longer interested in, or who no longer qualify under the Allocation Scheme 2013 to be housed by the City Council.

Approximately 22,000 letters and questionnaires were issued on the 4th July for return by the 27th July. Between 9,000and 10,000 were returned. Approximately 12,000 second letters went out on the 4th August for return by the 18th August. The total returned by the end of last week was 14,200. A third letter will issue in early September.

The return date to the Department of the Environment, Heritage and Local Government is the 12th October 2016.

Tenants Handbook:

A revised Tenants Handbook has been prepared and is ready to go to print.

Traveller Accommodation Update - September 2016

Allocations: A target of 35 allocations per year is set under the Traveller Accommodation Programme 2014-2018. As of August 30th, there were 8 Traveller Priority lettings to Standard Housing **(target is min 20 p.a.)**, a further 4 Traveller families housed with homeless priority; and 4 to Traveller Specific accommodation. There is increased overcrowding on group housing and halting sites as families move caravans into the backyards.

Fire Review:

- Waste management and the Traveller Accommodation Unit are working on a joint initiative to tackle the commercial scale dumping and burning of rubbish at Labre Park, which is impacting on the fire safety of the site. As of last week there had been 60 call outs of DFB to Labre Park this year alone.
- Individual site meetings are taking place to discuss the recommendations and implementation plan for each site.
- While many of the recommendations have been implemented, the key remaining difficulties are in getting adequate separation in the over-crowded sites: particularly Cara and Labre. Solutions have been identified but they will take longer to implement.
- In Avila and Cara there are additional issues with unsafe electrical connections being made to caravans at the back of houses. There is adequate space in many of the houses assessed but the feedback is that families are resistant to living together.

Labre Park Redevelopment: Earlier this month, the DHPCLG gave approval in principle for the full redevelopment of Labre Park under the Capital Assistance Scheme. Clúid Housing Association will complete the redevelopment in 3 stages. There is a risk to the project at present, as it was agreed by all residents of Labre Park at the outset that the redevelopment was for existing residents and any new unauthorised occupancies would hamper the project going ahead. This issue will be raised with residents by DCC & Clúid in light of the unauthorised occupant who has refused to leave the site although stating he has alternative accommodation.






Chart: Families in ALL EA - Trend: June 2015 to August 2016

Public Participation Network PPN



The new PPN Secretariat met on 26th September to look at a work plan for the coming year. The work plan has been informed from feedback from the community groups who attended PPN events in April and July. The main focus for the coming year will be the development of the linkage groups, and how the links and information flow between the PPN and the SPCs can be

improved. Training for representatives on the committees on how to represent communities within Dublin City Council structures will be ongoing.

Comhairle na nÓg

Comhairle members attended an AGM training day workshop recently in preparation for the AGM. This was in addition to the planning committee and general monthly meetings. The AGM will be held in Croke Park on 27th of October.

Comhairle members participated in consultations and activities including:

- Interview with RTE 2 News2Day programme on Dublin Bay Biosphere video created by members of the Comhairle.
- Interview at Dublin Castle by RTE on Imagining Ireland 1916-2016 for Culture Night.
- Video script workshop and filming at Richmond Barracks 'Education System & Emotional Counselling: Issues in the Classroom'.
- Creating two surveys for students and for teachers on the Education System and Emotional Counselling. Statistics from both to be submitted to the Dept of Education and Skills.
- Social Inclusion Week workshop to represent socially excluded groups by Comhairle members at Dalymount Park on 1st October.

Earlier this year, the Comhairle were congratulated on their innovative Dublin Bay Biosphere video at the <u>UNESCO Summit: Peru 2016</u>

In a message to Comhairle na nÓg members, Meriem Bouamrane of UNESCO said, "The passionate video you have designed shows very clearly what a Biosphere is: a celebration

of life and a long term commitment for people to care for each other while connecting with nature. You are inspiring examples for your peers, for your parents, for adults and for the World Network of Biospheres. You are demonstrating that young people care about this planet and play a vital role in our societies to benefit both the local and global communities".

ARTS OFFICE

Review:

In keeping with other sections in the Department, the Arts Office is undergoing a full internal review with external oversight. This review will focus on governance, purpose and the relevance of the Arts Office work in a local, national and international context. A new Vision Document is being discussed by all staff and when agreed will form the basis of recommendations to Council.

ARTS IN LOCAL AREAS

The Arts Office is now leading the collaborations between National Cultural Institutions and City Council areas in order to develop projects and new initiatives for city neighbourhoods. Advisory groups have been formed in all City Council areas and reports have been made to the all Area Committees and to the Arts, Culture and Recreation SPC.

Projects have now been selected, community partners chosen and artists/arts organisations tendered.

PARTNERSHIP WITH ARTS ORGANISATIONS AND OTHER AGENCIES

A methodology for cultural audits as part of the Draft Development Plan has been agreed to include identification of current facilities and in addition the identification of important organisations and individuals. This process known as Cultural Mapping will also set out the deficits in each administrative area. A report on the methodology has now been presented to the SPC and adopted. A sports audit will be included in this process.

ARTS EDUCATION AND LEARNING

A Draft Arts and Education Policy has been recommended by the SPC and is being presented to the October Council meeting for approval.

SUPPORTING ARTISTS

A new agreement has been signed between the CCMA and the Arts Council setting out a new partnership between the Arts Council and Local Authorities. The Arts Office is working with the Arts Council to define the partnership actions in Dublin in the light of the Arts Plan, the Dublin City Cultural Strategy and the upcoming National Cultural Strategy. New applications for funding to the Arts Council for collaborations with the other Dublin Local Authorities will be led by Dublin City Council in the area of Early Years Arts. The Arts Office was successful in this funding application.

EVENTS

Bram Stoker Festival - Friday 28th October 2016 - Monday 31st October 2016



Bram Stoker Festival is now in its 5th year which is a partnership between Dublin City Council and Failte Ireland. Plans are well under way for this ever popular event, taking place this year with 4 days and nights of deadly adventures from 28th to 31st October. The Festival Programme was officially launched on 13th September, with some great indoor and outdoor events planned for Halloween weekend 2016. The Events Section will process the event application and liaise with all statutory agencies and stakeholders in relation to all aspects of this event.

NYF Dublin - Thursday 29th December - Saturday 31st December



The New Year's Festival Dublin is an initiative of Fáilte Ireland, in partnership with Dublin City Council. This is the last year of the contract with Leisure Project Management Ltd. (t/a Holohan Leisure), who were appointed in 2014 for the three year period to February 2017 to deliver the event.

NYF Festival details will be announced in early October with the countdown concert due back in St. Stephens Green South and some new exciting events planned for the festival event. The core events will be supplemented by a programme of Arts and Culture events to be produced directly by the City Arts Office.

The core public events will be subject to an Outdoor Event Licence application under Part XVI of the Planning & Development Act 2000 and Planning & Development Regulations 2001 as amended by the Planning & Developments (Amendment Regulations 2015 S.I. No. 264 of 2015)

Filming Update

Dublin City Council is currently working with the Irish Film Board on a number of large budget productions due to start filming in Dublin, see details below. All filming will be carried out in consultation with the Film Liaison Officer in Dublin City Council to ensure compliance with the cost of best practice for filming in the City.

Into the Badlands

A new television drama which commenced production in Dublin/Wicklow in September called INTO THE BADLANDS, is a big-budget international television drama series for the US broadcaster, AMC.

The show is the creation of Alfred Gough and Miles Millar (SPIDERMAN 2, SHANGHAI KNIGHTS, SMALLVILLE). The show's Irish producers are Octagon Films, with James Flynn as executive producer. Irish actors, Orla Brady and Sara Bolger are two of the show's main cast members.

The Irish Film Board has worked closely with Octagon for the last several months to secure this major investment for Ireland. The show is worth €39m in foreign direct investment and will employ 250 cast and crew and 1200 extras over the next 5 months. The production is benefitting from an investment from the IFB as well as the Irish tax incentive for film and television, Section 481.

Innocent

Innocent is a four part series which was filmed in Dublin for ITV in August and September 2016. The production budget for the entire shoot is €3.5m. There are 50 Irish crew and 10 Irish cast being employed by the production. All extras and daily crew will be sourced in Dublin.

The series is a crime drama.

The Professor and the Mad Men

This film tells the story of the making of the <u>Oxford English Dictionary</u> and one of its most prolific early contributors, <u>Dr. W. C. Minor</u>, a retired <u>United States Army surgeon</u>. Minor was at the time, imprisoned in the <u>Broadmoor</u> Criminal <u>Lunatic Asylum</u>, near the village of Crowthorne in Berkshire, England.

The production will be shooting in Dublin from October to November. The production budget is €20m, and will be starring Mel Gibson and Sean Penn.

Rebellion 2 (In-Between Two States)

Following on from the success of Rebellion, RTE have scheduled a second series of this hit drama series. "In-between Two States" tell the story of Ireland in the War of Independence era. The production team is working with Dublin City Councils Film Liaison Officer to research various locations in Dublin. The production budget will be €4m.

DUBLIN CITY GALLERY THE HUGH LANE

Visitor Numbers:

The number of visitors to the Gallery continues to grow with 128,753 visitors to the end of August compared to 105,703 in the same period last year. Our August numbers of 18,365 are the highest we have experienced since 2008.

We continued our pilot Bank Holiday Monday openings at the August weekend. We are currently assessing the cost/benefit of opening on all bank holidays next year, and a report will issue to the November meeting.

Refurbishment Update:

Strategic accommodation brief

A fee proposal has been obtained from consultant architects for assisting the Gallery to develop a strategic accommodation brief for it's future services. The purpose of this is to clarify the Gallery's long term accommodation requirements to enable planning of options for addressing current deficits (for example future requirements for deliveries, storage, archive and additional exhibition space).

1930s Wing re-roofing and environmental services

This work has been reviewed with the Conservation Officer to clarify the specialist conservation services required. Therefore City Architects will seek to procure a multi-disciplinary design team led by an architect with specialist conservation expertise.

Development Sub-Committee

The Development Sub-committee comprising members of the Board last met on 6th September 2016.

The development of a new Strategic Plan 2016 – 2021 is being progressed as a priority issue. The consultants, Eaton Square, have met City Councilors, DCC Executive, members of the Board and the Gallery staff to assist with the development of this plan.

In light of the new Companies Act 2014, the report on the role and responsibilities of the Gallery Board was discussed. Following advice by the Law Agent, the articles of Memorandum of Association for the Hugh Lane Gallery Trust are being revised to comply with the new Companies Act.

Hugh Lane Gallery Trust Ltd

The Board of the Hugh Lane Gallery Trust last met on 6th September 2016.

The members were updated on the status of the Strategic Plan and the review of the Articles of Memorandum of Association to comply with the Companies Act 2014. At that meeting the following acquisition was approved:

Exhibitions

Continuing the theme of the **Artist as Witness**, the gallery presents the final exhibition in the series "The Metronome Burst of Automatic Fire Seep through the Dawn Mist like Muffled Drums and We Know It for What It Is" by Sven Augustijnen, which runs from 8th September 2016 until 22nd January 2017.

This exhibition was launched by **Clir Sonya Stapleton** on the evening of 7th September 2016.

Beyond Tradition by Michael Kane opens to the public on 20th October and continues until 8th January 2017. The exhibition will be opened by the Lord Mayor of Dublin Brendan Carr on 19th October at 6:30pm and will conclude our 2016 Artist As Witness programme.

Education

EU Funding CAPP

In 2017 the gallery will partner with Create - the National Development Agency for Collaborative Arts - to create a collaborative socially engaged arts project 2017/2018 through the European based Collaborative Arts Partnership Programme (CAPP).

CAPP EU partners are Ireland, Spain, Finland, Hungary, Germany and U.K with Ireland /Create being the lead partner. The commission will run from 2017 into 2018 and will link the gallery with local communities working on a collaboratively engaged project. It is designed to connect and deepen the gallery's engagement with local communities and broaden audience bases. A call for submissions will be organised by CAPP and will comply with EU regulations. The value of the commission is €40,000 with €20,000 contributed by CAPP.

Public Events

• Culture Night: Friday 16th September, until 10pm

The gallery was open late on Culture Night. Events included a performance by musical group Hvmmingbyrd, tours on the current exhibition by Sven Augustijnen, highlights from the Collection, as well as drop-in family workshops for all ages from 5.30 to 7.30pm. It was very well attended.

- Public Talk: 1984 Dunnes Stores Strikers in Conversation with Olivia O'Leary, Saturday 24th September, 2 – 4pm
- This event celebrates the strikers' contributions to political activism in Ireland and the donation to The Hugh Lane of the 1984 Dunnes Stores Strikers artwork by Garrett Phelan. Reflecting back some 30 years later, journalist Olivia O'Leary will be discussing with the group their motivations for striking and the consequences.

Autumn Courses

The Gallery will be running a variety of art and art historical courses this autumn, annual portfolio course for those interested in attending art college, as well as our regular adult drawing classes. We will again be collaborating with UCD's Adult Education Centre and the People's College to deliver two lecture series that focus on and respond to the theme of *Artist as Witness* and the Gallery's Collection.

In collaboration with the Irish Architecture Foundation, we will be holding drop-in workshops for families that will be inspired by the architecture of the Hugh Lane Gallery. These include ever-evolving sculptural and drawing installations, and designing your own imaginary art gallery of the future.

DUBLIN CITY SPORT AND WELLBEING PARTNERSHIP

The Dublin City Sport & Wellbeing Partnership inaugural Statement of Strategy 2017 - 2020 was endorsed by its board on Monday 15 August 2016.

The strategy is progressive and ambitious and sets out 16 initiatives and 26 actions under the following strategic goals:

1. Places and Spaces

Providing opportunities for more people to participate in sport and physical activity in Dublin City through what is available, identifying gaps and developing plans for future investment.

2. Programmes and Services

Delivering a consistent and measurable suite of programmes and services to meet the needs and enhance the lives of all people living and working in Dublin City.

3. Promoting Sport and Inspiring People

Engaging and connecting with all people living, working and visiting Dublin through events, programmes, technology and real-life experiences.

4. Good Practice

Delivering and maintaining high standards through our people, our board, our partners and those we work with to fulfil best practice and good governance.

The Statement of Strategy is scheduled to be published by the end of October 2016.

DUBLIN CITY PUBLIC LIBRARIES AND ARCHIVE

PROPOSED NEW CITY LIBRARY, PARNELL SQUARE Project Stage 2(a) Sketch Design

Stage 2(a) Sketch Design project report has been approved by the PSCQ Foundation. Work will commence on Stage 2(b) Design to Planning following site investigation works.

Consultants have been appointed to proceed with Site Investigation works. The SI schedule, subject to confirmation, is proposed to commence in mid-September. The purpose of the works is to garner high quality information on conditions of the buildings, grounds etc. This information is an essential component in the design process to planning submission, reducing project risk at construction stage. Information on the works will be circulated in advance to neighbours and local businesses.

The City Librarian presented a status and draft sketch design up-date on the Parnell Square City Library project to the September meeting of the Arts and Culture SPC.

KEVIN STREET LIBRARY - PART 8

The Part 8 Planning Process has completed, with representatives from City Architect's Division and Dublin City Public Libraries presenting responses to planning submissions to the South East Area Committee on 12th September.

City Architect's continue to finalise detailed design drawings incorporating suggestions made through the planning process with the intention of publishing a tender in the next 3-4 weeks.

LIBRARIES MANAGEMENT SYSTEM (LMS)

Dublin City Council is the project manager for the implementation of a new Library Management System, Sierra, in all public libraries in Ireland. Seventeen library services, including Dublin City, are now live on Sierra.

Phase 3 of the project is now underway with the remaining thirteen library services due to join the system in early 2017.

AUTUMN PROGRAMME

The Library and Archive service's autumn programme runs from September to November and includes lectures, exhibitions, workshops, and music. The programme has been circulated to all councillors.

DUBLIN FESTIVAL OF HISTORY 2016 - 23rd September - 8th October

The Dublin Festival of History was launched on 22nd August 2016. This is the fourth year of this popular festival with talks, tours, exhibitions, film and a family/children's day on the programme. Speakers at the 2016 Festival include Frank Dikotter, Saul David, Roger Moorhouse and a high-profile event on Hillsborough with Phil Scratyon, Adrian Tempany and Paul Howard. All events are free and open to all.

Dublin Bay UNESCO Biosphere Conference: Connecting people and nature

The "Dublin Bay UNESCO Biosphere Conference: Connecting people and nature" will take place on Wednesday October 26th, 2016 at the George Moore Lecture Theatre, Science Centre East, University College Dublin.

The conference will feature both international and local speakers who will give us insight into UNESCO's World Network of Biosphere Reserves and what Biospheres stand for as well as highlighting the work that is being done by a wide range of stakeholders within Dublin Bay Biosphere. The conference will include sessions of talks on "Education for Sustainable Development" and "Conservation & Research" as well as parallel workshops on communication and engagement, access to funding and research networking.

Keynote speakers

Setting priorities: the World Network of Biosphere Reserves and the Lima Action Plan 2016-2025

Professor Martin Price is Director of the Centre for Mountain Studies, Perth College, University of the Highlands and Islands, Scotland, where he holds the UNESCO Chair in Sustainable Mountain Development. He has been involved with UNESCO's Man and the Biosphere (MAB) Programme since the mid-1980s, including chairing the UK national committee, serving on the International Advisory Committee for Biosphere Reserves, and acting as rapporteur of the International Coordinating Council from 2014 to 2016.

He led the preparation of the 10-year Strategy and Lima Action Plan for the MAB Programme and its World Network of Biosphere Reserves. He has published widely on mountain and tundra ecosystems and biosphere reserves.

The Biosphere brand: starting a global movement

Jeff Melnyk and Laurie Bennett are the founding partners of Within People - an international partnership that helps organisations find their purpose and grow. For the past decade, they have been helping consumer brands and NGOs around the world to find and tell powerful stories about who they are and what they stand for. Over the last 5 years,

they've been working with the UNESCO Man and the Biosphere programme, including Dublin Bay Biosphere, to build a global movement that can inspire positive change for people and nature.

Tree Day 2016

Tree Day takes place on Thursday, 6th October. The theme this year is Tell me How to

Workforce Numbers

The total number of employees at 31st August 2016 was 5,634 (headcount). The full time equivalent (FTE) number (i.e. taking account of worksharing arrangements) was 5,328.30 The total workforce number of 5,634 represents a reduction of 23.6 per cent since December 2008. The greatest reduction in resources has taken place in management grades where numbers have reduced by 34 per cent and in the professional technical grades (eg. engineer, planner, architect grades) where numbers have reduced by 29 per cent. Numbers in operational grades have reduced by 24 per cent and in firefighter operational grades by 7 per cent.

Throughout recent years, and on a continuing basis, managers and staff have undertaken restructuring, reassignment and prioritisation of work to continue service delivery to citizens and customers despite reduced workforce numbers. Managers and staff are continuing to review how services are delivered to optimise customer service, within constrained resources.

Labour Activation

(i) Jobbridge

Since the commencement of the Jobbridge scheme, a total of 61 JobBridge Interns have been placed in Dublin City Council. A further 17 interns have been placed in Arts Organisations, facilitated by DCC and 1 intern is currently in place in these organisations.

As of the 13th of September 2016, there are no Job Bridge interns placed in DCC. Six internship requests are in progress; these requests have been advertised on www.jobsireland.ie and are due to close in the 23rd of September.

(ii) Gateway

As at 13th September 2016, 85 people are engaged by the City Council under the Gateway Scheme. Twenty one (21) Gateway staff have been successful at interview for the confined General Operative competition, 13 successful candidates have been offered positions, 12 have been appointed and one candidate is pending appointment.
