6. Motion in the Names of Councillor Mary Freehill & Dermot Lacey

"Since the termination of Dublin Tourism, Dublin city no longer has any democratic representation and oversight in the development of tourism policy for the City of Dublin. DCC therefore calls on the Minister for Transport to appoint a member elected by Dublin City Council to the Board of Tourism Ireland"

7. Corporate Media Strategy

Alan Breen gave a report on the role of the Media Relations Office which covered the scope of its work, how it is developing a distinctive brand for Dublin City Council and the relationships it has built with contacts in the media as well as the challenges the organisation faces in getting its message across in a crowded media landscape. The Members thanked Alan for his presentation and highlighted areas where they thought the corporate strategy could be developed such as communication with public and being pro-active when dealing with contentious Area issues, the greater involvement of SPC Chairs & Vice-Chairs in explaining City Council policy and balancing the representation of the corporate and political positions of the Council. Alan welcomed the input of the Members and would take onboard their concerns. There was further debate on the release of Agenda and Reports to the media in advance of Committee meetings and also about the volume of Freedom of Information requests each Department had to deal with

8. Meetings Management System update

The Manager reported that the new system was currently undergoing testing to determine which tablet device was most appropriate. The Protocol Committee will be provided with devices and training in August with a view to piloting the system in September.

Members stressed their concerns with regards encryption and emphasised that one device must serve all their requirements without cumbersome security. **Order: Noted**
