

With further reference to the grant of a licence to Smithfield Boxing Club for use of Aughrim Sports Hall, Aughrim Street, Dublin 7

Report No. 249/2016 which was assented to by the City Council at its meeting on 5th September 2016 approved the grant of a licence to Smithfield Boxing Club Limited for use of Aughrim Sports Hall, Aughrim Street, Dublin 7 for 4 years and 9 months for use as a boxing club only.

There is no objection to this proposal.






