### Breviate for the Month of October 2016

---

In accordance with Standing Orders of the Dublin City Council, the Breviate of the meeting of the South Central Area Joint Policing Sub-committee held on the **24<sup>th</sup> October 2016** is set out hereunder.

**59. Garda Matters - Garda reports.**

**Order: Reports noted.**

The following issues were raised and a response was given by members of An Garda Síochana: -

- (i). Serious anti-social issues at Basin Street. Councillor Criona Ni Dhalaigh queried the following: - Clarity is required to identify/determine which Local Policing Fora Basin Street falls under, the Canals LPF or the South Inner City LPF. South Inner City Drugs Task Force funds a lot of projects in Basin Street yet the Garda Station it actually reports to is Kilmainham which has the remit for the Canals Drugs Task Force. The Councillor requested that this issue be referred to the City Wide JPC for determination
- (ii). Substance abuse in the South West Inner City area, particularly at James Street and Thomas Street.
- (iii). Antisocial behaviour at Convent Lawns playground.
- (iv). Intimidation by large groups of young adults with fireworks at shops on Ballyfermot Road.
- (v). Threats and intimidation linked to the intended Housing sites in Cherry Orchard.
- (vi). Garda numbers and resources in Ballyfermot are insufficient .
- (vii). Chief Superintendent Clerkin gave an explanation on the difference between Breach of Barring Order, Breach of Protection Order and Breach of Safety Order.
- (viii). A request was made for the inclusion of the discharge of fire arms statistics in each District and uniformity within the crime statistics reports.
