	<ul style="list-style-type: none"> - ➤ MA queried how the board will tackle the 'wellbeing' element of its brief - <i>SMCl explained that this is incorporated into the strategy but essentially it is something that the HSE Rep will be expected to drive</i> ➤ RH asked for an update on the Marrowbone Lane dispute - <i>BK explained that a number of meetings are scheduled for the coming weeks whereby the current stalemate will be brought to a head and hopefully the issue gets resolved. The preferred solution is to work a full GAA size pitch into the current regeneration plan for Donore Avenue (St. Teresa's Gardens). However, a lot of work needs to be done in order to make this happen.</i>

Management Update</p>	<ul style="list-style-type: none"> ➤ SMCl informed everyone that the Small Grants Scheme is now closed for 2016. 97 clubs received €650 each, totalling just over €63,000. ➤ SMCl updated the board on upcoming events such as the Great Dublin Bike Ride (Sept 11th), Kids Marathon (Sep – Nov '16), Women's Rugby World Cup 2017 & Euro 2020 (launch on Oct 13th). ➤ The board were also informed that Don Daly has now been given responsibility for the WRWC 2017, Euro 2020 & Dalymount Park. He will be based in Palace St. alongside the DCSWP admin team. ➤ FC sought clarification that major

Draft Statement of Strategy</p>	<ul style="list-style-type: none"> ➤ SMCl presented the draft strategy document to the board and invited any questions or comments - <i>A number of board members provided feedback in the form of suggestions & recommendations</i> <p>SMCl committed to take on board all feedback and make any necessary changes to the strategy document.</p> <ul style="list-style-type: none"> ➤ FC thanked SMCl on behalf of the board for all her hard work to date. 	<p>SMCl</p>	<p>asap</p>

A specially appointed Senior Sports Development Officer (SSDO) will work under her but will also be aligned to the Partnership. The total amount of funding towards both capital and revenue projects will comfortably exceed €1 million. The bulk of this will need to be spent by Dec 31st so the team involved will need to hit the ground running. - <i>A general discussion ensued in relation to what the area needs and how DCSWP can contribute.</i> <p>It was recommended that the new SSDO, once in place should report to the DCSWP advisory board meetings.
