

## With further reference to the disposal of 41 apartments at New Priory, Hole in the Wall Road, Dublin 13.

Report No. 357/2016 which was assented to by the City Council at its meeting on 5<sup>th</sup> December 2016 approved of the disposal of 41 apartments in blocks 1-7 coloured pink on map index number SM-2016-0546 at new Priory (former Priory Hall), Hole in the Wall Road, Donaghmede to the applicants.

In relation to apartments no 1 and 6 the legal formalities have not yet been completed and the Development Department has been informed that these disposals should now be completed in the joint names as listed below. The disposal of apartments no 5 and 8 fell through and the Development Department has been informed that terms have been agreed to dispose of these apartments to the new purchasers whose names are listed below.
