To ask the Manager to look at the ramps at (details supplied). They are not preventing speeding on the roads

To ask the Manager to arrange for Kissing Gates at the lane at (details supplied).

Q.3 Councillor Noeleen Reilly

To ask the Manager to clean the leaves on both sides of (details supplied) which are highly dangerous at present and also to reinstate the margins on these pavements which are badly overgrown.

To ask the Manager to review the footpaths in (details supplied) and set out a schedule for repair.

To ask the Manager to look at road signage and lighting at (details supplied).

To ask the Manager to get an update on the Balconies repair at (details supplied).

To ask the Manager to look at lighting at the Corner of (details supplied). It is very dark and gangs often hang around there. Damage has been done to gates and railings around that area and lighting would improve the situation.

To ask the Manager to request that the litter warden investigates the continuous problem of dog dirt on the public path at (details supplied) that this area is observed with intention to catch the dog owner in the act.

Every time it is emptied it fills up again within a couple of days. There is a bin provided on the green for dog dirt so a bin at this location is not necessary.

To ask the Manager confirm a timeframe for the trees to be pruned in the gardens of (details supplied) which housing maintenance have given a commitment to do as a 'once-off' measure.

Could the word STOP also be painted here to prevent cyclists continuing on to the road without checking properly for traffic on (details supplied). A cyclist was recently knocked down here. There is a YIELD sign on the post at the same location, could the manager arrange for this to be changed to a STOP sign.

I have witnessed antisocial behaviour around the green area and the parking issues with (details supplied) now in site I have seen turn nasty with constant road rage incidents. I hope the council will take this opportunity to make a village centre for (details supplied).

To ask the Manager that this committee seeks a detailed plan in relation to the development of housing in (details supplied) examining:

As a concerned resident of (details supplied) I would be interested in learning of any developments regarding any future housing developments in (details supplied). While I completely agree that there is a need to build houses on this land as a means to address the homelessness crisis, I also fundamentally believe that it should be done in line with a (details supplied) Development Plan and the construction of local and social amenities on this site. For example a small number of shops, an upgraded community hall (to replace (details supplied)), a primary health centre and the maintenance of space/Roads for the possibility of a future LUAS extension through this area. Any information on the above would be greatly appreciated.
