Repair and Leasing Scheme

On 13th February an eMail giving details about this scheme was sent to Councillors. The City Council will begin to roll this scheme out shortly. John Ryan has been assigned this task.

St Helena's Drive Update

Work is continuing on the construction of 39 rapid delivery houses at St. Helena's Drive. (12 x3 bed 27 x2 bed) (pictures below).





The steel frame has been constructed for blocks 1, 2, 3 and 4 and the floor slabs has been poured on the remaining two blocks 5 and 6.

Windows and doors have been fitted to blocks 2 and 4 and blocks 1 and 3 are constructed to roof level.

Bricklayers have completed the brick and block work to block 2 and work is in progress on blocks 3 and 4.

First fix plumbing, heating and electrics are now in progress on block 2.

Work on the new boundary wall cannot start until the scaffolding at block 1 is removed.

The project is on schedule and it is hoped that houses will be handed over on a phased basis from May 2017 and the site will be completed in the 2nd quarter of 2017.
