1	Parking Prohibitions	35740	BALLYMUN ROAD (NW- EA)	D9	Double Yellow Lines	on the side road between the Ballymun Road and the Setanta all weather pitch on the pitch side of the road.	resident	Not Recommended	Double yellow lines are provided as a measure to maintain a through flow of traffic and to prevent congestion.  They operate on a 24 hour basis and are non-discriminatory. This request does not meet the criteria for the provision of double yellow lines and is therefore not recommended.  There is no issue of traffic flow at the library on Ballymun Road near the Setanta all weather pitch. It is up to the club to provide netting and duty of care to its members and not to have its members running onto the public road.  The purpose of the Rules of the Road is to save lives and prevent injury on our roads. The rules apply to all road users: drivers, pedestrians, motorcyclists,horse riders, cyclists and those in charge of animals.  The rules ask the public to take personal responsibility for our use of the road, and in doing so become better, safer and more socially responsible road users.	0	22/12/2016
2	Traffic Signals	33723	BEAUMONT ROAD (NW- EA)	D5	Filter Light	for turning right and left to go into Beaumont Hospital from Beaumont Road.	resident	Not Recommended	ITS have monitored the junction and the addition of a filter light would cause undue additional congestion on the entrance to Beaumont hospital for emergency vehicles at peak times. In order to faciliate a filter, time would have to be allocated which would in turn reduce time for all other movements which would then cause congestion. The Finnbear Fort to the the T junction inside in the estate is 65 metres. Dublin City Council only put in ramps where the straight section of road is 200 metres minimum. 6	Parking Prohibitions	35625	GLENCAR ROAD (NW- EA)	D7	Double Yellow Lines	at the junction of Glencar Road and Glenbeigh Road.	resident	Not Recommended	Under The Road Traffic (Traffic & Parking) Regulations, Section 36 paragraph(2) c, It is illegal to park "within 5 meters of a road junction." As a a result, is illegal to park within 5m of the junction of Glencar Road and Glenbeigh Road. It is an enforcerment issue and it is a matter for the Gardaí. It is not recommended to introduce parking restrictions where restrictions are already covered under the law, such as extending yellow lines around corners, as this would lead to a proliferation of same and additional expense due to maintenance etc. Infringements of the Act should be referred to Dublin Street Parking Services Ph.6022500 for enforcement under the law.	0	19/12/2016
