Re: Ireland 2040 – Our Plan National Planning Framework

Dear Cathaoirleach,

Ireland 2040 – Our Plan, the NPF will be the long-term, national 20-year strategy for the spatial and place-making development of Ireland that will assist in shaping future growth and change. On 2nd February, I launched the first consultation stage on the plan with An Taoiseach and Minister of State Damien English. Collectively, influencing the pattern of development in Ireland over the next 20 years will require a range of expertise, perspectives and inputs. As part of this consultation period, an *Issues and Choices* paper has been prepared to encourage debate and is available to view and download at the following dedicated website <u>www.ireland2040.ie</u>.

I believe that Local Government is one of the key stakeholders in the preparation of a National Planning Framework for Ireland and your engagement with a plan for Ireland's future is central not only to its preparation, but also to its implementation. In this context, I would like to invite you to engage with the consultation process at pre-draft stage with a view to making a submission at this stage in the process.

As part of the process in engaging with Local Government and where the timeframe allows, I am requesting that the topic of *Ireland 2040* is included on the agenda of your next monthly Council meeting as a means of discussing what the aspirations of your Council are for Ireland's future and how Ireland might look in 2040.
