There is a number of crime prevention strategies conducted in the Cabra area.

**Operation Crossover** which maximises resources deployed to Beats and Patrols during Unit crossover times is ongoing, as well as **Operation Faussagh**. This is a specific operation to target issues of anti social behaviour in the Faussagh Avenue area. There is continued liaison with resident groups, local businesses, to assist in addressing issues of Anti Social Behaviour in the area.

**Operation Irene** is ongoing to tackle Public Order issues with particular emphasis on parks and open areas. There are targeted patrols by the Community Policing Unit on Friday and Saturday evenings between 4pm and 2am.

Operation Thor, Operation Creeper and Operation Hybrid continues with checkpoints, surveillance and searches carried out during each tour of duty. There is emphasis on high volume crime and specific criminal targets.

# Crime Prevention Matters and Other Information

There are 1 Sgt & 5 Gardaí attached to the Community Policing Unit in Cabra.

There were 48 Juvenile Referrals for the Cabra District and 23 for the same period last year, an increase of 109%.

Regular inspections of licensed premises remain a priority to target underage consumption of alcohol and the illegal sale of alcohol to minors. There have been 102 Licensed Premises Inspections in the 2016 in the Cabra area.

There is 1 project in Cabra,

STEP UP - 1 Project worker funded by the Dept of Justice.
