Review of Dublin City Neighbourhoods Competition

It was proposed that some minor changes to the current competition are introduced in the following areas

- Categories
- Judging Criteria
- Timelines
- Increase in prize fund

Review of Dublin City Neighbourhoods Competition

The Dublin City Neighbourhoods competition is run by Dublin City Council to acknowledge in a meaningful way the work done across the city by communities to improve and enhance their neighbourhoods.

Following feedback from entrants and the Area Departments a review was undertaken of the competition. A questionnaire was included in the entry form to be completed by participants in the 2016 competition.

Responses to the questionnaire indicated that participants in the competition were satisfied with the manner in which the competition was organised with some suggestions for minor alterations to the categories in the residential competition.

The results were reviewed in conjunction with the Area Depts and other issues identified to be addressed were:

- lack of entries in certain categories.
- Timelines for judging of the schools competition
- judging criteria.

A number of change proposals were recommended to the format of the competition:

Categories

Residential

- Remove the over 300 dwellings category due to lack of entries
- Alter 151 300 Dwellings category to Over 150 Dwellings.
- Allotment and Community Garden category to appear as two separate categories to cater for the 2 distinct types of activity

Special

• Include category for Team Dublin Clean-Up Initiative

Business

• Business Environment Initiative and Sustainability Initiative (Water, Conservation/Energy Efficiency) to be incorporated into one category due to lack of entries in distinct categories.

Schools

• Application forms for the Schools competition to be available by end of March to facilitate entries and judging before school term ends

Judging Criteria:

The proposed judging criteria to be as follows:

Residential competition

•	Voluntary and Community effort	50%
•	Absence of litter / graffiti	25%
•	Landscaping / biodiversity (where relevant)	15%
•	Overall Impression	10%

"Voluntary and Community effort" will include assessment of initiatives in communications, organising of events, clean-ups etc in the local area

Special Categories

Individual Contribution

• Assessment of individual contribution to community environmental initiatives

Team Dublin Clean Up

Assessment of overall community effort in carrying out a Team Dublin Clean Up event

Prize Fund

Proposed as follows:

• In each category - Winner €1,000, 2nd Place €600 and 3rd Place €300.

The effect of the proposed changes will be:

- to ensure that the categories remain relevant and that entries are maximised in each category
- That judging may be carried out in a manner that provides equal opportunity for all areas of the city to obtain awards.
- The schools competition can be completed during school term
- The prize awards are increased

There is no net increase in funding required as costs in relation to organising the competition and events night have been reduced through carrying out more functions within Dublin City Council in recent years.
