



**With reference to the proposed disposal of a plot of land to the rear of 7 Marino Park,
Dublin 3.**

An application has been received from Kevin Leech and Deirdre Connolly to purchase a plot of ground to the rear of their property at No. 7 Marino Park, Marino, Dublin 3. The plot of ground in question, which is shown coloured pink on Map Index No. SM-2018-0347, and has an area of approximately 51 sq. metres, has been incorporated into their rear garden for many years.

It is proposed to dispose of the City Council's fee simple interest in the plot of ground to Kevin Leech and Deirdre Connolly subject to the following terms and conditions:

1. The consideration shall be in the sum of €1,275 (one thousand two hundred and seventy euro) i.e. €25 per square metre i.e. €25 x 51 square metres.
2. The purchasers shall be responsible for any costs involved in incorporating the plot into their garden.
3. The purchasers shall be responsible for their own legal costs in the matter and shall also pay approximately €1,500.00 (plus VAT) towards the Council's legal costs.

This property was acquired from Richard Corballis in 1927.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

This proposal was approved by the Central Area Committee at its meeting on 15th April 2019.

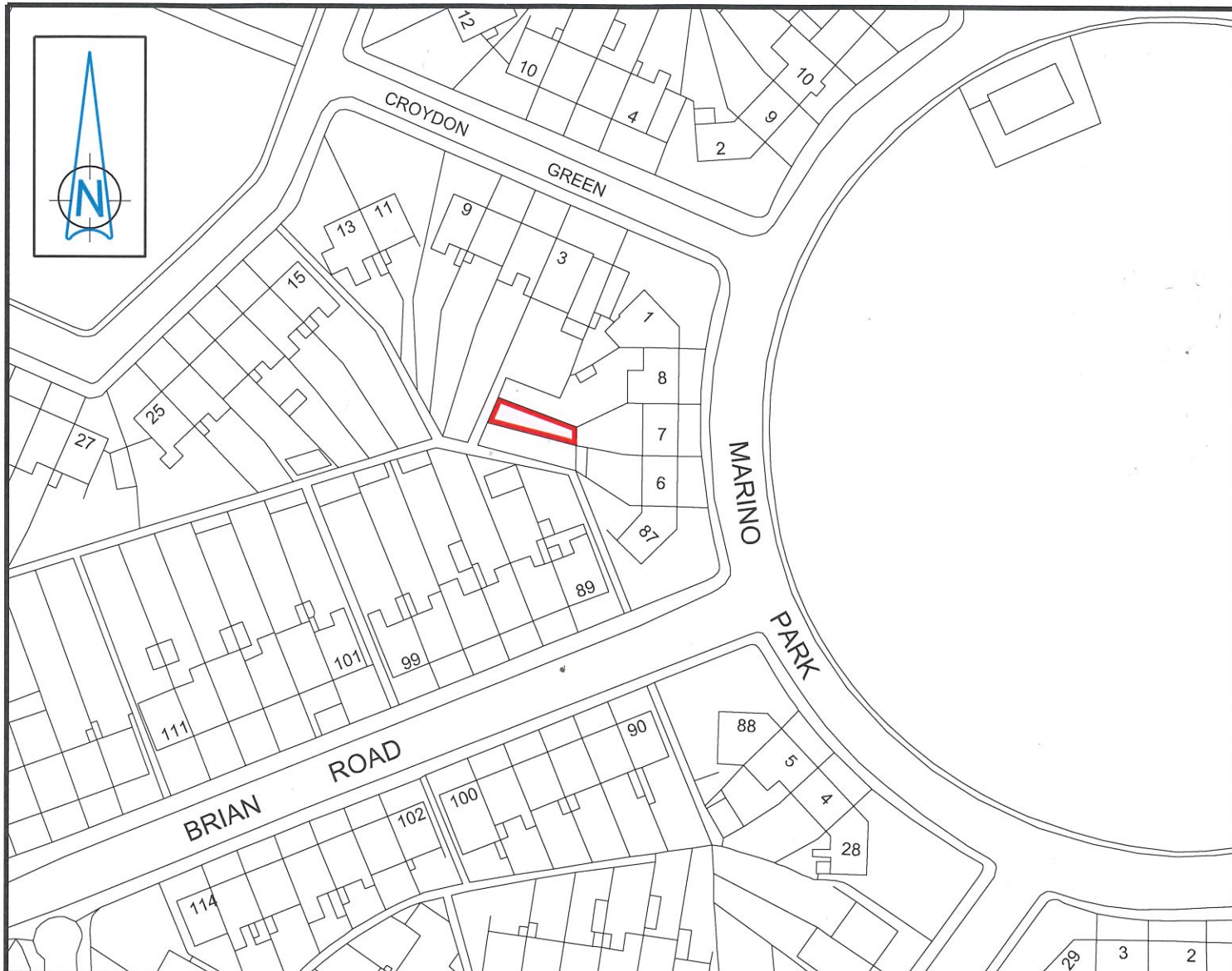
