Motions on Notice Dublin City Council Meeting 2nd September 2019

1) Councillor Chris Andrews

That this City Council agrees that in all future Local, General and European Elections the number of posters advertising each candidate will be limited in numbers and only permitted in designated areas to a maximum of 5 designated areas in each constituency and each poster be bio-degradable and the Protocol Committee determine the details of this proposal.

2) Councillor Criona Ní Dhalaigh

That this Council agrees to pilot a participatory budget instead of a discretionary fund in one of our 5 areas. A participatory budget would facilitate citizens in local communities to directly decide how to spend the discretionary budget in their area. It would give citizens the direct power to determine spending priorities to improve their community/area.

Participatory Budgeting gives people the power to improve their area and it is empowering, civic minded, educational, fair and transparent. Participatory budgeting is recognised internationally as a way for people to have a direct say in how local money is spent. I believe that it would be a tool for community engagement and for developing participatory democracy in our city. It was done as a pilot in areas of South County Dublin Local Authority, and proved very successful. We could follow their model or tweak to suit us.

3) Councillor Deirdre Heney

That this City Council ensures the protection of animals, (including carriage horses) in our city and makes every effort to bring about compliance with the law by all concerned in this regard, and further makes every effort to ensure that the required legislation to regulate the operation of carriage horses is put in place and that a report be provided on same.

4) Councillor Micheal MacDonccha

Dublin City Council calls on the Minister for Housing Eoghan Murphy to provide additional planning and enforcement staff to this Council to implement the new short-term letting regulations that will come into force on 1 July.

5) Councillor Rebecca Moynihan

This City Council asks that the Chief Executive to begin the process of taking the Iveagh Markets back into the full control of Dublin City Council. The terms of the lease granted to Mr Keane, first in 1997 and then again in 2004 under report number 218/2004 have been frustrated by the actions of the developer.

Report number 218/2004 clause 7 states that "Mr Keane or his nominee shall, within 36 months of the execution of the Agreement for Lease, have completed the redevelopment work on the market buildings and the construction of the hotel in the case of delay due to strikes, lockouts or any other circumstances outside the control of Mr Keane or his nominee. Such longer period if required to be agreed with Dublin City Council at the time the delay occurs. Mr Keane or his nominee shall not use the premises for any purpose other than redevelopment as a commercial market and the construction of a hotel".

The terms of this extension of the lease have not been met and so Dublin City Council

should begin the process to transfer the markets back into their full control with a view to developing the Iveagh Market.

6) Councillor Deirdre Conroy

That this City Council agrees to establish a Transport sub-committee to address the National Transport Authority Key Bus Connects issues throughout city suburbs, including tree removal, architectural heritage impact, cycle routes, community segregation. The sub-committee should include a number of Councillors from the affected areas, as well as officials. It is a priority as Round 2 on bus routes is due to be issued in September.

7) Councillor Joe Costello

That a moratorium be placed on the sale of public lands in the ownership of Dublin City Council while the housing crisis remains.

8) Councillor Mary Fitzpatrick

The elected members of Dublin City Council note with disappointment the lack of progress with the redevelopment of Phibsborough Shopping Centre. We call on the City Manager to invite the developers of the Shopping Center, Tesco, Dalymount Stadium and City Council Development office to meet and identify a solution to progress and commence redevelopment of this prime urban site without any further delay.

9) Councillor Nial Ring

That this Council recognises the selfless commitment of the Irish Defence Forces (Navy, Army and Air Corps) to the people of Ireland in defence of our nation and in the protection of the internal security of the State. In particular, it acknowledges the role played by the Defence Forces in multinational peacekeeping (600 personnel in 13 countries), humanitarian relief (18,000 refugees rescued in the Mediterranean), maritime security and fishery protection.

This Council, in its support for the campaign for Respect and Loyalty, calls on the Government to immediately take action to resolve the issues relating to the pay and conditions of service of Defence Forces Members as they are seriously impacting retention and recruitment.

This council also recognises that Military personnel are the lowest paid in Civil Sector, are subject to military law and will not withdraw labour notwithstanding that they are personally subject to unlimited liability, do not have a union and that their loyalty to serving the state cannot and would never be questioned.

That this Council expands the 30km/h speed limit zones throughout Dublin City.

23) Councillor Dermot Lacey 2019

Allocating dedicated arts funding which benefits children and young people in their communities. We know children benefit from taking part in arts, cultural and community activities, but for many children, these are simply too expensive. Less than half of nineyear-old children and one-third of 13 year olds take part in a cultural class or club (such as dance, drama and music) outside school time.

Reducing/restricting planning for fast food outlets building or advertising near schools in line with the National Obesity Policy and reducing the number of vending machines selling confectionary or sugary drinks in public spaces. (taking into account the appropriateness and proposed location of the site in line with 2013 guidelines for local area plans).

One in four of our children experience obesity or overweight. We know there is a link between availability of fast food outlets and obesity and yet three guarters of Irish schools have at least one fast food outlet within one kilometre. We want to create healthy, family-friendly communities by reducing further building or advertising of this kind.

24) Councillor Vincent Jackson

That this Council calls for more sustainable public street furniture on the streets of Dublin in order to assist people visiting the city, older persons needing places to rest etc. Dublin must rank as one of the worse cities in Europe in the provision of such basic facilities. In addition, we call for additional public toilets across the City.

25) Councillor Kevin Donoghue

That this council notes a recent request by developers to allow for delivery of co-living units under the minimum 12 m/sq outlined in planning guidelines.

This council is wholly opposed to any such request and calls on the Planning Department of Dublin City Council to be cognisant of the Minister's guidelines on coliving. There should be no co-living units below the guidelines. Additionally we need to ensure that there is not an over-supply of co-living units in the city as it would be detrimental to the development of sustainable communities.
