
Location: Rialto Cinema, No. 355 South Circular Road, Dublin 8

Proposal: The construction of a mixed-use building (with a total area of c. 11,266 sq m) comprising a student accommodation scheme of 317 No. student beds arranged in 313 No. bedrooms (276 No. 1-bed bedrooms, 4 No. 2-bed bedrooms and 33 No. studios); and ancillary café with an outdoor garden area

Date: 01/04/19

An Bord Pleanála issued the Notice of Pre-Application Consultation Opinion

- Impact of height on adjoining residential properties and the Strategic Development Regeneration Area (SDRA)
- Potential for overlooking and overshadowing to be addressed
- Proposed boundary treatments
- A site layout plan which clearly identifies the full extent of works to the site frontage, including proviso of footpaths and whether the footpaths are to be taken in charge.
- A construction and demolition waste management plan for asbestos removal
- Additional Drainage details
- Details regarding management of set down area to site frontage
- A site layout plan indicating all areas to be taken in charge and clarity whether the footpath to the site frontage is to be taken in charge
- A student management plan



Development Description Summary

- Demolition of all buildings and structures (c.2,575 sq m) on site with the exception
 of the front Art Deco section of the Rialto Cinema structure which will be retained
 and restored to its original form
- The construction of a mixed-use building (with a total area of c. 11,266 sq m)
- 317 No. student beds arranged in 313 No. bedrooms (276 No. 1-bed bedrooms, 4 No. 2-bed bedrooms and 33 No. studios);
- Café with an outdoor garden area
- 4 No. open courtyards (3 No. at Ground Floor Level and 1 No. at First Floor Level);
- TV lounge; gym; cinema; communal areas; circulation areas; reception; library; and a meeting/event room.
- 160 No. bicycles accessed directly from South Circular Road; 7 No. visitor bicycle parking spaces located to the front of the building off South Circular Road; a set down area off South Circular Road



Proposed Development

Building Height

- Development rises from 3 to 7 storeys
- Max Height: c. 20.00

Student Accommodation Breakdown

- A total of 317 No. student beds
- 276 No. 1-bed bedrooms;
- 33 No. studio units;
- 4 No. 2-bed bed


Access

- Set down/Service area provided to the front of the site




Development Plan – Zoning Objective

Site








First Floor layout



Submissions/Observations

Over 10 Number of Submissions/ Observations received:

Main Issues raised

- Welcome proposals to retain Art Deco frontage.
- Over concentration of Student Accommodation in Dublin 8.
- Need for a variety of housing typologies not solely student accommodation.
- Site is zoned for mixed use, possibility of incorporating cultural uses.
- Development could conflict with proposals for Phase 2 Dolphin House.
- Units proposed cannot be converted to any other accommodation type.
- Transient nature of accommodation, fear the units will be used for tourist accommodation during summer months.
- Height massing & scale of buildings is out of character with surrounding development and will dominate the South Circular Road frontage.
- Student accommodation is not near any college
- Welcome provision of 3 courtyards, request that thebe accessible to the public.
