NORTH EAST INNER CITY PROGRAMME OFFICE REPORT

ALLOCATION OF 2019 FUNDING

On recommendation of the NEIC Budget Sub-Group further projects were approved by the Programme Implementation Board at its meeting held on 25^{th} September 2019. This brings the total 2019 funding allocation to date to 6,317,450 (of 6.5M). The full list of approved projects / programmes is set out on **Appendix A**. The latest round of funded proposals, totaling 34,916 are as follows:

• Repairs to Garda CCTV - €9,716

A series of repairs / replacement was required as a result of a spate of vandalism on CCTV at Liberty Park, Mariners Port and St. Laurence Place East. This work has been carried out.

• Swimming Pool rental for Primary Schools - €25,200

The NEIC School Principals network sought funding from NEIC to replace funding previously provided via the School Completion Programme (SCP). This allocation will fund 12 schools X 1hr X 35 weeks. Swimming instructor costs are funded separately from schools own resources.

NEIC COMMUNITY GRANTS SCHEME 2019 (ROUND 2)

Round 2 of the 2018 NEIC Community Grants Scheme was open for applications with a closing date of 30th September. The overall allocation for 2019 was €100,000 and a total of €46,232 was awarded in Round 1 which closed at end April 2019. The balance of the allocation available for distribution in Round 2 is €53,768. 63 applications were received for this round seeking a total of €151,680. The assessment process will be carried out in the coming weeks with a view to bringing grant recommendations to the October meeting of the NEIC Board on 30/10/2019. Successful applicants will be notified after that date and a further report on grants awarded will be brought to the next meeting of the Central Area Committee

BREASTCHECK MOBILE SCREENING in NEIC

The HSE in partnership with NEIC has arranged for a Breastcheck Mobile Screening Unit to be available for free BreastCheck mammograms for women aged 50-52 in the NEIC area. The Mobile Screening Unit has been in place at Sean McDermott Street Church from Thursday 26th September and will remain there until Friday 18th October.

The uptake of the routine BreastCheck screening programme in the North inner city area is generally the lowest in the country compared to the national average. It is hoped that the presence of this visible mobile unit will encourage wider take-up of the service and to date response has been very positive.



NEIC SECONDARY SCHOOLS WORK EXPERIENCE PLACEMENT PROGRAMME 2019



Following on from the successful 2018/ 2019 placement of almost 100 second level (4th and 5th year) students in high quality 1-2 week work experience positions across businesses public and service organisations in the Dublin 1 & 2 area an ambitious target has been set by the NEIC Board, in partnership with the National College of Ireland, to place 420 students from all six second level schools serving the NEIC in similar work experience positions again in the 2019/2020 academic vear.

This Programme is a conscious effort to raise awareness and aspirations and ultimately to provide students in Dublin 1 schools with access to an insight into professions and career paths outside their existing network. The first placements will be made in November.

NEIC STRATEGIC PLAN 2019 - 2022

Work is continuing on drawing up a Strategic Plan for the next phase of the initiative. The three-year strategic plan will aim to build upon the successes of the NEIC Initiative to date and further enhance the momentum/progress in the coming years. A process of consultation involving, the Board, Sub-Groups and Community representative has been ongoing for several weeks and the document is now in final draft stage with publication expected in the coming weeks. Some structural changes have been recommended and these will take effect when the new Plan is launched e.g.

- The remit of existing Sub-Group 3 will be split to form a new Sub-Group 6 focusing on 'Driving Integration'
- Sub-Group 4 will be renamed to capture its full remit from 'Improving the Physical Landscape to "Enhancing Community Cohesion, Wellbeing and Physical Environment"
- o Membership of Sub-Groups will be reviewed to ensure balanced representation.

COMMUNITY ENGAGEMENT EVENT - Friday 27th September

There was very positive feedback on the Community Engagement Event held in D-Light Studios on Friday 27th September which was well attended by locals, the community development sector and public representatives. The event provided an opportunity to showcase approximately 20 NEIC supported projects with more detailed presentations given on some of the main strategic projects currently underway i.e.
