Environment and Transportation

Control of Stationless On-Street Bicycle Hire Bye-Laws

Bleperbike operations are continuing successfully. BleperBikes Licence has been renewed for a further 3 years. A preferred second operator has now been chosen. Trial of e-bikes (pedelecs) are currently underway and it is expected that e-bikes will be on street Q1 2020.

Parking Tag and alternative methods of paying for parking

The average number of transactions per week is now in excess of 111,000 representing over 59% of weekly Pay and Display revenue. There are 192,000 active accounts, an increase of 4,000 since last month. The Council have issued a Request for Tender for provision of the Parking Tag service for all Dublin Local authorities, Meath County Council and Kildare County Council. The closing date for receipt of tenders was Friday 20th September 2019. The opening and assessment of the tenders submitted will take place during October 2019.

Car Clubs

Discussion is ongoing with both operators who are seeking additional permits in order to expand their services and the number of vehicles located on-street, including additional EV vehicles. Two additional Car Clubs have contacted Dublin City Council and are considering setting up operations in Dublin City.

Electric Vehicle Parking/Charging

There are currently 35 dedicated EV only bays located on-street and further sites are being reviewed for suitability. The Council is currently working on a project on trialling an on-street EV charge point and expects to commission same in Q4 2019.

Pay and Display and Permit Parking

Road Maintenance Services

Road Maintenance Services Annual Works Programme to include the resurfacing of carriageways, footpath repairs and renewals, the upgrade of speed ramps and the replacement of damaged street nameplates across the city. The works programme is on target to be delivered by year-end. Road Maintenance Services is investing almost €20-Million in 2019 in the upgrade of the public road network in the City Council's administrative area. This investment will result in:

- 26km of resurfaced/ reconstructed carriageway;
- 18Km of renewed/ repaired footpaths;
- The permanent reinstatement of 2,500 utility openings;
- The repair of 220 discrete/ local defects on the road network (mainly footpath works); and
- The renewal/ replacement of 560 Street nameplates.

These works are approximately 70% complete and are on target to be completed by the year end. Road Maintenance Services has resolved over 7,500 customer services request during the first nine months of 2019. During the same period over 3,700 defects and hazards on the road network have been repaired and/or made safe. Additionally over 350 critical defects and hazards on the road network have been made safe and/or repaired within the targeted 24-hours which represents a performance score of 92%.

Licensing Unit

Casual Trading

There are approximately 260 Casual Traders Licenced in designated pitches in DCC. There were over 2,200 event trading licences issued to date this year. These include trading at the Aviva Stadium, Croke Park, Pride Parade, 3 Arena and Temple Bar Summer Night Markets. The Licensing Unit also Manage the contract for the weekly market in Meeting House Square. The Assistant Inspectors attend all these events to ensure compliance with the traders' licences. A procurement process has commenced for a Market Manager for this market. Tenders are due back on 24th October at 12 noon. As part of the Tender traders will be required to consider the Dublin City Council Climate Action Plan and the elimination of single use plastics. Preparations have commenced for Christmas Trading on Henry Street/Mary Street with two meetings held with the traders to discuss the conditions of the licences and improvements to trading for Christmas.

Street Performance

415 yearly Street Performance permits have been issued so far in 2019, with 90 visitor permits. The most popular areas for Street performers are Grafton Street and Henry Street. The permits are issued in accordance with the Street Performers Bye-laws 2016. The Assistant Inspectors are on Grafton Street/Henry Street and other areas daily and have issued 32 warning notices to date in 2019 for breeches of the Street Performers Bye-Laws. The Busker Fleadh took in Smithfield on the 15th September 2019. It was well supported with positive feedback. The licensing Unit worked closely with the Events Unit and the Street Performers for this event.

Horse Awareness Week 7th- 12th October 2019

Dublin City Council is represented on the Dublin Region Horse Welfare Working Group. A horse awareness week took place from 7th-12th October in the Finglas area. A Presentation on responsible horse ownership was given to the schools in the area. The Lord Mayor attended and spoke at the open day in the Finglas Youth Resource Centre on 12th October. Over 400 young people attended the presentations/open day and the feedback from the local horse owners has been very positive.

Dublin Waste to Energy Community Gain Projects Grant Scheme

With reference to the Dublin Waste to Energy Community Gain Projects Grant Scheme 2016 and 2017, 58 of the 67 projects approved have been completed with circa €7.1 million of the €9 million approved in principle been drawn down to date.

With respect to the Dublin Waste to Energy Community Gain Projects Grant Scheme 2019 The Community Gain Liaison Committee assessed each of the 51 grant applications submitted, against the Dublin Waste to Energy Community Gain Projects Grant Scheme 2019 general conditions and criteria and following detailed consideration 37 grant applications were approved in principle to a total value of circa €1.4 million.

Housing Recycling Project

The project is currently focusing on the South East where there are 45 DCC housing complexes. 23 complexes have seen the introduction of Green and brown bins and residents have also had the opportunity to attend a recycling workshop at a nearby location. To date 23 (1100 Ltr) Green bins and 32 (240 Ltr) Brown bins have been introduced as part of the project. Increased recycling rates have led to extra green bins introduced in some complexes and the removal of 20 (1100) litre general waste bins.

Community Environment Action Fund 2019/2020

The Department of Communications, Climate Action and Environment have awarded €33,638 to DCC for the Community Environment Action Fund (Local Agenda 21) for 2019 /2020. This was match funded by DCC. The scheme was advertised in the national press on the 23rd August and the closing date for applications was the 27th September. Climate and Biodiversity related projects are prioritised for receipt of funding under the scheme.

137 applications were received by DCC for the funding. These applications are currently undergoing assessment, and the list of projects funded under the 2019/20 scheme will be published by the DCCAE on their website once approved.

Reuse Month

Reuse Month which takes place annually in October encourages people to reuse everyday items as often as possible, while considering alternative options to single use products, repairing rather than replacing when feasible, and upcycling and repurposing unwanted items regularly. National Reuse Month now in its fourth year was developed by Ireland's Waste Management Offices and is supported by the Department of Communications, Climate Action and Environment through www.mywaste.ie. Reuse Month is a month long event which supports the UN's Sustainable Development Goals, and in particular Goal 12 which calls for Responsible Consumption and Production.

Dublin City Council kicked off Reuse Month with a sustainable fashion event, Unravel, in the Dean Hotel on 6th October 2019. Working with 'Swapsies' and '100% Reloved' to deliver the sell-out event, attendees repaired and upcycled their clothes, while learning about the true cost of our clothes. A screening of a short film about where second hand clothes end up, was followed by a panel discussion on sustainable fashion.

ReLove Fashion

Dublin City Council in conjunction with other Eastern Midland Regional Local Authorities launched a fashion competition promoting reuse aimed at secondary schools, designed to coincide with Reuse Month. Nine schools have entered the competition from the Dublin City Council region, with various entries from each of these schools. The DCC finalist, will be announced on 7th November and will go on to a grand final which takes place on 21st November at the Rediscovery Centre. The overall winner will receive a fashion design pack to the value of €1000.

Green Schools Awards 2019

The annual Green Schools Seminar organised by Dublin City Council for schools taking part in the awards scheme was held in Croke Park on 2nd October. Over 70 schools were represented at the seminar, with staff from the Environmental Awareness Office and An Taisce present to give information on each of the various Green Schools themes.

Dublin City Neighbourhoods Awards 2019/Pride of Place Competition

The results of the City Neighbourhoods competition were announced in Croke Park on the 26th September 2019.

The City Neighbourhood Schools competition awards ceremony will be held in the Mansion House on Friday 6th December 2019. The IPB Pride of Place Awards will be announced in Kilkenny on 30th November 2019.

Let's Talk Climate Action Workshops

'Let's Talk Climate Action' workshops have been rolled out to community and residents groups. The workshops help to generate interest and grow awareness in the community, which will assist in implementing climate actions. Two workshops have been held to date. The final workshop in this series will be held on 9th November in the Westin Hotel. The workshops are free to attend and open to all. The Waste Management Department will seek to roll out further workshops into 2020.

Halloween Response

The Waste Management Department in conjunction with the Local Area Departments, Housing Department and Parks Department have put in place a range of resources that are available out of hours and on call in the lead up to Halloween to deal with stockpiling of bonfire materials. Customers can report materials for removal to 222 2222 or out of hours at 1800 29 39 49 or online at dublincity247.ie.

Litter Management Plan

A draft replacement 3-year litter management plan is being prepared to present to the Environment SPC for approval to proceed to public consultation

Special Speed Limit Bye-Laws 2019

The Special Speed Limit Bye-Laws, 2019 public consultation was closed on Sunday 22nd of September. Feedback of public is being assessed and the report on it will be presented at the next Transportation Strategic Policy Committee meeting. Should the bye-laws be adopted, a phased implementation will begin in January; the 30km/h speed limit will be introduced to three separate areas over the course of the year. Upon completion, all residential areas with the Dublin City Council Administrative Area will have a 30km/h speed limit.

New Service Request System

With a view to streamlining the process for Transport Advisory Group Service Requests being submitted, assessed and replied to, we have set up dedicated websites for Councillors and members of the public to submit their requests. The public website can be accessed via the following link

<https://www.dublincity.ie/traffic-service> while a link to the Councillor Website has been emailed directly to the elected members. The aim of the websites is to ensure that the Administrative Staff and the Area Engineers are furnished in one request with all necessary information to begin to evaluate it. This should in turn lead to a quicker response time on service requests.

Water Framework Directive (WFD) Greenways and River Flood Protection

DCC is working to integrate a number of projects to ensure that the opportunities to meet DCC's WFD obligation of achieving "good" status for each river by 2027 at the latest are maximised. Current examples are:

- The River Camac where consultants have been appointed by DCC to deal with flood risk across the DCC and SDCC sections of this river and this is being integrated into a desire to "de-culvert" this over engineered river where possible so that it can, over time, be restored to a natural state. The project will also involve identifying and remedying urban pollution sources, where possible. This is also being done in conjunction with an existing Greenway proposal and also in tandem with Urban Regeneration and Development Fund (URDF) funded projects in the area.
- The River Santry where DCC is preparing a brief to engage consultants as part of a URDF funded project to restore the river to a more natural state, and investigate and remedy sources of pollution. Again this work is being designed in conjunction with an existing Santry River Greenway Project.

Surface Water and Pluvial (Rainfall) Flood Risk Management

It has become increasingly apparent that, as a result of climate change, rainfall patterns in Dublin have changed from the previous low intensity long duration type rain to shorter and far more intensive rainfall events. The drainage infrastructure was not designed to deal with this type of rainfall and, as a result, there have been a number of localised flood events in recent months.

Arising from work initiated by the DCC Surface Water and WFD teams in close liaison with the DCC Climate Change Action Plan team, it has been agreed that DCC should progress a number of nature based water retention measures using a sustainable urban design approach at different locations across the City. These will have the dual effect of reducing the rate of surface water runoff into sewers, thus reducing the risk of downstream flooding, as well as improving the water quality of that runoff through percolating the runoff through natural media with a green infrastructure approach.

In recent months, the WFD / Surface Water team has continued to liaise with their colleagues in E&T Roads, in the Parks Department and in the City Architect's Office to facilitate the implementation of this approach in particular public realm projects that are at design stage.

Bathing Waters

Dublin City Council has appointed a Senior Engineer to lead a joint effort with our colleagues in Dun Laoghaire Rathdown to deal with the long-standing problems regarding the quality of the bathing waters in the south city area. DCC is also working in close liaison with the EPA, the HSE, and the DHPLG and with Irish Water in relation to this matter. A Bathing Water Plan for the area will be prepared in early 2020.

Climate Action Regional Office (CARO) update

The 4 Dublin Local Authority Climate Change Action Plans (CCAPs) were submitted to government at the end of September 2019. 12 sectors across 7 Government Departments have also prepared Climate Adaptation Plans as required under the National Adaptation Framework. CARO has made submissions to all of these sectoral plans. The CARO office has been working with Local Authorities and Codema in the delivery of the CCAPs and is now agreeing how the implementation of these plans will be undertaken at an individual Local Authority level.

The CARO has also been working with the LGMA, other CAROs and the Department of Communications Climate Action and Environment (DCCAE) on a Draft '*Local Authority Climate Action Charter*'. This Charter is an action in the National Climate Action Plan published in June 2019. The CARO is engaging with the planning departments of all Dublin LAs as well as the Eastern Midlands Regional Assembly and DHPLG on how Climate Action can be included in the review of the County/City Development plans.

There are a number of Climate Action training conferences and workshops coming up in November and December which will be of interest to elected members. These include two winter training events on Climate Action on November 21st (Athlone) and November 23rd (Cork) through the Association of Irish Local Government and a workshop on *Climate and Biodiversity Action* by the Irish Environmental Network and Environment Pillar in December in Dublin (date to be agreed).

DCC is undertaking a recruitment process for a Climate Action lead who will coordinate internally with the relevant interdepartmental climate action teams and liaise with CARO and Codema in the implementation of actions within the DCC Climate Change Action Plan.

Air Quality Monitoring and Noise Control Unit

DCC has signed an MOU with the Dublin Port Company to cooperate on air quality monitoring in Dublin Port. The first multi pollutant monitoring station in Dublin Port is due for commissioning by the end of 2019. DCC is completing the commissioning of a number of combined ambient air quality and noise monitoring station around the city and will launch a new website to coordinate the dissemination of air and noise data in real time to the public.

A Task Force convened by the Minister for Communications, Climate a Change Action and Environment is due to meet before the end of 2019. This Task Force, comprising of government and state agencies, as well as local authorities will consider how to address the threat posed by unacceptably high levels of nitrogen dioxide levels in the Dublin region. A working group within DCC, consisting of elected members and officials will be convened to feed DCC policy and op on the deletion of the Task Force.

Preparations for the next round of noise mapping and development of noise action plans under the Environmental Noise Directive will commence with shortly with a series of workshops and meetings between the various local authorities and other stakeholders.

Sustainable Mobility Communications and Promotion

European Mobility Week/Car Free Day

European Mobility Week took place from the 16th to 22nd of September 2019. This year's theme was 'Safe Walking and Cycling' with the call to action 'Walk with Us' putting the spotlight on safe walking and cycling and the benefits it can have for our health, our environment and our bank balance. Car free day is an integral part of European Mobility Week and took place on Sunday the 22nd of September 2019. Dublin City Council closed College Green on this day to motorised traffic and activated the space to promote a behavioural shift towards a more sustainable urban mobility culture. This free family event, had ongoing activities throughout the day including BMX Stunt Shows, Mindful Walking Tours, e-bike and cargo bike demos, bike polo and a bike clinic. A special Spokeswomen cycle tour also took place travelling from Herbert Park to College Green. Dublin City Council Culture Company were engaged to provide an art installation which manifested as a natural grass area where attendees were encouraged to participate in expanding the area by rolling out more grass or to relax in the area where beanbags and games were provided. Additional activities included athletics, ultimate frisbee, giant games and a chess challenge with a Russian chess grandmaster - something to suit all tastes! The event attracted in the region of 21,000 people.

Walktober

Walktober is an NTA Smarter Travel initiative. It is a fun, free walking challenge where teams of 3-6 people aim to increase their daily step counts, to have fun and to win prizes! Twenty-five teams from Dublin City Council signed up to the challenge with a total of 109 participants. Looking at the figures 2 weeks into the challenge, the average number of steps per DCC participant was over 11 thousand steps per day. General guidelines equate 10,000 steps to 30 minutes of moderate intensity physical activity, which is the target amount to benefit from the health enhancing benefits including improved physical and mental health and decreased risk of disease. Regular physical activity is also associated with improved work productivity and decreased absenteeism.

To add some additional fun and motivation to Walktober as well as targeting staff members not signed up to the challenge, weekly staff lunchtime walks were organised for the month with a different focus each week e.g. paced walk, mindful walk, historical walk.

European Transport Conference

The European Transport Conference (ETC), the annual conference of the Association for European Transport, took place in Dublin Castle from the 9th to the 11th of October. The conference attracts transport practitioners and researchers from all over Europe where they can find in-depth presentations on policy issues, best practice and research findings across the broad spectrum of transport. A number of Dublin City Council

Transportation staff presented at the conference. In addition, DCC hosted an exhibition stand showcase some of the key projects the teams are involved in.

Handshake Assembly

Three DCC Transportation staff will travel to Munich in October for the bi-annual Handshake Assembly. Handshake is a European project involving thirteen cities collaborating on over 60 measures across 23 different types of solutions, which are designed to make cycling a more attractive everyday mode of transport. The Handshake project focuses on all stages of delivery, from planning through to implementation and the monitoring of success. These are aided by governance arrangements that help manage a transition towards a greater quality of life through increased levels of cycling. The Munich Assembly includes a reflection on Dublin's 2019 Velo-city experience.

New Cycling & Walking Officer

The new Dublin City Council Cycling & Walking Officer is due to commence work on Tuesday the 29th of October 2019.

1. New Policy/Strategic

The Poolbeg SDZ Planning Scheme has been approved by An Bord Pleanála and will provide a New Urban Neighbourhood of some 3,500 homes. The Ballymun LAP has been approved by the City Council and will significantly contribute to the continued regeneration of the city. The Cherry Orchard LAP was approved by the City Council at its October meeting. The implementation of the Clongriffin-Belmayne LAP is being progressed.

The new National Planning Framework 2040 provides for 265,000 extra population and associated infrastructure in the Dublin Area. The DHPLG has published new Guidelines for Planning Authorities in March 2018. “Sustainable Urban Housing” Design standards for new apartments. In December 2018 the DHPLG published Guidelines on Urban Development and Building Heights.

The Regional Spatial and Economic Strategy which includes a Metropolitan Area Strategic Plan (MASP) was approved by the Regional Assembly in May 2019. The City Council has embarked on a major review of Z6 industrial land banks, following a presentation to the Planning SPC and the City Council in March.
