- 1) While our parks are maintained by direct labour there are a number of open spaces maintained by contract, this is an arrangement that has been in place for a number of years, which is satisfactory.
 - The contractors were appointed following an E-Tenders competition held under the remit of E.U. procurement rules. The Contract award notice can be viewed at https://irl.eu-supply.com/ctm/Supplier/PublicTenders/ViewNotice/190484
- 2) The landscape contractors are primarily in place to maintain grassed areas and keep them cut. Dublin City Council is a partner to the All-Ireland Pollinator Plan, which is a national plan to prevent the decline in our pollinator species. As part of the Parks Service's commitment to the programme, we have stopped using herbicide, which has knock on benefits to biodiversity
