With reference to the proposed transfer of the residue of a leasehold interest in a plot to the rear of 34 Sandford Road, Ranelagh, Dublin 6

An application has been received from Chester and Diana Reid, the owners of no 34 Sandford Road, Ranelagh, Dublin 6, to purchase a landlocked plot of ground measuring 24sqm at the rear of their property which has been incorporated into their garden for over 20 years. The subject plot is shown outlined red on the attached map index no SM-2019-1046.

The Chief Valuer reports that agreement has been reached with the applicant subject to the following Terms and Conditions which he considers to be fair and reasonable:

- 1. The subject plot comprises an area of 24 sq. metres and is shown indicatively outlined in red on the attached map ref SM- 2019-1046.
- 2. The Council will dispose of the subject plot comprising 24sqm at €25per sqm for the consideration of €600 (six hundred euro)
- 3. The Council will transfer the residue of its leasehold title in the subject plot.
- 4. The applicants will be responsible for their own legal fees in the matter and €1,500 (one thousand five hundred euro) plus VAT towards Dublin City Council legal fees
- 5. The applicant holds the freehold title or equivalent interest in their respective property.
- 6. The applicant is deemed to purchase the property with full knowledge of its actual state, condition, and structure, and will take it as it stands subject to any right of way, water, light, drainage or other easement, right or privilege and be familiar with its boundaries, fences and walls.

DCC acquired the unexpired residue of Leasehold title in the property in 1974 from Windale Limited the original lease was for a term of 890 years from 29 September 1830. Registered on folio DN72418L

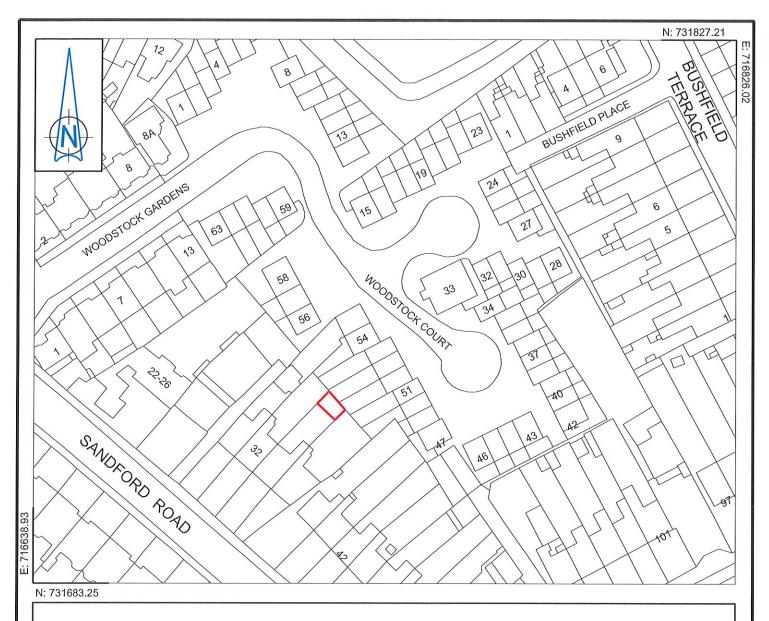
