As part of the new limits "Speed limit" signs are erected at all points where there is a change of speed limit. Incorporated into these new signs there is a "children at play" and "Slow Zone" signalong with the speed limit. This is to warn motorists that it's a residential area and to expect children. 2) Raising the profile of speed ramps would not be recommended and can lead to additional noise, vehicle damage and possible personal injury. We would therefore not recommend the raising of ramp heights that would be higher than our best practise standards. However, the following measure to assist these right turners was implemented in June 2019. Specifically, we programmed and installed a new program to alter the operation of the traffic signals at this junction so as to apply an early cut off green to the traffic entering the junction from the Lucan Road direction. In practice, this means that the vehicles entering the junction from St. Laurence's Road will have a green light for a longer period than those entering the junction from the opposite side, thereby facilitating the road users seeking an acceptable gap in traffic to turn right from St. Laurence's Road to Chapelizod Bridge.
