Reply

Any further growth of the Just Eat dublinbikes scheme in the city is dependent on the identification of additional sustainable funding for capital and operational costs. This work is ongoing and is in addition to measures to finance the existing bike scheme in its current format. A further factor that must be considered is the impact of 'dockless' bike hire schemes on the Just Eat dublinbikes business and operational model. There is therefore no definite timeline in place for expansion in Dublin South Central Area at this time.

Can the Director of Services please give me a breakdown on the Air Quality over the past 5 years for the Ballyfermot, Chapelizod / Cherry Orchard area. From my observation, it appears after many years on improvements the air quality has reduced over the last few years.

Reply

Currently the monitoring station at Ballyfermot Library monitors **Particulate Matter** (**PM**) and **Nitrogen Dioxide** (**NO**₂) levels as part of the National Air Quality Monitoring Network. This network consists of monitoring stations spread out across the country, which monitor for various air pollutants. The data from each site is collated and then compared to EU legal limit values.

The results shown below are annual maximum levels taken from the monitoring station located at Ballyfermot library over the past 5 years. Levels above the limit value are shown in the data tables below, but these do not constitute an exceedance based on the fact that EU Clean Air For Europe Directive allows a maximum number of times the limit level values can be surpassed before an exceedance is applied.

For example, the **NO**₂ limit value of 200 μg/m³ must "Not to be exceeded more than 18 times in a calendar year" and the **PM10** limit value must "Not to be exceeded more than 35 times in a calendar year".

Based on these requirements there has been no exceedances of EU limits over the past 5 years at the Ballyfermot site, albeit levels have on occasions, been above the limit value, but within the acceptable allowable number per year.

The expansion of the air monitoring network in Dublin does indicate that elevated levels of nitrogen dioxide are being identified in some areas, particularly along the M50 and in the St. Johns Road area. Dublin City Council is one of the stakeholders

on the Working Group on Urban Transport-Related Air Pollution established by Minister Richard Bruton to address this challenge.

Q9 Councillor Vincent Jackson

To ask the Director of Services that Dublin City Council seek to employ a number of staff who would be revenue neutral. If the works of dog wardens were aligned with litter wardens and the obstacles in allowing these roles to be effective were sorted out once and for all with primary legislation / bye laws etc. The level of fines for indiscriminate dumping and dog fouling are indications our current system is not working.

Reply

The role of Dog Wardens and Litter Wardens is laid out in the Control of Dogs Acts and the Litter Pollution Acts respectively. Dog Wardens are responsible for the enforcement of the Control of Dogs Act while the Litter Wardens enforce the Litter Pollution Acts. The Control of Dogs Act deals with, inter alia, dog licences, stray dogs, etc. while the Litter Pollution Acts, (Section 22) deals with dog fouling.

Litter Wardens and Dog Wardens are authorised under Section 22 of the Litter Pollution Acts to issue fines to a person in charge of a dog where they do not clean-up immediately after their dog. Others persons authorised to issue fines under Section 22 are members of the Garda Síochána and DCC staff working in the Environmental area in the Public Domain.

Q10 Councillor Vincent Jackson

To ask the Director of Services to request that the Road Engineer meet with me and a number of residents to see at first hand the horrendous issues residents are met with trying to exit the Drumfinn area of Ballyfermot when travelling from Cleggen Park area of Ballyfermot towards Clondalkin etc. The current lights at Drumfinn Road onto Ballyfermot Road do not afford sufficient time to exit this busy estate with 4 schools, Social Welfare Office, Garda Station, Youth Reach, Civic Centre and 1,200 houses. Having a full set of traffic lights on Ballyfermot Road at Cleggan Park would help alleviate the situation.

Reply:

Regarding the traffic signals at Ballyfermot Road at Drumfinn Road please note that in September 2017 we made a number of changes to the junction signal operation in order to allow, if required, an increased number of vehicles to enter and exit Drumfinn Road. Specifically, we increased the amount of time allocated to the relevant traffic phases which permit the movement of vehicles to and from Drumfinn Road. In other words there is a greater amount of green time available to those wishing to enter/exit Drumfinn Road. Furthermore, we have taken measures at this junction and at adjacent junctions, to ensure that the cycle length (the total amount of time available to all traffic phases) will reduce during off-peak times. In essence this provided more opportunity for vehicles entering/exiting Drumfinn Road as the wait time between the traffic phases permitting movements in/out of Drumfinn Road reduced.

Please also note that in November 2019 we further increased the amount of available time for traffic exiting Drumfinn Road via our SCATS system following a customer query.

In response to your concerns above we have further increased the amount of available time for traffic exiting Drumfinn Road via our SCATS system (effective as of 06/01/2020) but are limited in our scope to do so since this junction is sited along a busy bus priority corridor and the junction is set up in such a way so as to allow buses priority thereby reducing time to side roads when a bus approaches this junction. We will continue to monitor the operation of this junction via our SCATS Adaptive Traffic System and will make any further changes as necessary to ensure the continued smooth and safe operation of this junction for all road users. Finally, please note that we have referred the second part of your question regarding a request for a full set of traffic lights on Ballyfermot Road at Cleggan Park to the Area Engineer Niall O'Neill.

To ask the Director of Services to look at bringing the precinct improvement plan for Ballyfermot Road back onto the table and that this project include a retail strategy for this busy commercial district, which could look at Kylemore Road, Decies Road, Claddagh Green, in conjunction with Ballyfermot Road.

Reply

The NTA's programme to improve bus services across the Dublin region is currently under public consultation and amendments to the original proposals are ongoing. Ballyfermot Road will be impacted by these plans but the proposed changes to traffic layout have not been finalised. Business owners and residents in Ballyfermot have been invited to engage with this consultation process to allow their suggestions and concerns to be incorporated into any new proposals. Along with the upgrade of the bus services, it is intended to incorporate precinct improvements where possible along the route. Until this process is completed and the impact of the changes are assessed, it is not feasible to consider a separate precinct improvement plan to Ballyfermot Road. However, meetings did take place last year between the business owners in Ballyfermot, Planning, Public Domain and Ballyfermot Area office and I am happy to facilitate these again if they proved helpful.

Can the Director of Services please ask Public Lighting / ESB when public lamp standards are to be re-painted in the South Central Area? Many are in a poor state and its years since they were re-painted. Can I be told how an area is chosen for these works?

Reply

Public Lighting Services carry out painting on a certain number of their poles every year throughout the five council areas.

There is a very limited budget allocated for painting poles in each of the five council areas each year. In 2019, €10,000 was spent on painting poles in the South Central Area and the following roads were painted; La Touche Road, Ballyfermot Road, Stannaway Road, Mount Shannon Road, Clanbrassil Street, Mayfield Road, O'Donovan Road, Madison Road and Harold's Cross Road.

All requests received for painting of poles are examined and if the poles are suitable and painting is required, they are added to a list for inclusion on a future painting programme subject to available finances.

The poles are painted in order of priority of need, unless specific funding is provided from the area offices for painting the poles on a particular road or area.

If there are specific poles or roads the councillor is requesting painting on, if the councillor provides the required details (road name, pole numbers, nearest house numbers etc.), they will be examined and if painting is required and the poles are suitable, they will be added to a list for inclusion on a future painting programme, subject to available finances.

There are a number of public lights installed on ESB Network poles in the South Central Area. While Public Lighting Services own and maintain the lights and the brackets the lights are installed on, the poles themselves are the property of ESB Networks. The painting of ESB Network poles is a matter for ESB Networks.
