To ask the Chief Executive why the Tenant Purchase Scheme is not allowed for tenants in Modular Housing and if this decision is to be reviewed at any stage?

To ask the Chief Executive how many units in the Scribblestown PPP development will be earmarked for people with a disability and how many will be for Senior Citizens.

**Q.12 COUNCILLOR ANTHONY CONNAGHAN**

To ask the Chief Executive to arrange for the removal of the trip hazard at **(details supplied)** which was caused when the court was paved recently. Council tenant's homes were given new footpaths but this house was left without. Can this be rectified ASAP please?

**Q.13 COUNCILLOR SÉAMAS MCGRATTAN**

To ask the Chief Executive to install a hand rail in the following lanes **(details supplied)** to assist elderly people using them.

**Q.14 COUNCILLOR SÉAMAS MCGRATTAN**

To ask the Chief Executive to put speed ramps on **(details supplied)**.

**Q.15 COUNCILLOR SÉAMAS MCGRATTAN**

To ask the Chief Executive to have the following works carried out for the tenant in **(details supplied)**, repair the damaged path outside her gate, repair the damaged fence in her back garden and fix the broken shower rail.

To ask the Chief Executive to install signage, on existing poles on the surrounding main Roads, to direct people to **(details supplied)**.

To ask the Chief Executive the basis for the Dublin City Council policy to reject new zebra crossing installations, including both the rationale for the policy and when, how and by whom the decision was reached.

**Q.18 COUNCILLOR CRÍONA NÍ DHÁLAIGH**

To ask the Chief Executive with regard to voids:

- What is the average length of time a void lays empty?
- What is the average length of time it takes to reallocate a void?
- What is the average cost of reallocating a void?

**Q.19 COUNCILLOR CRÍONA NÍ DHÁLAIGH**

To ask the Chief Executive if he will consider for a transfer for **(details supplied)** to a more suitable accommodation. Her flat has had so many floods she just cannot cope anymore and the stress is impacting on her health.

**Q.20 COUNCILLOR MARIE SHERLOCK**

To ask the Chief Executive the number of residential planning applications which have received planning approval since the start of 2017, in which one or more units are below the minimum floor area standard as per the Dept. Housing, Planning and Local Government design standards.

**Q.21 COUNCILLOR MARIE SHERLOCK**

To ask the Chief Executive for a list of planning applications submitted between 2013 and 2017 for each of the following; shared accommodation, student accommodation and co-living residential developments and to detail the number of which have been granted or refused permission.

**Q.22 COUNCILLOR MANNIX FLYNN**

To ask the Chief Executive to issue a full report with details regarding any land ownership or lands in the hands of the Council at the Montague Court area of Dublin. These lands relate directly to the planning application for development of 45-47 Greenside House, Cuffe Street, by the development group KC Properties Limited. This planning application relates to the demolition of the existing building and the construction of an 8 story office block that incorporates developing the lands at Protestant Row and Montague Court.

**Q.23 COUNCILLOR MANNIX FLYNN**

To ask the Chief Executive to confirm what companies, if any, have been engaged as consultants with regards the upcoming DCC Development Plan 2020-2025.

**Q.24 COUNCILLOR MANNIX FLYNN**

To ask the Chief Executive to clarify whether DCC Homeless Executive wish to stand over the remarks made by one of its senior staff members at a recent housing SPC meeting, regarding an alleged consultation process between the community at Whitefriar Street, the Peter McVerry Trust and the Dublin Homeless Executive on any proposals for Homeless services at Avalon House, Aungier Street.

Further, it is now firmly established within the community that no consultation took place. This has been accepted by the Peter McVerry Trust and apologies have been made in writing to certain individuals who were named as having been consulted regarding the Avalon House Development.

The responsibility is now on Dublin City Council and Dublin Regional homeless executive to clear up this matter and to offer an apology to the community.

**Q.25 COUNCILLOR MANNIX FLYNN**

To ask the Chief Executive to issue a full update and evaluation of the cost of implementing the revised plaza plan for the Dame Street area. Given the rising cost of construction within the city it is time to reappraise the budgets and the costings for these major projects.

Further, can the manager also include the envisaged costs of the white water rafting project and also the costing projections for the intended stand-alone library development at Parnell Square?

This is one question regarding public expenditure on major DCC projects.

**Q.26 COUNCILLOR LARRY O'TOOLE**

To ask the Chief Executive to respond to this request of **(details supplied)**: to have the surface of the back yard of these premises be resurfaced. In its present condition it floods on a regular basis.

**Q.27 COUNCILLOR LARRY O'TOOLE**

To ask the Chief Executive to respond to this request: to have the shores in the back garden of **(details supplied)** cleared.

**Q.28 COUNCILLOR LAWRENCE HEMMINGS**

To ask the Chief Executive if a ticketing system/CRM for council can be created to track representations submitted by members on behalf of constituents as is used by Fingal and South Dublin County Councils to assist with the efficacious delivery of results for service users of Dublin City Council.

**Q.29 COUNCILLOR DEIRDRE CONROY**

To ask the Chief Executive to review and remove the footpath car parking to make safe access for pedestrians and disabled people along Clogher Road between Bangor Road and Sundrive Road. Resident notes that pedestrians have to walk on main road with prams to pass parked cars.

There is a large primary school 200m away from where the footpath is blocked for access due to the parking obstruction. The road is busy with cars and buses as speed on the narrow section of road.

**Q.30 COUNCILLOR DEIRDRE CONROY**

To ask the Chief Executive when the City Council and NTA working group/Transport sub-committee will commence. As there are issues on roads all over Dublin that the Council is involved in, such as traffic management, parking, pedestrian crossing, footpath and road maintenance, the Enquirer in Question 1 notes that the latest BUS CONNECTS proposes to re-route more buses and traffic on the narrow stretch of Clogher Road (Between Sundrive and Bangor Road), away from Crumlin Road and other minor roads.

This road is at maximum capacity at present considering the narrow road width, volume of traffic and hazard of parked cars. It is also very busy with pedestrians and cyclists. Hence, I ask whether the Council will consider traffic calming, rather than extensive increase in traffic on this narrow residential road.

**Q.31 COUNCILLOR DEIRDRE CONROY**

To ask the Chief Executive to what extent will the Council renovate and repair drainage and sewage systems on Crumlin Road adjacent to Iveagh Gardens where there has been serious flooding damage and foul overflow from the Storm Ciara and Storm Denis mid-February? The emergency assistance from the Council so far is appreciated from enquirers, however, a fundamental repair system will be required and interaction with Irish Water. Can information on the repair system be provided?

**Q.32 COUNCILLOR VINCENT JACKSON**

To ask the Chief Executive to please give me details of the following: Dublin City Council changed the contract with Dublin Media to some new company in the past few months. We are now told the costs of doing business with this new company are substantially more expensive than the previous operator what is the rational of giving the contract to a new company who is more expensive? I was always led to believe the awarding of contracts was based on service & value for money.

**Q.33 COUNCILLOR VINCENT JACKSON**

To ask the Chief Executive to ensure the bad surface along the perimeter wall along Long Meadows Pitch & Putt Course at Sarsfield Road Ballyfermot Dublin 10, be looked at to see if it's safe & remedial work be done to repair / replace the wall / surface. Residents have told me that the pebble dashing is falling off in small sheets from time to time.

**Q.34 COUNCILLOR VINCENT JACKSON**

To ask the Chief Executive to please give me a report on the following: DCC bought back the lease on **(details supplied)**. I am told it is to be turned into a domestic dwelling due to the fact this is a small commercial terrace. I find it would be more suitable to retain the ground floor for commercial purposes. In addition this area can be difficult enough with groups of youths hanging around. The logic of not just buying a local house for the AHB would have I think been a better alternative.

**Q.35 COUNCILLOR VINCENT JACKSON**

To ask the Chief Executive to look at the retention of industrial lands at **(details supplied 1)**, which are currently subject to a material variation towards residential use. I am fully supportive of all housing developments however this site offers excellent employment potential in the existing facility & the adjoining large site. If all employment is lost to the city people will continually have to travel great distances for employment, this variation will restrict employment potential development of the **(details supplied 2)** where they were planning the siting of a training centre on some of these site. Housing built on this site will do little to impact on our large housing lists.

**Q.36 COUNCILLOR KEVIN DONOGHUE**

To ask the Chief Executive if he will look at the drains on Thorncastle Street in Ringsend. The lid on the street is damaged and poses a risk to people using the footpath.

**Q.37 COUNCILLOR KEVIN DONOGHUE**

To ask the Chief Executive will the council build the garden wall at **(details supplied)** back to its original state as the prior tenant broke the wall to install a gate.

**Q.38 COUNCILLOR KEVIN DONOGHUE**

To ask the Chief Executive to prune the tree at **(details supplied)**, the tree is touching against the wall of the house and the tenant is saying that it is doing damage to the house.

**Q.39 COUNCILLOR JAMES GEOGHEGAN**

To ask the Chief Executive further to question 87 on the 4th of November 2019, question 22 in the 3rd of February 2020, the passage of Motion 25 of the South East Area Committee on the 9th of September 2019, Motion 6 and 17 of the South East Area Committee on the 10th of February 2020 South East Area Committee meeting and the request endorsed by all of the councillors present at the 10th of February 2020 meeting that councillors would also be on the joint task force established by Dublin City Council (DCC) in 2019, headed by a full time DCC Senior Engineer that has representatives from DCC, Dun Laoghaire Rathdown County Council, the Department of Housing, Planning and Local Government and Irish Water addressing Bathing Water and ongoing issues in relation to both Merrion Strand and Sandymount Strand if he can confirm if this request will be granted and the number of councillors that can be appointed to this Task Force and when a meeting can take place involving councillors with the Task Force.

**Q.40 COUNCILLOR JAMES GEOGHEGAN**

To ask the Chief Executive further to question 20 on the 3rd of February 2020, when the date for the next meeting of the Sutton to Sandycove Joint Committee shall take place; if no date has yet been set, please provide an explanation for why there has been no meeting of the Sutton to Sandycove Joint Committee since the local elections in May 2019 and detail within how many weeks it is anticipated that there shall be a meeting irrespective of whether a date has in fact not yet been confirmed.

**Q.41 COUNCILLOR JAMES GEOGHEGAN**

To ask the Chief Executive further to question 22 to the South East Area Committee on the 10th of February 2020, whether existing statute or bye-law prevents a private individual from seeking or obtaining permission to install an underground electrical cable duct underneath a public footpath adjacent to their home to carry an electric vehicle charging cable; if existing statute or bye-laws do prevent a private individual from obtaining such permission, please identify the relevant statute and bye-law along with section and subsections; if the Chief Executive is aware that in Meath, Kildare and Wicklow, it is permissible for a private individual to seek or obtain permission to install an underground electrical cable duct underneath a public footpath adjacent to their home to carry an electric vehicle charging cable; if the Chief Executive has any plans to consider how it may be permissible for a private individual to seek or obtain permission from Dublin City Council to install an underground electrical cable duct underneath a public footpath adjacent to their home to carry an electric vehicle charging cable.

**Q.42 COUNCILLOR JAMES GEOGHEGAN**

To ask the Chief Executive why Community Development within Dublin City Council is exclusively funded by discretionary budget funding instead of core budgetary funding; if the Chief Executive can outline whether Community Development in the past 10 years ever formed part of core budgetary funding or if it has always been funded by discretionary budget funding; if the Chief Executive has any plans to see Community Development funding form part of core budgetary funding.

**Q.43 COUNCILLOR RAY MCADAM**

To ask the Chief Executive to outline the streets to be included by the Roads Maintenance for the Works Programme for each of the five administrative areas within this Council; and whether he will make a statement on the matter?

**Q.44 COUNCILLOR RAY MCADAM**

To ask the Chief Executive to indicate what exactly is the preference of the Housing Department with regards the redevelopment of **(details supplied)**, in terms of housing typology, numbers of units, scale and density of any possible development and to indicate what contact with the Department of Housing, Planning & Local Government as to advance the Council's preferred plans for the site; and if he will make a statement on the matter?

**Q.45 COUNCILLOR RAY MCADAM**

To ask the Chief Executive to outline the number of commencement notices submitted to the Planning Department in line with granted planning permissions, for each month since May 2016; and if he will make a statement on the matter?

**Q.46 COUNCILLOR NIAL RING**

To ask the Chief Executive for the following details regarding the emergency accommodation provided by the Dublin Region Homeless Executive (DRHE):  
Number of facilities by type i.e. Supported Temporary Accommodation, Temporary Emergency Accommodation, Family Hubs, Private Emergency Accommodation facilities and Hotels/B&BS.

a. Number of places available by type.

b. Cost per person for each type of accommodation. (Annual, monthly, daily or whatever gives best indication of overall average per person)

To ask the Chief Executive in relation to the provision of dedicated Electric Vehicle (EV) only parking bays, can the Chief Executive detail how many such bays are currently in operation and to indicate the cost per annum of providing these bays. In addition, can the Chief Executive confirm how many more bays are planned and if the planned number will meet future demand.

**Q.48 COUNCILLOR NIAL RING**

To ask the Chief Executive for an update on progress on the design and implementation of the Second Dublin City Public Art Programme and, in addition, the work being done to maximise Per Cent for Art funding opportunities across the council.

**Q.49 COUNCILLOR NIAL RING**

To ask the Chief Executive for the following updates in relation to Fairview Park:

- a) Tearoom project: preferred location, planning stage, cost and a possible time line for construction/completion of same.
- b) To ask for details as to where the old bandstand is stored and if it is intended to bring it back into public use (the old bandstand was removed and stored at the

commencement of the port tunnel works in the park but local residents were assured it would a. be safely stored and b. put back up in the park on completion of the works.

- c) Details to the usage and management of the dressing room facilities in the park.

To ask the Chief Executive in relation to the Dog Pound, can the Chief Executive answer the following questions?:

- a) When is the contract with Ashton Pound due for renewal?

To ask the Chief Executive in relation to the "Community Benefit Clause in Construction Works Initiative" can the Chief Executive detail the following?

- a) The number of building projects where this initiative has been used in the last 5 years?
- b) The number of local people employed on each project under this initiative, detailed by job title, temporary or permanent position, qualifications attained and any other benefits accruing,

To ask the Chief Executive to detail the number of tenant purchases over the last 5 years by area and whether the property was an apartment or house?

**Q.53 COUNCILLOR CIERAN PERRY**

To ask the Chief Executive to provide a report on the Housing Insulation program, detailing the following?

- a) The number of homes insulated last year, by area
- b) The total budget last year
- c) The total budget for the current year
- d) The projected number of homes to be insulated this year, by area

**Q.54 COUNCILLOR HAZEL CHU**

To ask the Chief Executive to provide details of any inspection, monitoring or quality assurance in place in relation to homeless services, including hostels, hotels and other services provided by third parties.

**Q.55 COUNCILLOR HAZEL CHU**

To ask the Chief Executive the total number of planning applications for commercial Airbnb lettings and the number of which that were granted.

**Q.56 COUNCILLOR HAZEL CHU**

To ask the Chief Executive to set out in tabular form the duration for accessing emergency accommodation for families accommodated at the end of January and February and the same information for those families in 'own door' accommodation.

To ask the Chief Executive for a report on the roads maintenance budget for 2020 with the schedule of works, breaking down the cost of each project.

To ask the Chief Executive for a report on the 2020 roads maintenance budget for the 20% sustainable travel portion of the roads maintenance budget, as agreed at annual DCC budget meeting, detailing the cost of each project.

To ask the Chief Executive to refer to the tree that was removed from **(details supplied)** and say if/when same will be replaced.

**Q.66 COUNCILLOR DEIRDRE HENEY**

To ask the Chief Executive if he can re-instate ramps at **(details supplied)** as motorists behave as if no ramps are present due to the worn condition of same and if rumble strips could be installed outside the school.

To ask the Chief Executive to please say if he can arrange to install a no left turn at **(details supplied)**.

To ask the Chief Executive to inspect the bathroom at the home of our tenant at **(details supplied)** with a view to identifying whether there are grounds for upgrade.

To ask the Chief Executive whether the laneway at the entrance to the Warrenmount Community Education Centre on Mill Street is owned by the council and if so, what are the plans for works on the Lane way to clean it and renovate it to the same standard as the new surrounding public domain which has been improved as a result of the newly built student accommodation and hotels in the area.
