The plot of land in question is a disused laneway known as "Back of the Pipes" which follows a culvert that houses the Poddle river and stretches from Reuben Street\Dolphins Barn at one end to St. James Walk\Grand Canal Basin at the other. This laneway was closed by the Council as a public right of way in 1997. Access to this laneway is restricted and is further hindered by obstructions and walls in the laneway so that it is not possible to walk from one end of the laneway to the other. Dumping in the laneway is a historic problem and DCC has incurred considerable expense in dealing with this. It should be noted that due to the restricted access to the laneway, any rubbish present can only have originated from adjoining properties. Property Management Section will arrange to

have it cleaned once again and will request that a Litter Warden attend to examine the rubbish present in an effort to identify possible culprits and take whatever action is deemed appropriate.

There are two separate Irish Water works taking place near the Grand Canal at Devoy Rd. The first set of works on the "Pitch" at Devoy Road are part of the Irish Water Liffey Siphons Rehabilitation Contract that received planning permission ref: 3827/15 in 2015. On completion of the work the area at the pitch will be reinstated as a grassed area with 9 trees planted in the "pitch" area. The Liffey Siphons works at the Pitch are now complete. However the contractor working on the Grand Canal Project will be using this compound (see below for further details). This contractor will complete the agreed landscape works under their contract.

There is a second piece of work taking place at the Grand Canal adjacent to "the Pitch" Devoy Road site. This is the Irish Water Wastewater Rehabilitation Project at the Grand Canal. Irish Water commenced in January 2020 essential repair works on the wastewater network which collapsed along the Grand Canal. This project will repair approximately 75 metres of wastewater network that collapsed due to poor structural condition. This section of pipe crosses under the Grand Canal, the Luas line and Suir Road. The pipe is a key part of the wastewater infrastructure for Dublin and the repair works will be complex in nature. GMC Utilities Group is working on behalf of Irish Water to deliver this project. Works are expected to be completed by May 2020.

- Location (is it a residential road, a main road or city centre area etc.)
- Road Category (this determines when work is permitted to be carried out, i.e. working hours or weekends only)
- Is there an existing supply available in the area or is a new supply connection required.
- What type of supply is in the area (are the existing supplies overhead or underground)
- What type of equipment is to be installed (i.e. is standard, decorative or heritage type equipment required)

The approximate costs for four (4) no. different types of installation are provided below. These costs include for the material costs (column, bracket, luminaire, column fit-out), labour costs (electrical and civil), road opening licence, a 1m x 1m reinstatement, and traffic management.

The costs in the scenarios provided below does not include any of the costs relating to:

- 1. The amount of ducting and cabling required from the nearest existing supply point/column.
- 2. The costs associated with obtaining and installing a new supply connection if one is required.
- 3. Any reinstatements larger than 1m x 1m.

4. If the installation of a new column and luminaire is a replacement for a light that has to be removed, there are other costs associated with the removal of an existing column and light.

The ducting and cabling costs are dependent on the distance from the section pillar/nearest column.

Also, Waterways Ireland has agreed to undertake improvements to the bicycle gate adjacent to Bluebell Community and Youth Centre. This work will involve increasing the width of the gate and eliminating a pinch point where cyclists currently have to dismount.

To ask the Director of Services to please take air quality / monitoring / testing in the Chapelizod Area which is now totally gridlocked with motorised traffic. I would be very worried about the long-term damage to the health of residents living in the area as the problem gets progressively worse.

Reply

Dublin City Council currently has permanent air quality monitoring stations in Ballyfermot and the Phoenix Park, both roughly equidistant from Chapelizod. Before determining the location for new monitoring sites, it is practice to carry out a period of pre-monitoring using low cost nitrogen dioxide samplers to determine overall pollution in a given area.

Currently there is a regional study of this nature being carried out by the Bus Connects project to determine baseline air quality as part of the preparation of the Environmental Impact Assessment Report (EIAR) for that project. This commenced at the beginning of 2020 and will continue into the middle the year. As part of this study a number of these nitrogen dioxide samplers have been deployed in the general Chapelizod area, and there is one specifically located on Chapelizod Hill Road adjacent to Chapelizod Court.

Dublin City Council is cooperating with the Bus Connects project team in deploying these sensors, as well as assisting the Environmental Protection Agency in a similar study which is assessing candidate sites for further expansion of the national ambient air monitoring network. The data from both these studies will be in the public domain at that point and will be instrumental in Dublin City Council considering additional monitoring in Chapelizod and other areas of the city.
