Mary Hayes, Senior Executive Officer in DCC Housing Allocations detailed the Supreme Court Appeal Judgement between Darren Fagan, Seena Coogan, ScoutLarue Coogan and Darren Coogan AND Dublin City Council (December 2019) with regard to the DCC allocation decision & the resulting significance regarding Dublin City Council's Scheme of Lettings & Housing Assessment Payment assessment procedures.
