Twenty five former tenants have begun moving back into the refurbished St. Mary's Mansions. Fifty five families from Dublin City Council housing list are moving in and these should be in their new homes within the next few weeks. The complex will provide 1, 2, 3 and 4 bedroom new homes.

The Oaklee Development:



The construction of The Oaklee Complex on Poplar Row is complete and nomination of residents has been passed on by DCC to Oaklee. Final fix and snag-listing is underway and should be completed in October in 2020. The development will provide new homes for Senior Citizens.

O'Brien Hall:

The new locks have been installed at front and back doors throughout the blocks of O'Brien Hall to provide extra security for the residents.

Camera installation and upgrades:



Contractor have been appointed for the installation of new CCTV at Courtney Place. The system should be installed in the coming weeks to provide extra security for the residents

Bonfire Materials:



Housing staff continue to work in conjunction with Waste Management and other sections of DCC in the detection and safe removal of Bonfire Materials such as Tyres and Wooden Pallets throughout the Central Area.

Duggan Brothers are currently constructing 5-3 bed town houses, 67 apartments consisting of 5-3 bed, 50-2 bed and 12 1-bed units, a community facility and retail/commercial units with 47 car spaces at basement level on the eastern side of Dominick St. Crane 1 and Crane 2 erected. 1st floor slab decking ongoing. Information leaflets on proposed work are delivered to Residents on a monthly basis.


Ongoing monthly meeting has recommenced with Duggan Brothers, Residents & DCC Officials.

Tenants have gotten together and participated in enhancing the garden areas of the complex.

Enhancement works to the courtyards of the complex will commence on the 19th October and should be completed by the end of the month.

Parking Enforcement (Apcoa) will be re-instated 2nd November in this Complex,

Power washing of stairwells have commenced on an arranged programme residents to be notified a couple of days in advance.

Henrietta House

Residents of the complex are working closely with Estate Management & Community Section i.e. planting playground area to enhance the complex. Works still ongoing.

Hardwicke Street

Estate Management are working closely with Men's Gardening Club.

Railings have now been installed around the four triangles at Plaza area Hardwicke Street.

Sheridan Court Place

A painting programme is still ongoing within the complex.

Drumalee Estate

A clean-up programme will commence on the 5th October within this estate, this to include removal of tree stumps, Open & Close fencing (Laneways) to remove illegal dumping, weeding of footpaths and open spaces in the estate.
