- Type of materials and a rough estimate of the quantity, e.g. 10 pallets and 4 truck tyres.

• If possible a photograph of the location and materials.

We need the public's help to do this and we are calling on people to report stockpiling of bonfire material to us as soon as possible so we can remove it safely. We have received great assistance from the public in recent years and we are calling on people to assist us again in 2020.
