I am asking on foot of reports of residents living on Donore Road that cars illegally parked on other streets in the area are being moved to their streets. When they asked the clamping operatives they were told it was permissible.

Reply

The Dublin Street Parking Services remove illegally parked vehicles to a nearby safe location when they are parked in a location where they present a safety risk to other road users or pedestrians such as vehicles parked on a clearway, cycle way, block an entrance to a residence, a footpath or block a street. Also, when vehicles are parked in a location that prevents other road users from using a space legally such as in a loading bay, the Dublin Street Parking Services relocate an illegally parked vehicle to a nearby safe location and clamp the vehicle there. This practice is ongoing to ensure a safe and more free flowing use of public road space for motorists, cyclists and members of the public on foot.

To ask the Director of Services to give Councillors an update on the work done to implement the motion passed in September on school mobility plan especially the schools that will not be included to the list of DCC School Zone.

Reply

New School Outreach Officers

Between November 2020 and January 2021, two new Schools Outreach Officers were recruited internally to join the Covid Mobility Team. The role of these Officers is to work directly with schools and the school community to encourage and support active travel to school.

School Zones

In a School Zone, the overall design objective is to reduce congestion and increase safety at the front of the school, and thereby prioritise active travel to and from school. School Zone measures include colourful road markings outside the school area to alert drivers that they are in a School Zone and encourage them to reduce their speed. Pencil-shaped bollards on the footpaths will prevent illegal parking and allow more space for children to walk safely to school. It is hoped that reducing space for cars to park at the school gate will increase walking and cycling among the school community.

In late August of 2020, we contacted all primary schools in the DCC area informing them of our School Zone initiative and information on how to apply. To date, we have received applications from 103 schools and 29 have been installed. The COVID Mobility Technical Team are assessing all submissions for suitability. Schools will be contacted with timelines, if it is deemed to be an appropriate intervention at the particular location. The breakdown of the 29 School Zones completed to date by administrative area is as follows:

The next installations are due to take place in the South City are as follows:

- Our Lady of Good Counsel GNS, Knocknrea Road, Drimnagh, Dublin

- Our Lady of Good Counsel Infant School, Drimnagh, Dublin 12
- St Ultan's School, Cherry Orchard Avenue, Cherry Orchard, Dublin 10
- St Harold's Cross Primary School, Clareville Road Harold's Cross, Dublin 6

Scoil Mológa, Clareville Road, Harrold's Cross, Dublin 6

There are a further 2 on the Southside at final design stage. Subject to final consultation with school Principals and the NTA, these will be completed over the coming weeks.

There are 10 schools citywide at preliminary design stage with the NTA, 8 of which are in a 50km/h speed limit zone.

Site observation visits from technical and Schools Outreach Officers will be conducted for all schools who have applied. The current COVID restrictions and the closure of schools will mean that, in general, works will be completed on schools where the designs have already been agreed and survey work and design proposals drawn up for other locations. The interviews and observations during these visits will facilitate the co-design of supports and resource materials appropriate for each school. Schools within a proposed or completed School Zone location will be encouraged to work collaboratively with the community to gain the best possible outcome from the School Zone installation.

Cycle & Scooter Parking for Schools

The City Council has been granted funding from the NTA to deliver cycle and scooter parking to schools and sports clubs in the DCC administrative area. This round of applications is open until 15 February, 2021. We have received applications from 13 schools to date. Applications can be made online Consultation Hub.

Schools Mobility Online resources

We have a dedicated <u>School Mobility page</u> on the DCC website providing information on our programme with links to School Zone and Cycle & Scooter parking applications. In addition, the page provides useful guides and links to behaviour change resources and interventions. We will continue to develop this page as our programme develops.

Walking and Cycle Buses and Park & Strides

We have engaged and supported a number of these parent-led initiatives.

Green-Schools Walkability & Cycleability Audits

We liaise with various departments within DCC to implement the actions requested through Green-Schools walkability and cycleability audits.

School Cycle Training

We provide funding to primary schools for the delivery of cycle-right training.

New Walking & Cycling Action Plan

- To increase the number and diversity of people walking and cycling in Dublin City;

Q14 Councillor Vincent Jackson

To ask the Director of Services to request that DCC please look into the following *(details supplied)* and can we please ensure that in future before any changes are made of a major nature, discussions take place with adjoining properties / services.

Reply

A School Zone is an initiative designed to give priority to students at the school gate by freeing up footpaths and reducing vehicle drop-offs, pick-ups and idling. In a School Zone the overall design objective is to reduce congestion and increase safety at the front of school, and thereby prioritise active travel (walking and cycling) to and from school. School Zone measures include colourful road markings outside the school area to alert drivers that they are in a School Zone and encourage them to reduce their speed. Pencil-shaped bollards on the footpaths will prevent illegal parking and allow more space for children to walk safely to school. Reducing space for cars to park at the school gate supports walking and cycling among the school community whilst creating greater space for social distancing during the Covid-19 pandemic. Due to the emergency nature of the pandemic the School Zones are prioritised to be installed within a minimum period of 4 weeks from successful application by the School.

In late August of 2020, we contacted all primary schools in the DCC area informing them of our School Zone initiative and information on how to apply. Supporting information on the application page advises schools that School Zones are only suitable on local and residential roads and must have the support from the school, the parents and local residents. On their application form *(details supplied)* indicated that

they had support for the School Zone. Both the Area Engineer and the Schools Outreach Officers visited the site, spoke to the Principal and were of the understanding there was support for the School Zone.

An oversight on the final design drawing for the school indicated the pencils were to extend across the driveway of the Church. As soon as the error was raised, the placement of the bollards was rectified immediately. Both the *(details supplied)* were contacted to inform them that the issue was being addressed straight away. Subsequently, the Schools Outreach Officer spoke to the *(details supplied)* at a later date to further explain the objectives of the School Zone initiative and obtained valuable local information to support *(details supplied)* in their management of the School Zone once the schools reopen.

The next steps include liaison with the Principal and An Taisce Green-Schools Programme to roll out an awareness campaign to prepare parents for the use of the School Zone when the schools reopen. Driver behaviour around the School Zone once the schools reopen will be monitored ongoing feedback obtained from the Principal on any issues relating to the School Zone. Going forward the School Outreach Officers will engage on neighbourhood level for each School Zone installation to facilitate local supports including liaison with the Local Area Offices.

Two Schools Outreach Officers were appointed since late November 2020 to support the schools through the application process and to provide them with resources to help them inform both the school and local community about the School Zone initiative.

Dublin City Council has a policy of replacing damaged infrastructure. The School Zones do not affect the normal functioning of a road other than to act as a traffic calming measure and to prevent illegal parking on footpaths.

This would be a private matter between the householder and the site owner.

Can the Director of Services please give an update of what stages we are at with the Cherry Orchard LAP, to include when we hope to commence the various actions of the LAP, what are the anticipated costs of the said actions and our efforts to date to get European Regional Development Funds / national funding.

The Park West / Cherry Orchard LAP has a total of 86 objectives, as follows

- 11 Economic Objectives
- 12 Housing Objectives
- 16 Movement Objectives
- 17 Urban Design Objectives
- 11 Community and Social Objectives
- 4 Heritage Objectives
- 8 Green Infrastructure / Biodiversity Objectives
- 7 Infrastructure Objectives

Many of these actions are ongoing, many are dependent on funding and will be achieved through the development of the eight development and two key amenity sites, listed below: The first five sites are owned by DCC, the balance privately. A briefing for Councillors in relation to these sites is being arranged in the near future. Two structures to assist implementation are in place, an internal LAP implementation team and the interagency Cherry Orchard Development Group.

URDF:

An application for funding in the sum of €31,618,770 for various projects was made to the Urban Regeneration and Development fund in 2020, which would require match funding of €10,539,590 from the City Council. This funding is towards the implementation of key objectives of the LAP, to support the delivery of between 2,200

and 3,000 new homes, along with new employment and enterprise space, supported by new community and recreational facilities. The major elements are

- Cherry Orchard Park redesign and redevelopment (€8m)
- Gallanstown Waterworks, exploration of feasibility and design (400k)
- Strategic Greenway Design, Le Fanu Park to the Grand Canal (€300k)
- Bridge Design and Construction (over the Grand Canal, linking Le Fanu Park, Cherry Orchard Park, the Train Station, Park West and Gallanstown to the Canal Greenway) (€2.14m)
- Servicing sites 2, 4 and 5 of the LAP
- Cherry Orchard Community and Social Enterprise Hub (€2.69m)
- Public Lighting upgrade throughout LAP area (€3.173m)
- Extension of Community CCTV system (€500k
- Upgrade of wider area water supply and foul drainage network (€1.6m)

It is hoped that a decision on the URDF application will be received in the near future.

Q18 Councillor Vincent Jackson

To ask the Director of Services to request that Dublin City Council please look at repositioning the recycling banks from the Tesco Car Park to some more suitable location. I regret to say, whilst I love recycling, the bottle banks etc. attract a large amount of unwanted waste to the area. The banks themselves are in a poor state as are others in the Ballyfermot Area. Can I ask for a report on the matter on what we can do to try and sort out the problem.

Reply

Waste Management Services is committed to recycling and providing the best service we can in a busy, urban environment. However, the reality is that finding sites for new bottle banks in the city is very problematic. Publicly owned land is at a premium. The majority of Bottle Banks in the city are located on privately owned land e.g. supermarket car parks. Bottle banks are incredibly difficult to maintain and despite cleaning by our own staff and by service providers, dumping is often an issue for us – which makes them unpopular.

We are restricted to where we can place them under planning regulations (SI 600 of 2001) and our service provider needs to be able to service all sites in a safe manner. The area must be free of overhead cables and overhanging trees, must not conflict with bus or cycle lanes, and must be directly accessible by HGV.

Unfortunately, I am not in a position to remove the banks from their present location at this time, but I am happy to work with the area office to attempt to find a suitable alternative location for the banks at Tesco Ballyfermot.

Waste Management Services are currently developing a bottle-bank maintenance programme and intend to systematically re-paint all DCC stock steel bottle banks this year. We are also engaged in a programme of animation of bottle banks in highly visible locations. The programme is currently on hold due to social distancing restrictions but I would be happy to add the banks at Tesco Ballyfermot to the list.

Our Street Grading programme began in late 2019, and we saw noticeable improvements in the grades assigned to each area over the course of 2020. Bottle banks were recently added to this programme and we anticipate a similar improvement in the maintenance of recycling facilities in the coming weeks and months as a result.

We have updated settings in our SCATS Adaptive Traffic Management system and repaired a faulty pedestrian push button on site to prevent this from occurring again. Finally, please note that we are also installing a new traffic signals program to the controller on site which contains some additional functionality to further ensure that this intermittent fault does not occur again. Can the Director of Services commence an audit on suitable commercial premises to promote and encourage business owners to consider "over the shop living" in the villages of SWIC and report back to this Committee?

Reply

The Living City initiative (LCI) is a tax incentive scheme to assist and encourage owners and investors to claim tax relief for money spent on refurbishment or conversion of commercial property and residential property (owner occupied and rented residential). The scheme was revised in early 2017 to include rented residential property and the criteria used in order to qualify under the scheme were amended to encourage greater up take of the scheme. The minimum cost of works to qualify under the scheme is €5,000. While Dublin City Council administers residential and rented residential applications, applications for the commercial element of the LCI must be made directly to the Revenue Commissioners for assessment and certification.

The commercial property aspect of the LCI focuses on the regeneration of retail and commercial districts by allowing owners to claim an accelerated capital allowance on money spent on refurbishment or conversion of commercial property. The relief for commercial properties is available over a 7 year period (15% per annum for 6 years & 10% in year 7) and is applied for directly through the Revenue Commissioners. In order to qualify under the scheme, the property must be within the designated 'Special Regeneration Area'. A map outlining the exact area is available on the DCC website at https://mapzone.dublincity.ie/MapZoneLCI/MapZone.aspx?map=LCI

The Living City Initiative unit in DCC is ready to assist owners unlock the potential of derelict or underutilised older buildings. The Unit will engage with the Area Manager to identify suitable properties and try to contact the owners to promote the Living City Initiative. Following the announcement that the closing date for the scheme has been extended to the end of 2022, the LCI team launched another advertising campaign.

This campaign was targeted within the designated SRA and included Digi Screen and Bus Shelter advertising platforms (see overleaf). A Facebook advertising campaign also took place to generate a greater awareness of the scheme.

The LCI unit has set up a 'One Stop Shop' advisory team from Planning, Architects, Fire Prevention, Building control, Conservation, Valuers etc., which is available to meet and advise owners and investors on statutory planning and development requirements. This free service is available by making an appointment in advance with the LCI unit by email at livingcityinitiative@dublincity.ie

Despite continuous promotion of the LCI in Dublin City Council, the number of residential and rented residential applications submitted remains disappointing. During a presentation given by DCC's LCI Advisory Team to the Irish Property Owners Association (mid-2019) a comments sheet was circulated and the information gathered was included in a report. This report identified that a grant based incentive, rather than a tax relief based incentive, similar to that in Amsterdam may result in a greater volume of interest. The Amsterdam incentive (2015/2016) offered a grant of up to €25,000 to store owners to convert unused space on their premises to homes. This resulted in the occupation of 850 apartments, many of them on upper floors above shops.

The adaptation of this scheme to the LCI initiative, along with extending the deadline for receipt of applications could be explored further. The Development Department in the process of reviewing the Living City Initiative and will make recommendations to the Revenue Commissioners to improve awareness, incentivise take up and increase the number of applications.

As previously reported to the March City Council meeting the process of putting in place a contract to satisfy procurement requirements initially delayed the programme of providing free sanitary products. A trial programme was in place up to February 2020 in a limited number of Sports and Recreation buildings. From March 2020 when the procurement process was resolved, a contract was entered into with Bunzl to supply products as required. The products were ordered and due for delivery just as the Covid − 19 restrictions were introduced and the suppliers resources went into transporting urgent goods for the HSE. However, a supply of the sanitary products were received in August and are available in those Sports and Recreation centres which are open. However, as Covid 19 restrictions introduced in March 2020 have had a significant impact on the numbers assessing these buildings no meaningful analysis or report can be provided at this time in relation to uptake. The initial costs to the Sports and Recreation Section is approximately €9,000 to date.
