#### Reply

Planning guidelines may be issued by the Minister for Housing under Section 28 of the Planning and Development Act 2000 (as amended). Planning authorities and An Bord Pleanála are required to have regard to the guidelines and are also required to apply any specific planning policy requirements (SPPRs) contained in the guidelines, within the meaning of Section 28 (1C) of the Planning and

Development Act 2000 (as amended) in carrying out their functions.

SPPR3 contained in the Urban Development and Building Heights Guidelines for Planning Authorities (2018) states that "It is a specific planning policy requirement that where; (A)1. an applicant for planning permission sets out how a development proposal complies with the criteria above (*outlined in the guidelines*); and 2. the assessment of the planning authority concurs, taking account of the wider strategic and national policy parameters set out in the National Planning Framework and these guidelines; then the planning authority may approve such development, even where specific objectives of the relevant development plan or local area plan may indicate otherwise".

Accordingly, it is not considered necessary to seek legal advice relating to the ability of the Planning Department to recommend that permission be granted for appropriate development that may exceed development plan height parameters on the basis that SPPR3 outlined the Urban Development and Building Heights Guidelines for Planning Authorities (2018) takes precedence over any conflicting, policies and objectives of development plans and local area plans.

#### Reply

However, in accordance with Section 34 of the same Act, the determination of a planning application is a function of the Chief Executive.

The purpose of presenting planning applications at an area committee meeting is to keep elected members informed of the implementation of development plan provisions and to enable them to respond to queries from members of the public. However, any comments made at area committee meetings do not form part of the deliberation process and cannot be taken into account in determining planning applications.

An elected member can make a written submission to support or object to a planning application within the statutory 5 week time limit which will be taken into consideration when determining a planning application.

The North Central Area Committee recognises the imperative of providing additional social housing needs across our area. The North Central Area Committee also recognises the important role Approved Housing Bodies play in supporting Dublin City Council in such provision. However, the North Central Area Committee also recognises the crucial role of local community consultation and liaison in the planning processes of any new housing development.

Therefore, the North Central Area Committee demands that ahead of the submission of a planning application for Millwood Court that the following aspects be agreed with the local community:

- a) a construction traffic management plan
- b) a demolition plan that takes cognisance of the incidences of COPD among residents in the immediate vicinity
- c) demolition and construction working hours

#### Reply

As part of the planning application process, a condition would pertain for a detailed construction and demolition management plan to be submitted on appointment of a contractor. This plan would include details such as intended demolition and construction practice for the development, construction phasing and programme, a detailed traffic management plan, hours of working, noise and dust management measures, and off-site disposal of construction/demolition waste. The appointed contractor liaises with DCC Road Works Control Section during the demolition and construction period.

A preliminary Construction and Demolition Management Plan may be submitted as part of the application process to provide an overview of the anticipated phasing programme and traffic management plan; however this cannot be finalised until a main contractor has been appointed to the development and any site specific requirements associated with said contractor can be agreed as part of an ongoing process with the Roadworks Control Section.

The working hours for construction and demolition are set out as standard in conditions attached to a planning permission. Any deviation from these working hours are subject to the approval of the Planning Department.

In addition any contractor who may be engaged to work on this development will be required to comply with H & S obligations and good practice. All of these elements will be directed and overseen by an appointed Project Supervisor who will co-ordinate all matters regarding safety and health including identifying hazards. This will include but will not be limited to dust control and damping down during the demolition stage.

FOLD will consult with the local community on the above mattes if planning permission is granted for the development, and a representative will be appointed to liaise directly with the local community on all matters relating to the construction and build of the development.


The voluntary 30kph trial would only take place if approval is given by Dublin City Council that the impending DCC Special Speed Bye-Laws are sent for statutory public consultation"

#### Reply

The 2004 Road Traffic Act provides the legislative basis for speed limits generally, providing for the application of default speed limits in respect of various road types. There is no provision in legislation to allow us to have a trial for the 30 kph speed limit as set out in this motion.

The Default speed limits can only be changed by making Special Speed Limit bye-laws. The power to do so is vested in the Elected Members of Local Authorities. The primary purpose of any such intervention should be to better match the maximum speed allowed to the road conditions, and to improve road safety.

To introduce the changed by making Special Speed Limit bye-laws local authorities most follow the following procedure setting in the Guidelines For Setting and Managing Speed Limits In Ireland (https://www.tipperarvcoco.ie/sites/default/files/Publications/Guide%20Speed%20Limits%20Ma Please see following diagram process:



Currently the Road Safety Section is working on the proposal for Dublin City Council Special Speed Limit bye-Laws April 2021. After the Non Statuary Public Consultation we are expecting to produce our final version of the proposal and we are aiming to report the outcome of the non-statutory public consultation at the next Transportation SPC meeting.

### Q.1 Question in the name of Councillor Larry O'Toole

"To ask the Manager to make provision to have safety rails erected on the street side inside the railings at the three pedestrian exits from Maypark, Donnycarney. Explanatory photographs & diagrams attached"

#### Reply:

It is not possible to install a pedestrian barrier at the side of 1 May Park, Malahide Road as there are utility covers on the footpath at this location which would prevent this. The parks section may be able to install a gate inside the park similar to the one on Killester Avenue.

The entrance at Clanree Road appears to be a vehicular entrance which is used for maintenance. As such it would not be possible to install a pedestrian barrier at this location.

It may be possible to install a pedestrian barrier at the entrance opposite Elm Mount Road. Road Maintenance Services will add this to our works list. This will be completed when a works crew is available in the area.

The large yellow sand bags positioned though-out the Clontarf promenade are required to be in position all year round, and therefore immediately available in adverse weather conditions as a temporary flood prevention measure. Flood prevention in this case includes the protection of properties and transport routes/road network.

Notwithstanding the prohibitive cost, it would be totally impractical if not impossible from a Dublin City Council drainage maintenance (DCC DM) operational perspective to store such a large number of large yellow sand bags elsewhere and reinstate in advance of forecasted adverse weather conditions, sometimes at quite short notice.

Note all the large yellow sand bags were replaced in Autumn 2019 by DCC drainage maintenance, and their condition is monitored on a continual basis.

The Neighbourhood Transport Scheme Process involves assessing and ranking residential areas in keeping with the formalised process as agreed at the Nov 2018 SPC. This involves assessing the areas against a number of set criteria (e.g. level of cut-through traffic at peak times) to determine the order of implementation for a Neighbourhood Transport Scheme. However, due to ongoing developments in the spread of Covid-19, it has been difficult to complete the assessment of these areas until travel / commuter patterns return to normal following the lifting of Covid-19 restrictions.

As restrictions ease, the recommencement of the NTS Programme is to be prioritised and the area selected for an NTS Scheme will be progressed further in the coming weeks. #### Reply:

Dublin City Council aims to provide citizens with a comprehensive waste infrastructure that will enable them to dispose of and recycle their waste in a responsible manner. However, the reality is that finding sites for bottle banks in the city is very problematic. Publicly owned land is at a premium. The majority of Bottle Banks in the city are located on privately owned land such as supermarket car parks or sports grounds.

Bottle banks are incredibly difficult to maintain and despite cleaning by our own staff and by service providers, dumping is often an issue for us – which makes them unpopular with those who live in close proximity. We are restricted as to where we can place them under planning regulations and the area must be free of overhead cables and overhanging trees, must not conflict with cycle or bus lanes and must be directly accessible by HGV to ensure safe access for service provider Glassco.

Glass-recycling facilities are currently available on Main Street, Clongriffin at Trinity Sports. I recently investigated the area for suitable locations for additional bottle banks but unfortunately due to its high density residential nature I was unsuccessful.

Other nearby glass recycling facilities are located at Donaghmede Shopping Centre and Tesco Clare Hall. A wider range of items can be recycled at Oscar Traynor Road Bring Centre.

Design work on the library and public domain has been completed and it is our intention to proceed in partnership with the North Central Area Office to improve accessibility for the library and the surrounding footpaths.

#### **RAHENY LIBRARY**

With grant aid funding through Dept. of Rural & Community Development we will replace original single glazed windows with new double-glazed units. The objective is to put in place materials that will achieve a level of performance that is in excess of the required standard of the most recent update of Part L of the Building Regulations. The objective for the replacement of these windows is to achieve a U-value of 1.4 W/m²k.

This will significantly increase comfort levels for library staff and users, while reducing heat loss and energy consumption. Similar works at Ballymun Library saw the value of Gas bills fall from €7,500 in 2018 to €6,000 in 2019 and an estimated €5,500 in 2020. Natural ventilation will also be improved (conditions permitting) through increased opening size.

We intend to replace the suspended ceiling, floor covering and shelving later in the year.
