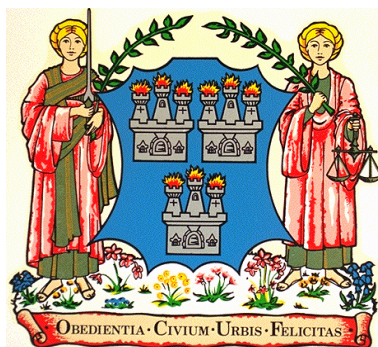

The Lord Mayor opened the Meeting and invited the City Planner to outline the process. The City Planner advised that this stage of the Development Plan process is to give strategic direction to the executive in drawing up the Draft Development Plan in line with planning legislation. Recommended strategic policies for each theme are set out in the CE Report 133/2021 and on foot of which councillors submitted 1047 motions. The response to these motions are in CE Report 134/2021. All motions agreed at this meeting will be incorporated into the Draft Plan while at the same time ensuring it's not repetitive and that it is internally consistent and userfriendly. The matrix of motions will be used to manage the meeting. There will be further opportunities to submit motions at the Draft and amended Draft stage. The meeting administrator outlined the procedure for dealing with the motions in order to make best use of the meeting time.

The meeting administrator highlighted the councillors' responsibilities under the Code of Conduct in particular sections 4, 5 and 6 which deals respectively with conflict of public and private interest, councillors and the planning process and lobbying by third parties. Councillors must indicate to the meeting administrator if they or a connected person has a conflict of interest to any motion on the agenda so that the conflict and motion number be declared, minuted and the councillor withdraws from the meeting until the item is dealt with.

Cllr Danny Byrne declared as he is a property consultant he has taken the decision not to engage with the Development Plan process and he removed himself from the meeting.

The meeting progressed over three nights and the matrix was used to facilitate this with members issuing their directions to the executive.

Finally it was proposed by the Lord Mayor and seconded by the Deputy Lord Mayor that taking account of directions of the members of the authority in relation to the Chief Executive's Reports numbered 133/2021 and 134/2021 (including addenda) to give strategic direction to the executive in drawing up the Draft Development Plan it is hereby recommended that Report No. 133/2021 is adopted and Report No. 134/2021 is adopted as amended.

A full list of all decisions on the motions is detailed in Appendix A attached. The meeting concluded at 8.30pm on 24<sup>th</sup> June 2021 when all the business on the Agenda was completed.
