In particular, could DCC confirm that the online reporting services for litter issues is working? Residents report that this was not working in late August and so pallets in the area remained in place and were subsequently lit on fire in All Saints Park (25th August)"

As much of an eyesore as it is, its also a danger to elderly pedestrians as it is at a different level to the remaining path.

Can the Area Manager please organise some intervention to repair the damage, blend the pathway back to its former glory and ensure that the contractors do not take any more shortcuts"
