# The European Programme Support Office

Dublin City Council's European Programme Support Office (EPSO) for the organisation continues to develop and implement the EU Programme Participation Strategy 2021 – 2027 for the organisation.

Developments for Q4 2021 have included, but not limited to:

- Analysing & Showcasing Dublin City Council involvement in European projects and Programmes
- Developing European Network Connections
- Focusing on European Funding Programme Opportunities
- Further developing the EPSO

Full details on the developments for Q4 are outlined in the sections below and overleaf.

## **Dublin City Council – European Project Involvement**

Dublin has had a successful year in Europe to date with the below achievements:

- Smart Cities Dublin currently ranked 26<sup>th</sup> Smart City in the world, up 15 places on the previous year.
- Economic Development Dublin chosen as 1 of 8 global cities to partake in OECD Social Economy peer to peer learning project
- Codema –securing €1.2 million EU funding to lead project to test & develop a project implementation unit for energy efficient & renewable projects in Dublin including €20million worth of upgrades to council buildings & sites within the region
- Dublin's 14 Henrietta Street, recently awarded the European Museum of the Year Silletto prize 2020 for local community engagement.

Dublin City Council has been successful in securing EU funding programmes for 18 projects previously.

## Successful Projects to date – Active in 2021

Under the European Territorial Cooperation (ETC) Interreg programme, URBACT, Dublin City Council is involved in a number of projects, a selection is outlined below:

URBACT - URBACT ACCESS Action Planning Network – To ensure access to culture for all citizens



**Project Aim:** Collaboration to create new policies for cultural inclusion to ensure access to culture for all citizens

**Project Overview:** The cities are collaborating in a newly established network named ACCESS, funded by URBACT, an EU programme to develop sustainable solutions to urban challenges. The aim is to bring about a real

shift in cultural policymaking in Europe and as a result ensure access to culture for all citizens.

During the initial phase of the project, which took place from September 2019 to March 2020, the ACCESS Network cities identified the important role of culture in the solutions to the complex issues facing their cities.

In January 2020, Dublin welcomed representatives from the other eight European capital cities to Richmond Barracks as part of the URBACT ACCESS Action Planning Network.

#### **URBACT Programme:**

The URBACT programme enables cities to work together and develop integrated solutions to common urban challenges, by networking, learning from one another's experiences, to improve policy and

develop solutions.

Co-financed by the European Regional Development Fund (ERDF), the 28 Member States, Norway and Switzerland, URBACT is an instruction of the Commission's Cohesion Policy and contributes to its Europe 2020 strategy.

Outside of the ETC Interreg Programmes, Dublin City Council is also involved in a number of European programme projects; a selection is outlined below:

### Smart City Connectivity – Wifi4EU Project: Connecting Communities – Connected Europe



Dublin City Council; in partnership with Virgin Media Ireland are delivering the Dublin WiFi4EU programme. The project involves deploying Wi-Fi while also promoting digital literacy via dedicated educational and engagement events throughout the course of a 3 year partnership.

Dublin's WiFi4EU programme is connecting communities and families across the city with over 30 locations connected, including the Cabbage Garden Interagency Project in Dublin City Centre.

Wi-Fi plays a significant role in cities and communities around the world by driving exciting and innovative projects to 'connect the unconnected'.

While Dublin households have the highest levels of fixed internet access in Ireland with over 92% of households connected, according to the CSO, there are still a number of areas and communities across Dublin who do not have the quality of connectivity required to achieve their true potential.

Dublin's Smart City Programme are partnering with Virgin Media Business to deliver reliable and fast public Wi-Fi services to communities that need it most. We want to support connectivity with a particular emphasis on strengthening community engagement and supporting wider digital innovation initiatives.

The partnership will drive new opportunities in areas such as the future of connectivity, digital innovation and engagement and best in class experiences. WiFi4EU aims to connect communities across the city and is funded by the European Union and Department of Rural and Community Development. It is part of a  $\epsilon_{120}$  million European-wide plan to boost Wi-Fi connectivity in public spaces and places.

The locations of the new Dublin City WiFi4EU zones include: training and community centres such as sports centres, homeless shelters, galleries, libraries, community gardens, parks, tea rooms and urban villages and other centres of public life.

#### Arts & Culture: Connecting School training & development to Europe



#### **Erasmus** + Looking to Understand Inclusion – Current - Social Europe

**Project Overview** Looking to Understand Inclusion project evolved from the success of the previous project Permission to Wonder. Five of the six partner countries remained to

continue on the new project. This Strategic Partnership focuses on schools, with Erasmus+ Social Inclusion as its main theme. Looking to Understand responds to the research findings and needs of partners and educators involved in Erasmus+ Permission to Wonder, which tested the Visual Thinking Strategies training pathways with educators across different educational settings, classrooms and museums and supported educators to train in the VTS methodology. The current project focuses on how the VTS facilitator can support social inclusion. The type of questions the project will address during the training activities are: What does social inclusion mean? What does social inclusion look like between an educator and their students? How do we address the challenges of implicit bias, such as institutional power in schools and museums and deal with historic patterns of marginalisation? The project will test how image selection in a VTS discussion can be used as a tool to practice social inclusion. The theme of social Inclusion will be examined via a range of visual sources that includes regional and international museum collections, along with different school curricula across the various countries as well as publicly available media

### Successful Projects to date – Active pre 2021

### SENATOR - Smart Network Operator Platform enabling Shared, Integrated and more Sustainable Urban Freight Logistics – Greener, carbon free Europe

#### **Project Overview:**

Project plans to develop an online platform which will manage and optimise freight collections and deliveries in Dublin and Zaragoza. The platform is for use by all delivery companies however core project partners and initial participants are national carriers An Post and Correos.

Consignments of deliveries will arrive into a consolidation centre (warehouse) to be transferred into smaller batches for sustainable transport mode delivery (EV, cycle, walker), delivery routes will be optimised via the SENATOR platform.

**Dublin City Council Project Role:** City as a testbed –From a local authority perspective introducing more sustainable delivery options will help to reduce carbon emissions and traffic congestion within the city centre. DCC are responsible for parking and city bye-laws which connected to deliveries, loading bays etc.

**Project Partners:** The city of Zaragoza, Correos, Deusto University (Spain).

- Project Duration: 4 years 2020-2024
- Total funding: €4 million, DCC funding: €239,000
- 11 member consortium including DCC, UCD, An Post (Ireland) and 5 further technical, communications and commercial partners.



iScape - the control of air quality and carbon emissions in European cities - Greener, carbon free Europe



#### **Project Overview:**

The iSCAPE project was European research and innovation project active from September 2016 to December 2019 that worked on integrating and advancing the **control of air quality and carbon emissions in European cities** in the context of climate change through the development of sustainable and passive air pollution remediation strategies, policy interventions and behavioural change initiatives.

Erasmus + Permission to Wonder – Project Completed - Smarter Europe

**Project Overview** The Permission to Wonder project was to train educators across 6 x European countries in the teaching methodology known as Visual Thinking

Strategy. Visual Thinking Strategies (VTS) is a research-based teaching methodology based on the work of cognitive psychologist, Abigail Housen and veteran museum educator Philip Yenawine that supports learner-centred thinking and feeling when looking at art objects. For this project the main target group and direct beneficiaries were educators in schools. In total 26 x Educators from 4 x schools in each country took part in the training.

The 5 x main objectives of the project were:

1 To develop a 'training of trainers' delivery mechanism in Europe to train and support educators in the VTS method. Educators taken part were primary school teachers, secondary art teachers, as well as museum facilitators/educators.

**2** To offer schools & cultural institutions opportunity to introduce the VTS method into their classroom and museum/gallery setting.

**3** To increase the use of art museums as settings for VTS teaching of visual arts

**4** To capture and share the impact of the training of educators and the pathways for using the VTS method in schools by developing one research framework across all partner countries

**5** To produce an image bank relevant to VTS compiled from European collections and artists' practice

## **Dublin City Council – European Networks**

### Lord Mayor European Network

#### **Barcelona City Council**

A meeting was held between Lord Mayor Alison Gilliland and Deputy Mayor Laia Bonet, Barcelona City Council and exchange of mutual interests and priorities at European level was discussed. It has been agreed that both parties will meet again at EUROCITIES conference and discuss how to strengthen collaboration between our two cities.

#### Embassy of the Republic of Poland

A meeting was held between International Relations, City Arts Officer and the Polish Cultural Affairs and Media and Media Coordinator to discuss further potential projects of common interest we could collaborate on in the future in order to promote the ties between the Polish community and the Irish people. Over the last 15 years, more than 100 thousand Polish people have been welcomed into Ireland and during that time have contributed significantly to the prosperity and cultural diversity of the country.

### **EuroCities**

### General Secretary, EUROCITIES:

A meeting was held between Lord Mayor Alison Gilland and Secretary General Eurocities Anna Lisa Boni. Discussed the priorities of the Lord Mayor's mandate such as housing and the sustainable post-Covid recovery. Information was exchanged in relation to Barcelona leading on a group of member cities interested in discussing the impact of the Covid crisis on city centres and as a first result of that reflection, a report has been published which was shared with Dublin.

The Secretary General also directly invited Lord Mayor Gilliland to be a panellist at the EUROCITIES Annual Conference to speak on the Panel debate on "**Socially Equitable and Just Cities**". Debate to focus discussion on key areas:

- Combining the digital and green transformation with a strong vision for a socially inclusive society
- protecting and supporting vulnerable groups in regards to the energy transition and affordable quality housing
- Changing our way of life to reduce our ecological footprint and making it affordable for all

### EUROCITIES General Assembly 2021:

Lord Mayor Gilliland attended the Annual Conference on  $3^{rd} - 5^{th}$  November and spoke on a Panel debate on **Socially Equitable and Just Cities**, a discussion with Mayors, experts, different institutions and audience. The debate will focus on key areas:

- Combining the digital and green transformation with a strong vision for a socially inclusive society
- protecting and supporting vulnerable groups in regards to the energy transition and affordable quality housing
- Changing our way of life to reduce our ecological footprint and making it affordable for all

### Climate Emergency City Strategies Workshop

The Lord Mayor will also present at a Workshop on **Climate Emergency City Strategies**, which will focus on Dublin City's Climate Change Action Plan, the public consultation process informing it, its targets, themes and actions. It will highlighted how Dublin use smart technologies to support finding co-created solutions to real life climate challenges and how Covid enabled the City Council to accelerate active mobility measures across the city.

### **European Chief Executive Network:**

### **Chief Executive Directors Meeting:**

Dublin was one of 17 cities who participated in an online meeting, hosted by Vienna City Council. Presentations were made on the topics **COVID situation in the Cities** (Lisbon) and **Climate Neutrality** (Madrid), which were followed by Q & A on the biggest challenges / solutions experienced by cities.

### **European Webinars & Seminars:**

### Communicating Europe Webinar – "A Duologue for Strength and Resilience"

The Irish Regions European Office (IREO) and Eastern and Midlands Regional Assembly (EMRA) will host an online seminar on Communicating Europe – "A Duologue for Strength and Resilience". Presentation on how European Territorial Cooperation (ETC) programmes can benefit local communities and on the other hand, how local communities can participate in a duologue with the EU. European Movement Ireland also provide information on tools for citizens' engagement in the Conference on the Future of Europe and the Wheel will talk about the opportunities for local government to work with civic society. They will be joined by a host of local Councillors and MEP's to debate how citizens can engage with the EU. Louth County Council and Dublin City Council present their involvement in European Territorial Cooperation programmes, providing a great opportunity for learning about how EU funding helps develop local communities, as well as supporting the achievement of local strategies. The seminar was funded by the Communicating Europe Initiative, managed by the Department of Foreign Affairs and Trade, aimed at deepening public awareness of the role the EU plays in our daily lives and at improving the quality and accessibility of public information on European issues, particularly at regional or national level. Invitations were issued to all Dublin City Councillors to attend the seminar.
