**Public Domain/Environmental Services Unit Report**

**Litter Hotline/CRM**

In the period 1<sup>st</sup> December – 23<sup>rd</sup> December 2021, 167 incidents were reported via Litter Hotline/CRM for the Central Area.

In addition to the CRM incidents, the Public Domain crew carry out inspections of their assigned routes on a daily basis. They will collect any dumped bags/materials which is not reflected on the above figures.

The total tonnage of collected illegally dumped items by our 5 outdoor staff members was:

- **32 tonne** for 1<sup>st</sup> – 24<sup>th</sup> December.

For reference, the average tonnage rests in or around 39-40 tonne most months.

**Community Clean-ups**

Community Clean up equipment was distributed to 13 Community Groups / individuals throughout the month of December. Requests for the removal of bags from community clean ups were looked after by Waste Management and Public Domain staff.
