South West Inner City Area Report

Review of the Year – despite the difficulties of the past year with the lockdown, the challenge of city recovery, limited personnel and the difficulties engaging contractors, the Area Office can look to the successful delivery of a wide range of improvements and projects across SWIC. These include:

- The commencement of a major public realm scheme on Francis Street and the completion of design work for Meath Street with the expectation to lodge a Part VIII application in spring 2022.
- Completion of improvements to existing parks and green spaces such as St Catherine's Park, Oscar Square, Turvey Park and St James's Linear Park at Fatima.
- Public realm improvements at James Street, Bridgefoot Street, The Coombe and Pimlico and Reuben Street/Haroldville Avenue and Basin Street.
- Conservation-led projects at St Catherine's Park, Francis Street and City Walls.
- Over 30 projects supported under the Shopfront Improvement Scheme 2021
- Launch of Smart D8, supporting a number of community wellbeing and placemaking initiatives like Bee8 and ShareIT sustainable food growing network
- Rollout of Culture Date with Dublin 8 initiatives to support recovery of the tourism sector in Dublin 8

The focus for the first months of 2022 includes:

- Opening of Bridgefoot Street Park and completion of other area improvements such as paving and lighting (January)
- Development of a proposal for tree planting and raingardens between Donovan Lane and Clanbrassil Terrace in Blackpitts with tendering in spring 2022
- Progress of interim public realm improvements at Dolphin's Barn/ SCR and to the front of Coombe Hospital on Cork Street
- Progress additional street tree planting at Reuben Street/ Haroldville Avenue and St Anthony's Road and Carman's Hall.

Weeding was carried out environs St Anthonys Road. CIE Works Estate. New Ireland Road Rialto. All the City Neighbourhood Certificates and vouchers have been presented to Groups and individuals in the SCA and photos will be on Facebook this month. Clean Slate Social Enterprise is supported by DCC and is currently working on litter picking and scrub clearance at Brandon Terrace, Ashgrove steps The Coombe, Coombe Court.

Kilmainham Mill:

Springvale Site

All residential blocks are now well advanced. The current overall revised date for completion is set for April 2022, a factor of up to a 10 week delay may occur due to ongoing Covid delays of suppliers etc.

Cornamona Site

Block A External envelope is complete including windows and roof Steel framed structure to balconies is complete Insulated render is projected to be completed to walkways shortly. Flooring to walkways is to be completed shortly.

Generally on programme (rev 9a) for Blocks A & B but block C is in delay (approx.10 weeks)

Lissadel Masionettes

A Contractor is onsite refitting the remaining empty Units and most should be ready in the next few weeks

One of the units has completed and is under offer.

Dublin City Council have met onsite with a CCTV contractor regarding the possibility of installing CCTV and have received a costing from the contractor.

The recent reports from rat infestation is likely stemming from household waste being dumped in the surrounds and not internal damages.

Crumlin Road/Rafters Lane

Part VIII approval given for the proposed demolition of the former Scoil Eanna and Funeral Home on lands bounded by Crumlin Road, Rafter's Road and Rafter's Lane, Crumlin, Dublin 12.

The redevelopment of the site will be the subject of a separate Part VIII Planning application.

In response to queries at Novembers SCAC meeting the Area Team will make themselves present at the next meeting regards above.

Bluebell

Dublin City Council received stage 1 approval for the first phase of the development. The Area Team are in regular contact with all those representing Bluebell.

A survey of the Bin Chambers in La Touche Court, Bernard Curtis House and Court with intention of providing Brown and Green bins service to the tenants of each complex.

The chambers may have to be replaced or upgraded depending on the storage capacity of existing chambers.

Cherry Orchard

The area team are monitoring all developments in the area and appreciate the frustrations with local residents whom we have met recently regards ongoing queries.

Sons of Devine Providence.

Paul Heffernan has been assigned to this Project. Dublin City Council are waiting for stage 1 approval.

Senior Citizen Complexes

A survey of bin chambers have taken place in the Complexes, with the intention of providing a green and brown bin service to all tenants in the complex Some of the complexes may require an upgrade of the bin chamber or have new Bin Chambers installed

Public Domain

Graffiti has been removed from Environs St Agnes Church Crumlin, Sommerville & Bunting Road Area, Tyrconnell Road and along the canal, St Johns College Kylemore Rd. Public Domain Deep clean was carried out at: Rafters Avenue, Lane & Road, Lissadel Road. Weeding was carried out at Nash St Oblate Drive, Ring Street, O'Donoghue Street, Jamestown Road environs, Sarsfield Road. Tree Planting will take place in Cherry Orchard Green over the coming weeks to continue on from the ADI of 2020. Wildflowers seeds will be sown along the BERM. The overgrowth along Chapelizod Bypass and Chapelizod Hill Road has been scheduled for treatment and will be completed before end of the month.

Community Development Report

Community Christmas Trees

The Council has installed trees and light displays throughout the South Central Area. We had also supported local groups to install lights on their trees and lamppost outside their houses. Each senior citizen complex will get a Christmas tree placed in the middle of the grounds.

Croftwood Green Residents Association have been prolific throughout the year with street clean-ups and seasonal events for the local children. The Community Development team supported the Christmas event on Friday 26th November. Festivities included Santa, lighting of the Christmas tree, music, a raffle with spot prizes.

The Ring Street Youth Group are back in their premises and are going from strength to strength. The group has organised a Christmas tree outside the Communicate Youth Centre beside their new diversity mural. The tree will be lit on Friday the 3rd of December at 7pm.

The Council has installed a Christmas light display at Walkinstown Library to acknowledge all the clean-ups carried out throughout the year by a revived Walkinstown Resident Association supported by St James Gaels Junior GAA team and a new group called "The Make Walkinstown Great Project". The Council has supporting the groups with Clean up Packs and bag collections.



Dublin Winter Lights

The City Council is excited to announce the return of the spectacular 'Dublin Winter Lights'. The lights were switched on last month and will remain on until January. This year photos of 76 people who work voluntarily in their local community will be rotated on the sails in Smithfield as part of the programme. Community Development Grants 2021

Payment of the 2021 Community Development and Informal Adult Education Grants for the Ballyfermot/ Drimnagh Area is now completed.

The Council has supported the local meals on wheels groups with their Christmas hampers and other seasonal projects. The Mother McAuley Centre in Drimnagh and Saint John Bosco Youth Club will pack and delivery 200 Christmas hampers to the local residents this Christmas.

Environmental Projects

16 large blue planter boxes were installed at the Walkinstown roundabout to deter illegal parking and to improve the aesthetics of the area. The Planters are being maintained by volunteers and local environmental groups.

The Bluebell and Chapelizod allotments have formed strong committees this year and had a very productive harvest. The council has supported the groups with skips, clean-ups of the communal areas and funding to enhance the facility.

Inclusion and Integration

As part of Mental Health Awareness and Inclusion and Integration Week a brochure was produced by the Community Development team with basic mental health tips, useful contact numbers and websites, details of meals on wheels, libraries and sports facilities and a word search. The brochure is being delivered to the sheltered housing complexes throughout November/December by the housing liaison staff.
