I wish to reply to your correspondence of 6<sup>th</sup> December in relation to the National Development Plan (NDP) 2021-2030. It is important to note that the Department of Public Expenditure and Reform sets the overall strategy and budget allocations for the NDP, and so it is a matter for individual Ministers and Departments to bring forward projects for approval and implementation.

It is possible to get a breakdown of all larger projects and programmes over €20 million through the Project Ireland 2040 tracker, where it is possible to separate by Department, County and Region, amongst other filters (link: <a href="https://assets.gov.ie/200464/3cceb69e-3275-4031-8b0a-36a39d69004f.xlsm">https://assets.gov.ie/200464/3cceb69e-3275-4031-8b0a-36a39d69004f.xlsm</a>).
