Report to the Finance Strategic Policy Committee

Dublin and the National Development Plan

Background

The recently published National Development Plan (NDP) 2021-2030 is a key element of the broader Project Ireland 2040. The scale of opportunity through the NDP for communities to benefit from is huge involving an investment of €165bn. At a previous meeting of Dublin City Council's Finance Strategic Policy Committee the potential economic, social and community benefit that could accrue to Dublin via the NDP was acknowledged.

It was agreed that information would be sought on NDP funding which may impact on Dublin and a letter was issued to Minister Michael McGrath TD on 6th December in this regard. A response to that correspondence was received on 11th January. Both items are included in the agenda pack under correspondence for review by SPC members.

Information provided

The correspondence from the Minister contained a link to an NDP database with details by project (i.e. specific issue/ proposal, typically relating to a single event or location) and by programme (i.e. broad issue / proposal, typically relating to a range of events or locations). The database has been analysed to extract information relevant to both Dublin City and Dublin more generally. This has occurred in a very short time frame given when the reply was received and the issue date for the SPC agenda pack.
