The trampoline was not broken as such but the independent safety assessor would not certify the modifications made by the manufacturer since it was previously installed in another playground. This matter has now been resolved between the manufacturer, the installer and the inspector.

The scheme of 12 homes on the site at **(details supplied)** received Part 8 Permission in 2021, and the Tender documents and final cost plans have now been completed.

A preliminary stage 3 submission is to be sent to the DHLGH WB 21<sup>st</sup> February 2022 for review by their technical team prior to the submission of the formal stage 3 application (Stage 3 approval from the DHLGH is required prior to the commencement of stage 2 of the tender process).

Stage 1 of the tender process is near complete, and the stage 2 tender documents are also ready to issue to shortlisted bidders. Upon receipt of the formal approval from the DHLGH the scheme will be issued to tenderers immediately for their stage 2 pricing and tender submittal. Following receipt of valid/acceptable tenders and post tender approval from the DHLGH, it is expected that the scheme will commence on site later this year (2022).

The Traffic Sign Manual explains that speed markings may be used where a speed limit changes, or in conjunction with upright repeater signs. It should only be used in situations where it is necessary to reinforce the upright signing for reasons of safety, such as the entrance to a village or where an unexpected reduction in speed limit occurs.

In the case of Skellys Lane, Kilmore Road and Beaumont Road the speed limit is 50 km/h, all the appropriate signs are in place and due to there are no changes on the speed limit on the roads it is not recommended to introduce speed roundels of 50 km/h at this time.

The North Central Area Office did however request a title search of this laneway be carried out by our Law Department. The following are the findings from the research carried out:

This laneway is registered in the land Registry as plan 116 on freehold folio DN5819.

The Registered freehold owner as registered on the 9<sup>th</sup> December 1953 is shown as Egan Estates Limited (Estate Development Co.) of 39 Westmoreland Street, Dublin.

Searches of the Companies Registration Office show Egan Estates to be a registered company with a registered address shown as 1 Clare Street Dublin.

This company was dissolved on the 06/11/1990.

Once a Company has been dissolved the assets of a dissolved company become State Property c/o The Office of Public Works, Property Management Services, Head Office, Jonathan Swift Street, Trim, Co. Meath.

The M1 speed limit is 80 Km/h coming off and onto the slip road. The speed limit at Coolock lane is 50 km/h. and **(detail supplied)** is 60 km/h. please see below map:

During a site inspection made on the 14 February 2022 the following signage were found: on the site:

- There are two 60Km/h sign and Roundabout Warning signs at the bottom of the slip road.
- There are two 50Km/h at the top of the slip road, as you enter onto the Roundabout.
- There are also two integrated FLASHING Solar-powered LED Signs indicating "Slow Down" with Pedestrian Logos installed after the 2 x 50Km/h signs. Also, there are additional Pedestrian Crossing Warning Signs immediately before the Roundabout entrance.

There is no Reduce Speed reminder sign in the Traffic Signs Manual. Therefore, Dublin City Council does not install this type of signage.

The installation of a repeater 50 km/h sign at the lamp pole 119 is not recommended, due to The Traffic Manual in Chapter 5 explains that for 50 km/h speed limit sing a repeater sign should not normally be used. Also, A repeater 50 km/h speed limit sign it is not recommended as Dublin City Councils policy not to erect repeater signs as this will lead to a proliferation of signage throughout the city. Please note that Under the Road Traffic Act "A person shall not drive a vehicle in a public place without due care and attention".

"To ask the Area Manager In relation to the newly constructed cycleway on Griffith Avenue, can the manager, for the benefit of a local resident who had a potentially seriously dangerous encounter with a cyclist on the footpath recently, say

- a. If any survey on the usage of the cycleway has been carried out to date
- b. What percentage of cyclists are using the new cycleway and what percentage are using the footpath, like they always did, as local reports suggest school going users are carrying on as before using the footpath,
- c. If he still feels the expenditure was justified, as it seems to have annoyed residents, many of whom see it as having been a waste of scarce resources, slowed down traffic flows, created weird parking zones and provided a cycling resource which is largely ignored by school goers who were supposed to have been the main target group, and
- d. If a statement can be made on the matter."

#### Reply

- A. Cycle Counter detectors were installed in the cycle lanes on both sides of Griffith Avenue close to the Swords Road junction in October of 2021. So far in 2022 these counters have registered 9,871 trips in the cycle lanes, a daily average of 280 trips.
- B. The Cycle Counters do not register the number of cyclists using the footpaths and this information is unavailable.
- C. The expenditure on the protected cycle lanes on Griffith Avenue is very much in keeping with Dublin City Council Policy as outlined in our current Development Plan to installed protected cycle lane where feasible as a means of encouraging Active Travel.
- D. The project is still ongoing with the sections on either side of the Swords Road and between the Charlemont Estate and the Malahide Road still to be completed. Changing established behaviour is a challenging task. However it is expected that as the route is completed, especially the links up to and through the main junctions, the numbers using the cycle lanes will increase. Our Communications Team will continue to work with the local schools in encouraging this behavioural change.




Under the current Dublin City Council's Bye-Laws adopted in the January 2020, the existing speed limit at this location are as follows:

- 1. From the junction of Castle Avenue to Vernon Avenue, (details supplied) West speed limit is 30 km/h.
- 2. From the junction of Clontarf Road to Vernon Avenue, (details supplied) East speed limit is 50 km/h. This is due to this section of the road being an arterial route. At the moment, there are no plans to reduce the speed limits at this section of the road.



## Reply

As inferred from the details supplied, charging EVs is a complicated matter. Indeed, this is one of the reasons we have embarked on a strategic approach to the question of public EV charging.

Dublin City Council is aware of the transition to electric vehicles as set out in the Climate Action Plan as we prepare to respond to the needs of the citizens of the City by providing a sustainable urban mobility strategy. The Council is also aware that technology is changing rapidly and that a range of different solutions will be required to successfully address current and future mobility demand, not only in the City, but also across the wider Dublin Metropolitan Area.

This requires careful consideration and planning to ensure that the Council can play their part to facilitate the provision of a comprehensive, reliable and interoperable electric vehicle-charging infrastructure. This is so that members of the public and business community can be confident in making decisions to purchase electric vehicles and to use electric vehicles for personal, leisure and business use, for use on both short and long journeys.

In order to inform the four local authorities of the type and number of chargers required, the four Dublin Local Authorities, together with SMART Dublin and CARO, commissioned a strategic study. This will allow us examine how the four Councils can best facilitate the provision of electric vehicle-charging infrastructure across the Dublin region and the scale of investment required.

The study sets out modelled EV uptake and consequent grid capacity requirements (ESBN are looking to pilot a number of new technical innovations). It also details numbers and recommended types of chargers required together with suitable business models, capital costs (including anticipated leveraged private sector capital), and areas more suited to Charge Points and has considered the options regarding public charging for those without access to off-street charging. SEAI schemes are currently being repurposed to take account of rapidly changing technologies and the realities of the business case and electrical infrastructure costs of public charging provision.

The Dublin Local Authority Electric Vehicle Charging Strategy is now practically complete and the working group are now moving forward with the next steps of the project, which will include a procurement plan required for the roll out of the strategy in balance with the Council's wider sustainable mobility policies. However, this will be subject to resources & availability of funding from the Department of Transport.

ESBecars currently provide a map of their charger network and other private operators continue to expand their charging offerings. <a href="https://esb.ie/ecars/charge-point-map">https://esb.ie/ecars/charge-point-map</a>. However, as you point out, the necessary parking fees must also be paid if within a parking controlled area. In addition, the provision of ducting, or other items such as cables crossing footpaths, to enable on street charging is not permitted, as such usage is considered a hazard.

In addition, variations to the City Development Plan 2016-2022 introduced new objectives such that all new parking for new (or extensions to) housing, apartments and places of employment that provide car parking shall be electric charge enabled.

Dublin City Council shall work closely with the ESB and other stakeholders to increase the number of EV charge points across the city. All new (or upgraded) commercially operated car parking developments shall be required to provide a minimum of 50% of spaces with EV charging facilities.

Dublin City Council has also been in close dialogue with the Department and the SEAI regarding a proposed new scheme of grant aid for Multiple Dwelling Units designed to facilitate EV charging infrastructure.

The preparation of the new City Development Plan 2022-2028 will provide an opportunity to review the implementation of the revised objectives from the previous plan and also incorporate the relevant outcomes of the above mentioned study.

This is a pressing matter for us in the Council and indeed with our colleagues in the Dublin Metropolitan area that we may enable and facilitate the transition to more sustainable mobility.

## Reply

The traffic signals on **(details supplied)** Road and Drumnigh Road are managed by Dublin City Councils (DCCs) Sydney Coordinated Adaptive Traffic System (SCATS) which is a transportation system used to manage the timing of signal phases at traffic signals. The new junctions at **(details supplied)** Road are also being actively managed by DCC's 24 hour Traffic Control Room and any necessary changes being made.

The traffic signals, which were switched on in December 2021 at this location, are being monitored and changes made based on demand.

As with all new road or junction layouts, there was a bedding in period and the timing of signal phases has been tweaked to provide optimal traffic flow in all directions.

Following implementation of these signal timing changes, observation of the junction has indicated that traffic wait times are very much reduced and traffic movement through the junction are much improved on all approaches.

The signals and layout were designed to allow for public transport and active travel priority and therefore any future bus routes through the junction will receive public transport priority at the traffic signals.

It is not deemed necessary at this stage to consider junction layout or operation changes as the traffic signal timing changes mentioned above have much improved the operation of the junction.

The junction will continue to be monitored as traffic volumes continue to increase following relaxation of Covid19 restrictions and further amendments made as required where there is scope to do so.

## **ITS Traffic Signals reply:**

ITS have reviewed the operation of the pedestrian signals and found the signals to be operating as designed.

Pedestrians have a maximum wait time of 38 seconds depending on when the pedestrian button is pressed during the traffic signal cycle.

A 'green man' of 6 seconds is displayed (this is a standard time and is an indication that it is safe to commence crossing) followed by an 'amber man' of 11 seconds (this is an indication not to commence crossing but if you have already commenced you have sufficient time to finish crossing safely – timing is calculated using crossing width @ a walking speed of 1 metre/second.)

The above is followed by an 'all red' signal of 4 seconds whereby both traffic and pedestrian are shown a red signal for safety purposes.

In order to ensure a sustainable mix of tenure and long term sustainable communities, a minimum of 40% of standard build to sell apartments will be required in BTR developments over 100 units.

The Guidelines for Planning Authorities on "Sustainable Urban Housing: Design Standards for New Apartments", issued under Section 28 of the Planning and Development Act provides that statutory development plans may specify a mix for apartment and other housing developments, but only further to an evidence-based Housing Need and Demand Assessment (HNDA), that has been agreed on an area, county, city or metropolitan area basis and incorporated into the relevant development plan(s).

An evidence based HNDA has been incorporated into the Draft Plan and forms part of the Draft Dublin City Housing Strategy. A key policy recommendation arising from the Housing Strategy is that the Draft Development Plan include a defined mix of dwelling unit types for the City, addressing the particular challenges of the inner city, responding to the demographic changes in households and taking into account the current housing stock.

The Draft Plan is currently on display and the closing date for submissions is the 14<sup>th</sup> of February. After the closing date, all submissions received including those from the Office of the Planning Regulator and the Department of Housing, Local Government and Heritage will be reviewed and assessed. Any recommendations arising from these submissions including any relating to the draft BTR policies will be addressed in the CE Report which will be circulated to all elected members at the end of April.

This 6000 capacity UEFA category 3 stadium will provide modern state of the art facilities for playing League of Ireland football and accommodate the four senior teams from Shelbourne FC and Bohemian FC as well as provide the public with a number of facilities including a new modern library, community rooms, and new public plaza. In order to contribute towards the funding of the new stadium, an option would be that the northern half of Tolka Park be disposed for residential Redevelopment. This could take the form of a sale to an Approved Housing Body for public housing if agreed by City Council as the approval of City Council is required for the disposal of Council lands. The southern half of the site could then be redeveloped to include public amenities, which would include a Multi-Use Games Amenity pitch (MUGA) which will be made available to local clubs and the wider community. Another objective for the site is to provide a cycle way route through the site and over the Tolka River to connect with the lands to the South providing much needed cycling infrastructure to the area.

However, it is acknowledged the land is currently zoned for Z9 purposes in the City Development Plan (recreation and open space). The draft City Development Plan 2022-2026, which is currently on public display, retains the Z9 zoning. All submissions in relation to the draft Development Plan will be considered by the elected members of the City Council before the final Plan is approved in the autumn of this year.

- a. Address the root cause of the Ivy in the public domain and

#### Reply

Ivy is a native woodland plant and is ubiquitous in such shady environments and is all but impossible to eradicate from its preferred habitat physically. Grubbing out would damage the mature tree roots in the area. Chemical treatment would not be keeping with policies around use of such biocides in the public realm. Ivy has enormous wildlife value and because it flowers so late in the year is one of the final sources of food for bees. Although access is problematic the site will be visited in the coming weeks to see if the ivy can be cut lower to the base but this will only provide a temporary remedy. Rather than sending the clippings that come through the fence to a green waste facility the most sustainable solution would be to spread the arising's evenly beneath the trees locally so the nutrients will be returned to the soil.

#### Reply

a. Dublin City Council is aware of the transition to electric vehicles as set out in the Climate Action Plan as we prepare to respond to the needs of the citizens of the City by providing a sustainable urban mobility strategy. The Council is also aware that technology is changing rapidly and that a range of different solutions will be required to successfully address current and future mobility demand, not only in the City, but also across the wider Dublin Metropolitan Area.

This requires careful consideration and planning to ensure that the Council can play their part to facilitate the provision of a comprehensive, reliable and interoperable electric vehicle-charging infrastructure. This is so that members of the public and business community can be confident in making decisions to purchase electric vehicles and to use electric vehicles for personal, leisure and business use, for use on both short and long journeys.

In order to inform the four local authorities of the type and number of chargers required, the four Dublin Local Authorities, together with SMART Dublin and CARO, have commissioned a strategic study. This will allow us examine how the four Councils can best facilitate the provision of electric vehicle-charging infrastructure across the Dublin region and the scale of investment required.

The study sets out modelled EV uptake and consequent grid capacity requirements (ESBN are looking to pilot a number of new technical innovations). It also details numbers and recommended types of chargers required together with suitable business models, capital costs (including anticipated leveraged private sector capital), and areas more suited to Charge Points.

The Dublin Local Authority Electric Vehicle Charging Strategy is now practically complete and the working group are now moving forward with the next steps of the project, which will include a procurement plan required for the roll out of the strategy in balance with the Council's wider sustainable mobility policies. However this will be subject to resources & availability of funding from the Department of Transport.

In addition, variations to the City Development Plan 2016-2022 introduced new objectives such that all new parking for new (or extensions to) housing, apartments and places of employment that provide car parking shall be electric charge enabled. Dublin City Council shall work closely with the ESB and other stakeholders to increase the number of EV charge points across the city. All new (or upgraded) commercially operated car parking developments shall be required to provide a minimum of 50% of spaces with EV charging facilities.

Dublin City Council has also been in close dialogue with the Department and the SEAI regarding a proposed new scheme of grant aid for Multiple Dwelling Units designed to facilitate EV charging infrastructure.

The preparation of the new City Development Plan 2022-2028 will provide an opportunity to review the implementation of the revised objectives from the previous plan and also incorporate the relevant outcomes of the above mentioned study.

This is a pressing matter for us in the Council and indeed with our colleagues in the Dublin Metropolitan area that we may enable and facilitate the transition to more sustainable mobility.

A number of years ago the residents association highlighted their concerns as to the number of large trees in small planting pits that were damaging pavements and kerbs and in poor condition generally due to the restricted rooting space. While the programme then became a little stop/start due to pandemic restrictions 32 trees were listed with a slightly lower priority for removal this winter and all but 6 have been removed.
