Not Recommended	<p>The area engineer has engaged with Dublin Fire Brigade (DFB) to ascertain in the event of an emergency would DFB have any difficulties accessing Lennox Terrace? The area engineer was informed by DFB as follows:</p> <p>“ In the event of needing to gain access (Lennox Terrace), crews could stop as near to an incident as possible and commence firefighting operations from either end of the street”.</p> <p>Dublin City Council (DCC) does not anticipate/pre-empt introduction of road makings such as double yellow lines or road traffic signs to allow for access by emergency vehicles if the emergency services had not previously requested them.</p> <p>The area engineer has looked at submitted images which shows the No. 2 locations double yellow lines should be provided by DCC. Double yellow lines have been request on Lennox Street opposite the existing No. 3 bollards on the northern part of Lennox Terrace. Demand for residential parking on Lennox Street is extremely high, the request received is for rescindment of part of an existing Pay and Display & Permit Parking Bay opposite these bollards. Given the demands for residential parking on Lennox Street the area engineer will not be recommending the introduction of double yellow lines and rescindment of part of the existing parking bays at this location.</p> <p>Double yellow lines have been requested on the southern section of Lennox Terrace at the junction with Portobello Harbour. If vehicles are parking across this junction and blocking vehicles entering/exiting Lennox Terrace this is a matter of enforcement. Residents should call Dublin Street Parking Services (DSPS) on 01-602-2500 or Email: info@dsps.ie or call An Garda Sióchána as this is a matter for the Gardai to enforce.</p>	Member of the Public	29/03/2021	1
