Not Recommended	SR Not Recommended - Following the assessment carried out by the Traffic Advisory Group Area Engineer it was observed that the ramps in the area are 4.5m long ramps and the correct number of ramps are installed based on the road conditions and lengths. The Area Engineer also noted that raising the profile of speed ramps can lead to additional noise, vehicle damage and possible personal injury. Dublin City Council has been subject to litigation claims for vehicle damage as a result of ramp height exceeding the standard best practice. We would therefore not recommend the raising of ramp heights that would be higher than our best practise standards. Currently Dublin City Council only use two types of ramps – 10m long ramps (generally used on bus routes)4.5m long ramps (generally used on roadways where there is no bus route)All ramps have to be agreed with the Environment and Transportation Department of Dublin City Council and have to meet the Construction Standards for Road and Street Works in Dublin City Council – May 2016.	e the Public f	19/05/2021	0

The road should be 200m in a straight line, traffic volumes should exceed 60 vehicles per hour and there should be visible speeding on the road. The area engineer didn't witness any of these and also observed on street parking which acts as a natural traffic calming measure. With this information it would not be recommended to install traffic calming on this road. However traffic calming in the form of the installation of a "slow" road marking sign would be recommended at the entrance to Saint James's Terrace from the South Circular Road. Not Recommended	SR Not Recommended - Following the assessment carried out by the Traffic Advisory Group Area Engineer the installation of Children at play/Slow signage would not be recommend at this location on Curlew Road as this area is within the new speed limits set by Dublin City Council for residential areas. As part of the new limits "Speed limit" signs are erected at all points where there is a change of speed limit. Incorporated into these new signs there is a "Home Zone" and "Slow Zone" sign along with the speed limit (30K/hr). This is to warn motorists that it's a residentia area and to expect children. Furthermore the school opposite Knocknarea Court has been chosen to be part of the "School Zone" project. It was observed that there are "slow" road markings, colourful roundels, "School Ahead" sign and a "School Zone" sign in the vicinity of the school.
