

With reference to the proposed disposal of a plot to the rear of 105 Brian Road, Marino, Dublin 3.

An application has been received from Frank O'Neill and Linda Healy, executors of the estate of the deceased Bridget O'Neill, formerly of 105 Brian Road, to purchase a plot of land to the rear of 105 Brian Road, Marino, Dublin 3.

The plot of ground in question, shown outlined red on Map Index 2022-0034, has an area of 96.1 square meters. This plot was omitted from the portfolio upon the original purchase of the house by Bridget O'Neill.

It is proposed to dispose of Dublin City Council's fee simple interest in the site to Frank O'Neill and Linda Healy as executors of the estate, subject to the following terms and conditions:

- 1. The consideration shall be in the sum of €2,402.50 (two thousand four hundred and two euro and fifty cents). i.e. €25 per square metre i.e. €25 x 96.1 square metres.
- 2. The purchasers shall be responsible for any costs involved in incorporating the plot into their garden.
- 3. The purchasers shall be responsible for their own legal costs in the matter and shall also pay approximately €1,500.00 (plus VAT) towards the Council's legal costs.
- 4. The disposal is subject to receipt of the necessary statutory approvals and such terms and conditions as may be deemed appropriate by the Council's Law Agent.

Dublin City Council acquired the land under Ref 15 of The Dublin (Marino & Croydon Park) Housing Order 1924.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

The disposal shall be subject to any such covenants and conditions as the Law Agent in her discretion shall stipulate.


This report is submitted in accordance with the requirements of Section 183 of the Local Government Act, 2001.
